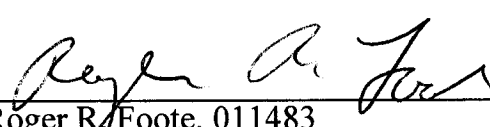
**NOTICE OF WITHDRAWAL OF

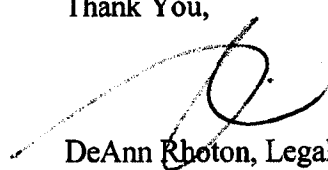
