**ORDER GRANTING DEBTORS' SIXTY-SIXTH  
OMNIBUS (NON-SUBSTANTIVE) OBJECTION TO CLAIMS**

Upon the objection, dated April 25, 2011 (the "Sixty-Sixth Omnibus Objection"), of Washington Mutual, Inc. ("WMI") and WMI Investment Corp. (collectively, the "Debtors"), as debtors and debtors in possession, for entry of an order disallowing in their entirety certain claims filed against these estates, all as more fully set forth in the Sixty-Sixth Omnibus Objection; and upon the *Declaration of John Maciel Pursuant to Local Rule 3007-1 in Support of Debtors' Sixty-Sixth Omnibus (Non-Substantive) Objection to Claims*, dated as of April 25, 2011; and the Court having jurisdiction to consider the Sixty- Sixth Omnibus Objection and the relief requested therein pursuant to 28 U.S.C. §§ 157 and 1334; and consideration of the Sixty-Sixth Omnibus Objection and the relief requested therein being a core proceeding pursuant to 28 U.S.C. § 157(b); and venue being proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and due and proper notice of the Sixty-Sixth Omnibus Objection having been provided to those parties identified therein, and no other or further notice being required; and the Court having determined that the relief sought in the Sixty- Sixth Omnibus Objection is in the best

interest of the Debtors, their creditors, and all parties in interest; and the Court having determined that the legal and factual bases set forth in the Sixty- Sixth Omnibus Objection establish just cause for the relief granted herein; and after due deliberation and sufficient cause appearing therefor, it is

ORDERED that the Sixty- Sixth Omnibus Objection is GRANTED as set forth herein; and it is further

ORDERED that each claim listed on Exhibit 1 hereto and listed in the column marked “Amended Claim to be Disallowed” is hereby disallowed in its entirety; and it is further

ORDERED that each claim listed on Exhibit 2 hereto is hereby disallowed in its entirety; and it is further

ORDERED that the rights and defenses of all parties, including, without limitation, the Debtors, to each claim listed on Exhibit 1 hereto and listed in the column marked “Remaining Claim Number” are expressly preserved; and it is further

ORDERED that Kurtzman Carson Consultants, LLC, the Debtors’ court-appointed claims and noticing agent, is authorized and directed to delete the claims disallowed pursuant to this Order from the official claims register in these chapter 11 cases; and it is further

ORDERED that this Court shall retain jurisdiction to hear and determine all matters arising from or related to the implementation, interpretation, or enforcement of this Order.
