### WMI LIQUIDATING TRUST'S EIGHTY-SEVENTH OMNIBUS (NON-SUBSTANTIVE) OBJECTION TO CLAIMS

WMI Liquidating Trust ("WMILT"), as successor in interest to Washington Mutual, Inc. ("WMI") and WMI Investment Corp., formerly debtors and debtors in possession (collectively, the "Debtors"), pursuant to section 502 of title 11 of the United States Code (the "Bankruptcy Code"), Rule 3007 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), and Rule 3007-1 of the Local Rules of Bankruptcy Practice and Procedure of the United States Bankruptcy Court for the District of Delaware (the "Local Rules"), file this eighty-seventh omnibus non-substantive objection (the "Eighty-Seventh Omnibus Objection") to those claims listed on Exhibit A hereto, and in support of the Eighty-Seventh Omnibus Objection, respectfully represent as follows:

The Debtors in these chapter 11 cases along with the last four digits of each Debtor's federal tax identification number are: (i) Washington Mutual, Inc. (3725); and (ii) WMI Investment Corp. (5395). The principal offices of WMILT, as defined herein, are located at 1201 Third Avenue, Suite 3000, Seattle, Washington 98101.

#### Jurisdiction

1. This Court has jurisdiction to consider this matter pursuant to 28 U.S.C. §§ 157 and 1334. This is a core proceeding pursuant to 28 U.S.C. § 157(b). Venue is proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409.

#### Background

- 2. On September 26, 2008 (the "<u>Commencement Date</u>"), each of the Debtors commenced with this Court a voluntary case pursuant to chapter 11 of the Bankruptcy Code.
- 3. On December 12, 2011, the Debtors filed their Seventh Amended Joint Plan of Affiliated Debtors Pursuant to Chapter 11 of the United States Bankruptcy Code [D.I. 9178] (as modified, the "Plan"). By order [D.I. 9759] (the "Confirmation Order"), dated February 23, 2012, this Court confirmed the Plan and, upon satisfaction or waiver of the conditions described in the Plan, the transactions contemplated by the Plan were consummated on March 19, 2012.

#### WMI's Business

- 4. Prior to the Commencement Date, WMI operated as a savings and loan holding company that owned Washington Mutual Bank ("WMB") and, indirectly, such bank's subsidiaries, including Washington Mutual Bank fsb ("WMBfsb"). Like all savings and loan holding companies, WMI was subject to regulation by the Office of Thrift Supervision (the "OTS"). WMB and WMBfsb, in turn, like all depository institutions with federal thrift charters, were subject to regulation and examination by the OTS. In addition, WMI's banking and nonbanking subsidiaries were overseen by various federal and state authorities, including the Federal Deposit Insurance Corporation ("FDIC").
- 5. On September 25, 2008, the Director of the OTS, by order number 2008-36, appointed the FDIC as receiver for WMB (the "Bank Seizure") and advised that the receiver

was immediately taking possession of WMB (the "Receivership"). Immediately after its appointment as receiver, the FDIC purportedly sold substantially all the assets of WMB, including the stock of WMBfsb (the "JPMC Transaction"), to JPMorgan Chase Bank, National Association ("JPMC") pursuant to that certain *Purchase and Assumption Agreement, Whole Bank*, dated as of September 25, 2008 (the "Purchase Agreement").

### The Bar Date and Schedules

- 6. On December 19, 2008, the Debtors filed with the Court their schedules of assets and liabilities and their statements of financial affairs. On January 27, 2009, and February 24, 2009, WMI filed with the Court its first and second, respectively, amended schedule of assets and liabilities and its first and second, respectively, amended statements of financial affairs. On January 14, 2010, WMI filed a further amendment to its statement of financial affairs (collectively, the "Schedules").
- 7. By order, dated January 30, 2009 (the "Bar Date Order"), the Court established March 31, 2009 (the "Bar Date") as the deadline for filing proofs of claim against the Debtors in these chapter 11 cases. Pursuant to the Bar Date Order, each creditor, subject to certain limited exceptions, was required to file a proof of claim on or before the Bar Date.
- 8. In accordance with the Bar Date Order, Kurtzman Carson Consultants, LLC ("KCC"), the Debtors' court-appointed claims and noticing agent, mailed notices of the Bar Date and proof of claim forms to, among others, all of the Debtors' creditors and other known holders of claims as of the Commencement Date. Notice of the Bar Date also was published once in *The New York Times (National Edition), The Wall Street Journal, The Seattle Times*, and *The Seattle Post-Intelligencer*.

### **Proofs of Claim**

- 9. Over 4,000 proofs of claim have been filed in these chapter 11 cases. WMILT is in the process of reviewing and reconciling the filed proofs of claim. To date, approximately 3,100 claims have been disallowed or withdrawn.
- 10. As part of its ongoing review, WMILT has reviewed each of the proofs of claim listed on Exhibit A hereto and has concluded that each such claim is appropriately objected to on the basis set forth below.

### **Objection to Claims**

- 11. Local Rule 3007-1 allows a debtor to file an omnibus objection to proofs of claim on non-substantive grounds. Omnibus non-substantive objections must include sufficient detail as to why each claim should be disallowed and must be limited to no more than 150 claims. *See* Local Rule 3007-1(f)(i). The following omnibus objection complies with Local Rule 3007-1(f)(i) as well as the other requirements of Local Rule 3007.
- 12. Each of the claims listed on <u>Exhibit A</u> hereto arises from the holding of certain hybrid REIT trust preferred securities (the "<u>Trust Preferred Securities</u>"), which were automatically exchanged for preferred equity interests specifically, Perpetual Non-Cumulative Fixed or Fixed-to-Floating Rate Preferred Stock in Series I, J, L, M and N, as applicable (collectively, the "<u>REIT Series</u>"). Because equity interests are not claims against the Debtors' estates, WMILT requests that the Court disallow the claims listed on <u>Exhibit A</u> in their entirety.
- 13. Moreover, in the Bar Date Order, the Court specifically ordered that "any person or entity that holds an interest in any Debtor, which interest is based exclusively upon the ownership of common or preferred stock" is **not** required to file a proof of claim. (Bar Date Order, at pp.4-5). With respect to the REIT Series, all holders of such securities (including all of

the claimants listed on Exhibit A hereto) held such securities through brokers or nominees, and thus the Debtors, or WMILT, as the case may be, were and are able to effectuate distributions to holders of such securities, whether or not such holders filed claims with respect to such securities.

- WMILT's *Eighty-Sixth Omnibus Objection to Claims* (the "<u>Eighty-Sixth Omnibus Objection</u>"), wherein the Debtors have objected to similar claims on identical grounds. Any capitalized terms used but not defined herein shall have the meaning ascribed to them in the Eighty-Sixth Omnibus Objection. Because the Local Rules specify that omnibus claims objection should include no more than 150 claims, the Debtors have objected to 4 Preferred Funding Trust Claims and 140 Individual Trust Preferred Claims in the Eighty-Sixth Omnibus Objection and to 102 Individual Trust Preferred Claims listed on Exhibit A hereto (the "Individual Trust Preferred Claims").
- 15. In February 2006, WMB's REIT subsidiary, University Street, Inc., created a new subsidiary called Washington Mutual Preferred Funding LLC, a Delaware limited liability company, to facilitate capital-raising transactions through the issuance of the Trust Preferred Securities to investors. The Trust Preferred Securities, an aggregate liquidation preference of \$4 billion, were issued through a series of four issuer trusts established under Delaware law (the "Delaware Issuer Trusts") and one additional issuing entity established as a company under Cayman law to facilitate the sale of Trust Preferred Securities to non-U.S. investors (the "Cayman Issuer").<sup>2</sup>

<sup>&</sup>lt;sup>2</sup> The Preferred Funding Trust Claims have been brought on behalf of the four Delaware Issuer Trusts with a purported liquidation preference of \$3.25 billion. No such claim has been brought on behalf of the Cayman Issuer which has a purported liquidation preference of \$750 million.

- 16. A key defining feature of the Trust Preferred Securities is the automatic exchange of the Trust Preferred Securities into WMI Preferred Shares at the direction of the OTS upon the occurrence of a defined "Exchange Event." Pursuant to the Conditional Exchange, the Trust Preferred Securities were to be exchanged for depositary shares, each representing 1/1,000th of a share of one of the REIT Series, as applicable none of which were outstanding prior to September 25, 2008. As the Court is well aware, the Conditional Exchange has been completed. Indeed, on January 7, 2011, the Court issued an opinion and entered an accompanying order holding, *inter alia*, that "the Conditional Exchange occurred on September 26, 2008" and that "the certificates held by the TPS holders are no longer TPS but are deemed to be Depositary Shares tied to WMI Preferred Shares." Thus, the individual holders of the Trust Preferred Securities were deemed to own interests in WMI preferred equity.
  - 17. The Bankruptcy Code defines an "equity security" as:
  - (A) share in a corporation, whether or not transferable or denominated "stock", or similar security;
  - (B) interest of a limited partner in a limited partnership; or
  - (C) warrant or right, other than a right to convert, to purchase, sell, or subscribe to a share, security, or interest of a kind specified in subparagraph (A) or (B) of this paragraph.

11 U.S.C. § 101(16). Holders of equity securities, such as shares of preferred stock, do not have "claims" pursuant to section 101(5) of the Bankruptcy Code, but rather equity interests. *See In re Insilco Technologies, Inc.*, 480 F.3d 212, 218 (3rd Cir. 2007) ("[an equity] interest is not a claim at all"); *In re Hedged-Investments Associates*, 84 F.3d 1267, 1272 (10th Cir. 1996) ("Simply put, an equity interest is not a claim against the debtor."). Because equity interests are not claims against the Debtors' estates, WMILT requests that the Court disallow the Individual Trust Preferred Claims in their entirety.

- 18. Additionally, most of the Individual Trust Preferred Claims are duplicative of proofs of claim numbered 2181, 2182, 2183, and 2184 (the "Preferred Funding Trust Claims"), filed by the trustee for the holders of the Trust Preferred Securities, Wilmington Trust Company ("Wilmington"). Therein, Wilmington alleged that, pursuant to the terms of the Trust Agreements, it has "the power and authority to act on behalf of the Trust[s] and to enforce any of the Trust[s'] rights in respect of the [Trust Preferred Securities] for the benefit of the Holders of the [Trust Preferred Securities]."
- 19. WMILT has objected to the Preferred Funding Trust Claims on similar grounds in the Eighty-Sixth Omnibus Objection. In addition to the non-substantive arguments above against the Individual Trust Preferred Claims, WMILT also notes that, other than a small number of claims arising from holdings of Trust Preferred Securities from the Cayman Issuer (which are not covered by the Preferred Funding Trust Claims), the Individual Trust Preferred Claims are duplicates of the Preferred Funding Trust Claims. Pursuant to Section 4.07 of the Trust Agreements, Wilmington had the right, but not the obligation, to enforce the any of the rights of the Delaware Issuer Trusts for the benefit of the holders of the Trust Preferred Securities. As Wilmington has already asserted claims on account of holdings of the Trust Preferred Securities, the Court should also disallow in their entirety such Individual Trust Preferred Claims on the grounds that they are duplicative.
- 20. Additionally, it should be noted that the holders of REIT Series including the claimants listed on Exhibit A, to the extent they held the REIT Series as of the voting record date of the Plan were classified in Class 19 of the Plan and already received a distribution (and will receive future distributions to Class 19, should there be any), provided they granted releases with respect to the Plan. To avoid the possibility of multiple recoveries by the

same claimant, WMILT requests that the Court disallow in their entirety the Individual Trust Preferred Claims.

- 21. However, regardless of whether any Individual Trust Preferred Claim arises from a holding of Trust Preferred Securities from the Cayman Issuer, all Individual Trust Preferred Claims should be disallowed because they are equity interests and equity interests are not claims against Debtors' estates.
- 22. WMILT has identified the proofs of claim that contain the Individual Trust Preferred Claims listed on Exhibit A by reviewing the attached supporting documentation to those proofs of claim, which contain, *inter alia*, CUSIP numbers identifying them as Trust Preferred Securities.

### **Declaration**

23. In support of the foregoing, WMILT relies on the *Declaration of John Maciel Pursuant to Local Rule 3007-1 in Support of the Eighty-Seventh Omnibus Objection*, dated as of the date hereof, attached hereto as <u>Exhibit B</u>.

### **Notice**

- 24. Notice of this Eighty-Seventh Omnibus Objection has been provided to:
  (i) the U.S. Trustee, (ii) those parties entitled to receive notice in these chapter 11 cases pursuant to Bankruptcy Rule 2002, and (iii) each holder of a claim objected to herein. In light of the nature of the relief requested, WMILT submits that no other or further notice need be provided.
- 25. Pursuant to Bankruptcy Rule 3007, WMILT has provided all claimants affected by the Eighty-Seventh Omnibus Objection with at least thirty (30) days' notice of the hearing to consider the Eighty-Seventh Omnibus Objection.

### DECLARATION OF JOHN MACIEL PURSUANT TO LOCAL RULE 3007-1 IN SUPPORT OF WMI LIQUIDATING TRUST'S EIGHTY-SEVENTH OMNIBUS (NON-SUBSTANTIVE) OBJECTION TO CLAIMS

I, John Maciel, pursuant to 28 U.S.C. § 1746, hereby declare under penalty of perjury that the following is true and correct to the best of my knowledge, information and belief:

1. I am a Senior Director with Alvarez & Marsal North America, LLC ("A&M") and the current Chief Financial Officer of WMI Liquidating Trust ("WMILT"), as successor in interest to Washington Mutual, Inc. ("WMI") and WMI Investment Corp., formerly debtors and debtors in possession (collectively, the "Debtors"). Previously, I was Chief Financial Officer of both of the Debtors. By order, dated November 6, 2008 [D.I. 246], the Debtors were, among other things, authorized to retain A&M as restructuring advisors, and to designate certain other personnel of A&M and its wholly owned subsidiaries, such as myself, to assist in the Debtors' restructuring process. Unless otherwise stated in this Declaration, I have personal knowledge of the facts set forth herein.

The Debtors in these chapter 11 cases along with the last four digits of each Debtor's federal tax identification number are: (i) Washington Mutual, Inc. (3725); and (ii) WMI Investment Corp. (5395). The principal offices of WMILT, as defined herein, are located at 1201 Third Avenue, Suite 3000, Seattle, Washington 98101.

- 2. In my capacity as Chief Financial Officer of the Debtors and of WMILT, I have been one of the persons responsible for overseeing the claims reconciliation and objection process in the Debtors' chapter 11 cases. WMILT's ongoing claims reconciliation process involves the collective effort of a team of A&M and WMILT employees, as well as WMILT's counsel, Weil, Gotshal & Manges LLP, and the WMILT's claims agent, Kurtzman Carson Consultants LLC.
- 3. I submit this Declaration in support of the WMI Liquidating Trust's Eighty-Seventh Omnibus (Non-Substantive) Objection to Claims (the "Eighty-Seventh Omnibus Objection"). Under my direction and/or supervision, each of the claims at issue in the Eighty-Seventh Omnibus Objection was carefully reviewed and analyzed in good faith using due diligence by the appropriate personnel. These efforts resulted in the identification of the Individual Trust Preferred Claims<sup>2</sup> as identified on Exhibit A to the Eighty-Seventh Omnibus Objection.
- 4. I have also personally reviewed the Eighty-Seventh Omnibus Objection and exhibits thereto and am, accordingly, familiar with the information contained therein.

#### Claims Objection

- 5. To the best of my knowledge, information and belief, the Individual Trust Preferred Claims listed on Exhibit A to the Eighty-Seventh Omnibus Objection represent equity interests and therefore are not claims against Debtors' estates. Accordingly, WMILT requests that those claims be disallowed in their entirety.
- 6. Additionally, to the best of my knowledge, information and belief, other than a small number of claims arising from holdings of Trust Preferred Securities from the

Cayman Issuer, the Individual Trust Preferred Claims listed on Exhibit A to the Eighty-Seventh Omnibus Objection are also duplicative of the Preferred Funding Trust Claims listed on Exhibit A to the Eighty-Sixth Omnibus Objection. Accordingly, to prevent multiple recoveries by the same claimant, WMILT requests that such Individual Trust Preferred Claims also be disallowed on the grounds that they are duplicative.

- 7. Based on the foregoing, and to the best of my knowledge, information and belief, the information contained in the Eighty-Seventh Omnibus Objection and exhibits thereto is true and correct, and the relief requested therein is in the best interests of WMILT, the Debtors' estates, and their creditors.
- 8. I declare under penalty of perjury under the laws of the United States of America that the foregoing is true and correct to the best of my knowledge and belief.
