**FIRST ORDER GRANTING WMI LIQUIDATING TRUST'S
EIGHTY-SIXTH OMNIBUS (NON-SUBSTANTIVE) OBJECTION TO CLAIMS**

Upon the objection, dated September 17, 2012 (the "Eighty-Sixth Omnibus Objection"), of WMI Liquidating Trust ("WMILT"), as successor in interest to Washington Mutual, Inc. ("WMI") and WMI Investment Corp., formerly debtors and debtors in possession (collectively, the "Debtors"), for entry of an order disallowing certain claims filed against the Debtors' estates, all as more fully set forth in the Eighty-Sixth Omnibus Objection; and upon the *Declaration of John Maciel Pursuant to Local Rule 3007-1 in Support of WMI Liquidating Trust's Eighty-Sixth Omnibus (Non-Substantive) Objection to Claims*, dated as of September 17, 2012; and the Court having jurisdiction to consider the Eighty-Sixth Objection and the relief requested therein pursuant to 28 U.S.C. §§ 157 and 1334; and consideration of the Eighty-Sixth Omnibus Objection and the relief requested therein being a core proceeding pursuant to 28 U.S.C. § 157(b); and venue being proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and due and proper notice of the Eighty-Sixth Omnibus Objection having been provided to those parties identified therein, and no other or further notice being required; and the Court

having determined that the relief sought in the Eighty-Sixth Omnibus Objection is in the best interest of WMILT, the Debtors' creditors, and all parties in interest; and the Court having determined that the legal and factual bases set forth in the Eighty-Sixth Omnibus Objection establish just cause for the relief granted herein; and after due deliberation and sufficient cause appearing therefor, it is

ORDERED that the Eighty-Sixth Omnibus Objection is GRANTED as set forth herein; and it is further


ORDERED that each claim listed on Exhibit A hereto is hereby disallowed in its entirety; and it is further

ORDERED that, with respect to the claim listed on Exhibit B hereto, the hearing to consider the Eighty-Sixth Omnibus Objection is continued, without prejudice, to the date reflected on Exhibit B, or as soon thereafter as counsel may be heard; and it is further

ORDERED that Kurtzman Carson Consultants, LLC, WMILT's court-appointed claims and noticing agent, is authorized and directed to delete the claims listed in Exhibit A from such official claims register; and it is further

ORDERED that this Court shall retain jurisdiction to hear and determine all matters arising from or related to the implementation, interpretation, or enforcement of this Order.
