
AMENDED AFFIDAVIT OF SERVICE



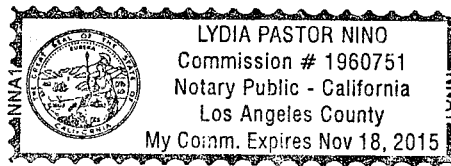
