**MOTION OF GENERAL ELECTRIC CAPITAL CORPORATION TO
WITHDRAW WITHOUT PREJUDICE ITS MOTION FOR RELIEF
FROM AUTOMATIC STAY PURSUANT TO 11 U.S.C. § 362(d), OR,
IN THE ALTERNATIVE, FOR ADEQUATE PROTECTION**

General Electric Capital Corporation (“GECC”), a secured creditor and party in interest, by its undersigned attorneys, and with the consent of the Debtor, hereby withdraws its Motion Of General Electric Capital Corporation For Relief From Automatic Stay Pursuant To 11 U.S.C. § 362(D), Or, In The Alternative, For Adequate Protection (Docket No. 206) (“Lift Stay Motion”), without prejudice. This Motion to Withdraw is being filed due to misstatements of facts having been made unintentionally in the Lift Stay Motion. More specifically, GECC states that the allegation made in paragraph 13 of the Lift Stay Motion that the Debtor was using the airplane for “personal transportation” was not in any way intended to mean that employees of the Debtor were using the airplane for personal use, and furthermore, GECC has no information to the effect that such was the case.
