## ORDER GRANTING DEBTORS' NINETEENTH TIER I OMNIBUS OBJECTION TO CERTAIN PROOFS OF CLAIM (INSUFFICIENT INFORMATION)

Upon the *Debtors' Nineteenth Tier I Omnibus Objection to Certain Proofs of Claim* (*Insufficient Information*) (the "**Objection**")<sup>2</sup> of Chemtura Corporation and its affiliated debtors and debtors in possession in the above-captioned chapter 11 cases (collectively, the "**Debtors**") requesting entry of an order disallowing and expunging the Disputed Claims listed on <u>Schedule 1</u> attached hereto, pursuant to sections 105(a) and 502(b) of title 11 of the United States Code (the "**Bankruptcy Code**") and Rule 3007 of the Federal Rules of Bankruptcy Procedure (the "**Bankruptcy Rules**"); and consideration of the Objection and the relief requested therein being a core proceeding pursuant to 28 U.S.C. §§ 157 and 1334; and venue being proper before this court pursuant to 28 U.S.C. §§ 1408 and 1409; and due and proper notice of the Objection having been provided; and it appearing that no other or further notice need be provided; and the

3. The terms and conditions of this Order shall be immediately effective and

enforceable upon entry of the Order.

4. This Court retains jurisdiction with respect to all matters arising from or related to

the implementation of this Order.
