ORDER GRANTING MOTION OF LIQUIDATING TRUSTEE (TWENTY-SEVENTH OMNIBUS OBJECTION) TO DISALLOW CLAIM NO. 1019

FILED BY MUDR BOHUMILA A. SLABOCHOVA

Dalton T. Edgecomb, the Liquidating Trustee of the Forum Health Liquidating Trust ("Liquidating Trustee"), objected to Claim Nos. 1014, 1016 and 1019 filed by Mudr Bohumila A. Slabochova ("Dr. Slabochova"), among other claims, in The Liquidating Trustee's Twenty-Seventh Omnibus Objection to Certain Filed Proofs of Claim (Late Claims) ("Objection") (Doc. # 1889). The Court held a hearing on the Objection on February 7, 2012 ("Hearing"), at which Dr. Slabochova appeared on behalf of herself and the Liquidating Trustee was represented by Manju Gupta, Esq.

As a result of the representations and admissions of Dr. Slabochova at the Hearing, the Court determined that Dr. Slabochova intended to have only one claim pending and disallowed Claim Nos. 1014 and 1016 (the "Disallowed Claims"). Disallowance of the Disallowed Claims was incorporated into Order Granting, in Part, the Liquidating Trustee's Twenty-Seventh Omnibus Objection to Certain Filed Proofs of Claim (Late Claims) (Doc. # 1965), which was entered on February 8, 2012. The Court did not deal with Claim No. 1019, but adjourned the Objection on Claim No. 1019 until March 6, 2012 ("Adjourned Hearing").

Ms. Gupta appeared at the Adjourned Hearing on behalf of the Liquidating Trustee and represented to the Court that, despite requests made by the Liquidating Trustee, Dr. Slabochova had failed to produce any documentation supporting Claim No. 1019. Ms. Gupta further stated that the Liquidating Trustee had no knowledge of any judgments in favor of Dr. Slabochova against Debtor Forum Health or any of the other Debtors. Although Dr. Slabochova was present at the Adjourned Hearing, Dr. Slabochova did not speak when the Court asked if anyone wished to appear in opposition to the Objection.

Dr. Slabochova filed Claim No. 1019 on August 18, 2011. She asserts that it amends her two previously filed Claims — i.e., Claim Nos. 1014 and 1016. Claim No. 1014 is the earliest filed claim and was filed on February 4, 2011. As a consequence, the Court finds that Claim No. 1019 relates back to the earlier filed claim and will be considered filed as of February 4, 2011.

The bar date to file proofs of claims was August 3, 2009 ("Bar Date"). (Doc. # 301.) The Court adjourned ruling on Claim No. 1019 at the Hearing although it was clearly filed well past the Bar Date because Dr. Slabochova asserted that she was a judgment creditor of Forum Health for the amounts set forth in her claim. Dr. Slabochova could not identify the name of the court in which the alleged judgment was obtained, the amount of the alleged judgment, the name of the cause of action or the defendant in such action. Because Dr. Slabochova failed to identify the judgment to which she referred, subsequent to the Hearing, the Court performed a search of the dockets for the Mahoning County Court of Common Pleas, the Trumbull County Court of Common Pleas and the United States District Court. Since 1989, Dr. Slabochova has been the plaintiff in 18 cases (including appeals) in state court. In all but one of these actions, summary judgment was entered in favor of the defendant or the case was dismissed. Only one case - Slabochova v. Dilullo (Mah. C.C.P. Case No. 1999CV00426) - was settled and dismissed. This case did not involve Forum Health as a defendant. A PACER search revealed 7 additional cases in which Dr. Slabochova was a plaintiff in lawsuits in federal court, each of which was dismissed.

Despite any representation or inference by Dr. Slabochova to the contrary, she does not have a judgment against Forum Health or any of the Debtors. Indeed, despite her litigious nature, Dr. Slabochova appears to never have filed a lawsuit against any of the Debtors.

In addition to providing actual notice to creditors whose addresses were known to the Debtors, the Debtors published notice of the Bar Date in: (i) one newspaper of national circulation, The Wall Street Journal; (ii) a newspaper with general circulation in Mahoning County, Ohio, The Youngstown Vindicator; and (iii) a newspaper with general circulation in Trumbull County, Ohio, The Tribune Chronicle. The Debtors are located in Mahoning and Trumbull Counties. Such publication occurred on June 30, 2009. (See Notice of Publication of Bar Date Notices, Doc. # 371.)

The Bankruptcy Code requires that notice must be "appropriate in the particular circumstances," 11 U.S.C. § 102(1)(A) (West 2012), and the Federal Rules of Bankruptcy Procedure permit notice by publication if "notice by mail is impracticable or that it is desirable to supplement the notice." FED. R. BANKR. P. 2002(1) (West 2012).

Fair or adequate notice has two basic elements: content and delivery. . . . [U]nless received, the notice was inadequate unless the means chosen to deliver it was [sic] reasonable. Mullane v. Central Hanover Bank & Trust Co., 339 U.S. [306] at 314, 319 [(1950)]; Towers v. City of Chicago, 173 F.3d 619, 628 (7th Cir. 1999); Schluga v. City of Milwaukee, 101 F.3d 60, 62 (7th Cir. 1996).

* * *

If [the creditor's] name and address are reasonably ascertainable, he is entitled to have that information sent directly to him, but, if not, then publication of the information in the newspaper or other periodical that he's most likely to see is permitted. In re Chicago, Milwaukee, St. Paul & Pacific R.R., 974 F.2d [775] at 788 [(7th Cir. 1992)]; In re Crystal Oil Co., 158 F.3d 291, 297 (5th Cir. 1998); Chemetron Corp. v. Jones, 72 F.3d 341, 345-47 (3d Cir. 1995); In re Savage Industries, 43

F.3d [714] at 721-22 [(1st Cir. 1994)].

Fogel v. Zell, 221 F.3d 955, 962-63, 2000 U.S. App. LEXIS 17363, **17-18 (7th Cir. 2000).

The Debtors do not dispute that they did not send actual notice of the Bar Date to Dr. Slabochova. However, there is no indication that the name and address of Dr. Slabochova were known to Forum Health or any of the Debtors.

As a consequence, this Court finds that notice by publication was fair and adequate to apprise Dr. Slabochova of the Bar Date and the requirement to timely submit a proof of claim. Since Dr. Slabochova failed to submit a proof of claim in any form until February 4, 2011, which was approximately 19 months after the Bar Date, it is clear that Claim No. 1019 is late filed and is time barred.

Moreover, Dr. Slabochova was well aware of the bankruptcy filing of Forum Health, which was well documented in the media from the time the bankruptcy petitions were filed on March 16, 2009. Indeed, Dr. Slabochova, who lives in downtown Youngstown, approximately two blocks from the Courthouse in which this Court sits, frequented the hearings on many Forum Health bankruptcy matters.

In response to the Objection, Dr. Slabochova has argued the alleged merits of her claim rather than trying to assert that it was either timely filed or that Claim No. 1019 should be allowed late because of excusable neglect. As a consequence, although Claim No.

1019 is disallowed because it was tardy, the Court will also address the merits of the claim. Dr. Slabochova asserts that Forum Health owes her back pay and a pension in the total amount of \$278,000.00 based on her alleged employment with Forum Health as an emergency room doctor from 1974 to 1976. The one page attached to Claim No. 1019 provides no facts, but instead consists of Dr. Slabochova's rambling and confusing narrative. Dr. Slabochova states that she is owed pension benefits in the amount of \$220,000.00, which include \$20,000.00 in penalties, and back pay in the amount of \$58,000.00. (Claim No. 1019 at 2.) However, she has provided no explanation or supporting documentation for how these amounts were calculated.

Claim No. 1019 fails to provide any information or evidence that Dr. Slabochova was covered by or that she was vested in a Forum Health pension plan. Although there is no basis to find that Dr. Slabochova is owed any pension amount as a result of her alleged employment with Forum Health, to the extent she may be entitled to any pension, her recourse would be from the appropriate pension plan rather than from the Debtors or the Liquidating Trust. Accordingly, in addition to Claim No. 1019 being late filed, neither the Debtors nor the Liquidating Trust owes any alleged pension liability to Dr. Slabochova. As a consequence, Claim No. 1019 must be disallowed to the extent it asserts a debt for pension or pension related payments.

Likewise, based upon the lack of documentation or other evidence, there is no basis for this Court to conclude that Forum

Health does now or ever did owe Dr. Slabochova back pay. To the extent Claim No. 1019 asserts a debt for back pay from Forum Health, it must be denied.

Despite Dr. Slabochova's vigorous opposition to the Liquidating Trustee's Objection, Claim No. 1019 was filed late and is time barred. Moreover, even assuming, arguendo, that Claim No. 1019 was not late, the bases for the debt(s) asserted in Claim No. 1019 have no merit. First, there is no evidence that Dr. Slabochova was ever covered by or vested in a Forum Health pension plan. Furthermore, Forum Health has no liability for pension benefits, which would in any case be the responsibility of the appropriate pension plan administrator. Second, there is no basis to find that Forum Health owes back pay to Dr. Slabochova and any possible cause of action for such pay would have been time barred long prior to the Debtors' petition date. As a consequence, the Court hereby sustains the Liquidating Trustee's Objection with respect to Claim No. 1019.
