**NOTICE OF (I) FOURTH SUPPLEMENTAL PAC DESIGNATION AND  
(II) OBJECTION DEADLINE TO PROPOSED ASSUMPTION AND  
ASSIGNMENT OF UNEXPIRED NONRESIDENTIAL REAL  
PROPERTY LEASES TO PURCHASER OR AN AFFILIATE THEREOF**

PLEASE TAKE NOTICE that, on April 6, 2011, Blockbuster Inc. and its debtor-affiliates in the above-captioned chapter 11 cases (collectively, “*Blockbuster*” or the “*Debtors*”) entered into an Asset Purchase and Sale Agreement (the “*Original Purchase Agreement*,” as amended and restated on April 20, 2011, the “*Amended Purchase Agreement*”)<sup>2</sup> with DISH Network Corporation or its permitted assignee under the Asset Purchase Agreement (the “*Purchaser*”), under which the Debtors agreed to sell to Purchaser certain assets (the “*Assets*”, as such term is defined in the Purchase Agreement) and Purchaser agreed to assume (or cause certain of its subsidiaries and/or affiliates to assume) certain liabilities related to the Debtors’ business (the “*Sale Transaction*”).

PLEASE TAKE FURTHER NOTICE that, on April 14, 2011, the United States Bankruptcy Court for the Southern District of New York (the “*Bankruptcy Court*”) entered an order approving the Sale Transaction (the “*Sale Order*”) [Doc. No. 1602]. On April 26, 2011, the Court entered an order [Doc. No. 1723] (the “*Supplemental Sale Order*”) approving the Amended Purchase Agreement. The Amended Purchase Agreement is annexed as *Exhibit “A”* to the Supplemental Sale Order.

**PLEASE TAKE FURTHER NOTICE** that, pursuant to the Sale Order and Supplemental Sale Order, the Debtors are authorized to seek the assumption and assignment of certain executory contracts (each a “*Contract*”) and unexpired nonresidential real property leases (each, a “*Lease*”) relating to the Assets that are designated by the Purchaser in accordance with the terms of the Amended Purchase Agreement, Sale Order, and Supplemental Sale Order (each a “*Purchaser Assumed Contract*” and, collectively, the “*Purchaser Assumed Contracts*”). A list of the initial Purchaser Assumed Contracts [Doc. Nos. 1623 and 1624] (the “*Original PAC Designation Schedule*”) was filed on April 16, 2011. In accordance with the Original Purchase Agreement, the Purchaser has designated additional Contracts to the list of Purchaser Assumed Contracts and the Debtors subsequently filed the Supplemental PAC Designation Schedule [Doc. No. 1626], the Second Supplemental PAC Designation Schedule [Doc. No. 1769], and the Third Supplemental PAC Designation Schedule [Doc. No. 1866] (collectively the “*Supplemental PAC Designation Schedules*” ). The Amended Purchase Agreement permits the Purchaser to designate additional Contracts and Leases as Purchaser Assumed Contracts until ninety days after the Closing Date.

**PLEASE TAKE FURTHER NOTICE** that, in accordance with the terms of the Amended Purchase Agreement, the Purchaser has determined, based on its review of relevant information, that it desires to designate the additional Leases listed on Annex A to this Notice, which can be found on the KCC Website, as Purchaser Assumed Contracts. Accordingly, a fourth supplemental list of additional Purchaser Assumed Contracts (the “*Fourth Supplemental PAC Designation Schedule*” and together with the Original PAC Designation Schedule and the Supplemental PAC Designation Schedules, the “*PAC Designation Schedule*”) has been filed on the Bankruptcy Court’s docket and is available on the internet at [www.kccllc.net/blockbuster](http://www.kccllc.net/blockbuster) (the “*KCC Website*”).

The PAC Designation Schedule, the Sale Order, the Supplemental Sale Order and the Amended Purchase Agreement are available on the internet on the Bankruptcy Court’s docket and on the KCC Website or upon request of the Debtor’s notice and claims agent, Kurtzman Carson Consultants, by phone at 1-877-660-6684 or by email at [BlockbusterInfo@kccllc.com](mailto:BlockbusterInfo@kccllc.com).

**PLEASE TAKE FURTHER NOTICE** that the Purchaser reserves the right to remove a previously designated Contract or Lease from the PAC Designation Schedule up to one (1) Business Day prior to the date of the hearing to consider the assumption and assignment of such Contract or Lease to Purchaser or at any time thereafter if the terms and conditions of the assumption and assignment of any Contract or Lease are not acceptable to the Purchaser.

**YOU ARE RECEIVING THIS NOTICE BECAUSE YOU MAY BE A PARTY TO A PURCHASER ASSUMED CONTRACT IDENTIFIED ON THE FOURTH SUPPLEMENTAL PAC DESIGNATION SCHEDULE OR REPRESENT A PARTY TO A PURCHASER ASSUMED CONTRACT THAT IS IDENTIFIED HEREIN.**

**PLEASE TAKE FURTHER NOTICE** that the Debtors have determined what they believe is the appropriate amount to cure all unpaid amounts due (the “*Cure Amount*”) for the Purchaser Assumed Contract listed on Annex A. In the event that the Cure Amount set forth in the Fourth Supplemental PAC Designation Schedule varies from the Cure Amount previously

set forth in the Designated Contracts Schedule, the Cure Amount in the Fourth Supplemental PAC Designation Schedule shall control.

**PLEASE TAKE FURTHER NOTICE** that the Purchaser Assumed Contracts listed on Annex B to this Notice, which can be found on the KCC Website, have been previously noticed for assumption on the PAC Designation Schedule filed on April 16, 2011, but have not been yet been assumed or rejected. Any objection that was timely filed to the assumption and assignment of such lease shall be preserved. In accordance with the Sale Order, you may only file further objections to the assumption and assignment of your Lease if any additional Cure Amount has accrued after April 21, 2011 or to the extent that the Cure Amount listed on the Fourth Supplemental PAC Designation Schedule is different than the Cure Amount listed on the Original PAC Designation Schedule. **IN THE EVENT THAT THE CURE AMOUNT SET FORTH IN THIS FOURTH SUPPLEMENTAL PAC DESIGNATION SCHEDULE VARIES FROM THE CURE AMOUNT PREVIOUSLY SET FORTH IN THE ORIGINAL PAC DESIGNATION SCHEDULE, THE CURE AMOUNT IN THIS FOURTH SUPPLEMENTAL PAC DESIGNATION SCHEDULE SHALL CONTROL.**

**PLEASE TAKE FURTHER NOTICE** that, to serve as an “*Adequate Assurance Package*” (as such term is defined in that certain *Order, Pursuant To 11 U.S.C. §§ 105, 363, 364, 365 and 503 and Fed. R. Bankr. P. 2002, 4001, 6004, 6006, 9008, 9014, and 9019 Approving (A) Bid Procedures, (B) Stalking Horse Expense Reimbursement, (C) Notice Of Sale, Auction and Sale Hearing, (D) Assumption Procedures and Related Notices, (E) Incurrence Of Sale-Related Administrative Priority Claims, and (F) Imposition Of An Administrative Stay* [Doc. No. 1223]), the Purchaser has submitted the following information:

1. Assignee. The Purchaser Assumed Contracts shall be assigned to Blockbuster Real Estate L.L.C. (the “*Assignee*”), which is an Affiliate of DISH Network Corporation, or any other assignee permitted under section 12.14 of the Purchase Agreement.
2. Proposed Use. With respect to any Purchaser Assumed Contract that is a lease of nonresidential real property, the Assignee or any other assignee permitted under section 12.14 of the Purchase Agreement intends to continue operating a Blockbuster store, including any modifications or supplements to such operations, on such premises in a manner that is consistent with the terms and conditions of the applicable lease or (a) as has been otherwise agreed, by either an oral or written agreement, between Blockbuster Inc. and the applicable lessor, and (b) as may be otherwise agreed, by either an oral or written agreement, between the Assignee or any other assignee permitted under section 12.14 of the Purchase Agreement and the applicable lessor.
3. Adequate Assurance. The Assignee and any other assignee permitted under section 12.14 of the Purchase Agreement intend to conduct the Business with the resources necessary to perform under the applicable Purchaser Assumed Contracts and that are appropriate in light of the nature of its business, operations and obligations.

(NEW YORK TIME)** before the Honorable Burton R. Lifland, United States Bankruptcy Judge, at the United States Bankruptcy Court for the Southern District of New York, Alexander Hamilton Custom House, One Bowling Green, New York, New York 10004, Courtroom 623 (the "**Hearing**"). The Hearing may be adjourned, from time to time, without further notice to you or to creditors or other parties in interest other than by announcement of the adjournment in open Court or on the Court's docket.

**PLEASE TAKE FURTHER NOTICE THAT OBJECTIONS, IF ANY, TO THE PROPOSED ASSUMPTION AND ASSIGNMENT OF YOUR PURCHASER ASSUMED CONTRACT ARE DUE ON JULY 7, 2011 AT 4:00 P.M. (NEW YORK TIME)** (the "**Objection Deadline**"), *provided however*, that, in accordance with the Sale Order, to the extent that your Contract or Lease was previously included on the Designated Contracts Schedule (a "**Previously Designated Contract**"), you may only file further objections to the assumption and assignment of your Contract or Lease to the Assignee on the basis of the identity of the Assignee and its ability to perform thereunder and any additional Cure Amounts accrued after the filing of the Designated Contract Schedule or, to the extent that your Contract or Lease is on the Fourth Supplemental PAC Designation Schedule and the Cure Amount set forth therein has changed since the filing of the Designated Contracts Schedule or the Original PAC Designation Schedule, as applicable, you may file a further objection with respect to such amended Cure Amount.

**PLEASE TAKE FURTHER NOTICE THAT THIS NOTICE DOES NOT EXTEND THE TIME IN WHICH TO OBJECT TO THE PROPOSED ASSUMPTION AND ASSIGNMENT OF ANY PURCHASER ASSUMED CONTRACT THAT APPEARED ON THE ORIGINAL PAC DESIGNATION SCHEDULE FILED ON APRIL 16, 2011, THE SUPPLEMENTAL PAC DESIGNATION SCHEDULE FILED ON APRIL 18, 2011, THE SECOND SUPPLEMENTAL PAC DESIGNATION SCHEDULE FILED ON MAY 17, 2011, OR THE THIRD SUPPLEMENTAL PAC DESIGNATION SCHEDULE FILED ON JUNE 15, 2011, EXCEPT ONLY TO THE LIMITED EXTENT SET FORTH ABOVE WITH RESPECT TO THE PURCHASER ASSUMED CONTRACTS SET FORTH ON ANNEX B, SUCH OBJECTION PERIOD HAVING ALREADY EXPIRED.**

**PLEASE TAKE FURTHER NOTICE** that, if no objection to the assumption and assignment of the Purchaser Assumed Contract or Cure Amount is timely filed and served, (a) the counterparty to such Purchaser Assumed Contract shall be deemed to have consented to the assumption and assignment of the Purchaser Assumed Contract in connection with the Sale Transaction and shall be forever barred from asserting any objection with regard to such assumption or assignment, and (b) the Cure Amount set forth on the Fourth Supplemental PAC Designation Schedule shall be controlling, notwithstanding anything to the contrary in any Purchaser Assumed Contract, or any other document, and the counterparty to the Purchaser Assumed Contract shall be deemed to have consented to the Cure Amount and shall be forever barred from asserting any other claims or Cure Amount related to such Purchaser Assumed Contract against the Debtors, the Purchaser or the Assignee, or the property of any of them.
