## CERTIFICATION OF ALISON M．TEARNEN SCHEPPER PURSUANT TO LOCAL BANKRUPTCY RULE 3018－1（A）WITH RESPECT TO THE TABULATION OF VOTES ON THE DEBTORS＇JOINT PLAN OF REORGANIZATION PURSUANT TO CHAPTER 11 OF THE UNITED STATES BANKRUPTCY CODE

## I，Alison M．Tearnen Schepper，certify and say under the penalty of perjury：

1．I am a Senior Managing Consultant employed by Kurtzman Carson Consultants LLC
（＂KCC＂），whose business address is 2335 Alaska Avenue，El Segundo，California 90245．I am over

the age of 18 and not a party to this action．On December 20，2011，the Court entered an Order


[^0]Approving (A) the Adequacy of the Debtors' Disclosure Statement, (B) Solicitation and Notice Procedures with Respect to Confirmation of the Debtors' Proposed Chapter 11 Plan, (C) the Form of Various Ballots and Notices in Connection Therewith and (D) the Scheduling of Certain Dates with Respect Thereto (the "Solicitation Procedures Order") [Docket No. 3066] designating KCC as the "Notice, Claims and Solicitation Agent".
2. KCC worked with the Debtors, counsel to the Debtors and the Debtors' financial advisor to solicit votes to accept or reject the Debtors' Joint Plan of Reorganization Pursuant to Chapter 11 of the United States Bankruptcy Code (the "Plan") and to tabulate the ballots of creditors voting to accept or reject the Plan. Except as otherwise noted, I could and would testify to the following based upon my personal knowledge. I am authorized to submit this Affidavit on behalf of KCC.
3. KCC has considerable experience in soliciting and tabulating votes to accept or reject proposed plans of reorganization.

## A. Service and Transmittal of Solicitation Packages and Related Information

4. On December 23, 2011, KCC caused to be served Solicitation Packages (as defined in the Solicitation Procedures attached as Exhibit 1 to the Solicitation Procedures Order) in accordance with the Solicitation Procedures Order. An affidavit evidencing KCC's service of the foregoing was filed with the Court on December 30, 2011 [Docket No. 3110].

## B. The Tabulation Process

5. The Solicitation Procedures Order established December 15, 2011, as the record date for determining which creditors and holders of interests were entitled to receive Solicitation Packages and, where applicable, vote on the Plan. Pursuant to the Solicitation Procedures Order, Holders ${ }^{2}$ of Claims in Class A (Second Lien Note Claims), Class E (Convertible Note Claims), Class F (9.125\% Senior Note Claims), Class G (Quarterly Interest Bond Claims), Class H (Trade Claims), Class I

[^1](Guaranteed Landlord Claims), Class J (Pension Withdrawal Claims), Class K (Union Claims) and Class L (General Unsecured Claims) together, (the "Voting Classes") were entitled to vote to accept or reject the Plan. No other classes were entitled to vote on the Plan.
6. Pursuant to the Solicitation Procedures Order, KCC relied on the Schedules of Assets and Liabilities filed by the Debtors on March 25, 2011 and the claims information pertaining to the Debtors' Chapter 11 Cases as reflected in KCC’s CaseView system in order to identify the Holders of Claims entitled to vote to accept or reject the Plan in Class H (Trade Claims), Class I (Guaranteed Landlord Claims), Class J (Pension Withdrawal Claims), Class K (Union Claims) and Class L (General Unsecured Claims). Based on this information, KCC sent each Holder of a Claim entitled to vote on the Plan with an official ballot indicating the applicable Class in which such Holder's Claim was classified.
7. Pursuant to the Solicitation Procedures Order, KCC relied on the security position reports provided by The Depository Trust Company ("DTC") to the Holders of Claims entitled to vote to accept or reject the Plan in Class A (Second Lien Note Claims), Class E (Convertible Note Claims), Class F (9.125\% Senior Note Claims), and Class G (Quarterly Interest Bond Claims) (together, the

## "Securities Classes").

8. Using the information outlined above, and with specific guidance and approval from Debtors' counsel, KCC created a voting database reflecting the names of Holders, addresses of Holders, voting amounts and classification of Claims in the Voting Classes.
9. Using its CaseView voting database, KCC generated ballots for holders of Claims entitled to vote to accept or reject the Plan. The Solicitation Procedures Order established January 24, 2012 at 5:00 p.m. (prevailing Pacific Time) as the deadline for receiving Ballots to accept or reject the Plan (the "Voting Deadline").
10. Pursuant to the Solicitation Procedures Order, KCC received and tabulated Ballots as follows: (a) each returned Ballot was opened and inspected at KCC's office; (b) Ballots were date-
stamped, sorted according to Plan Class, and scanned into KCC Caseview; (c) all Ballots received on or before the Voting Deadline were then entered into KCC CaseView, or in the case of Securities Classes, Master Ballots, tabulated against the security position amounts appearing for each Nominee as listed on the security position reports from DTC, and tabulated in accordance with the tabulation rules outlined in the Solicitation Procedures Order.
11. Set forth below is a summary of the voting results with respect to the Voting Classes:

If the Court were to consolidate the claims in Class E (Convertible Note Claims), Class F (9.125\% Senior Note Claims), and Class G (Quarterly Interest Bond Claims), Class H (Trade Claims), Class I (Guaranteed Landlord Claims), Class J (Pension Withdrawal Claims) ${ }^{3}$, and Class L (General Unsecured Claims) (together, the "Unsecured Classes") into a single class, $70.32 \%$ in number and $77.21 \%$ in value would have voted to accept the Plan. If the Court were to consolidate the claims in the Unsecured Classes excluding Class J (Pension Withdrawal Claims) into a single class, $70.28 \%$ in number and $77.55 \%$ in value would have voted to accept the Plan.
13. Exhibit A to this Affidavit is a detailed report of Ballots tabulated in Classes H, I, J, K and L .

## C. The Unacceptable Ballots

14. Exhibit B to this Affidavit is a detailed report of any Ballots not included in the tabulation above because they did not satisfy the requirements for a valid Ballot set forth in the Solicitation Procedures Order for the reasons described below:
a) Abstained Ballot - pursuant to the Solicitation Procedures Order, Ballots that do not indicate an acceptance or rejection of the Plan were not tabulated;
b) Duplicate Claim Ballot - pursuant to the Solicitation Procedures Order, parties who submitted multiple ballots on account of the same claims were tabulated once;
c) Fax/E-mail Ballot - pursuant to the Disclosure Statement Order, ballots submitted via fax or email were not tabulated;
d) Improperly Submitted Ballot - pursuant to the Solicitation Procedures Order, for the Securities Classes, ballots submitted by parties other than the record holder

[^2]identified on the list provided by the Depository Trust Company were not tabulated;
e) Insider Ballot - pursuant to the Solicitation Procedures Order, Ballots cast by Insiders that indicated an acceptance of the Plan were not tabulated;
f) Late Filed Ballot - pursuant to the Solicitation Procedures Order, Ballots that were not received on or before the Voting Deadline were not tabulated;
g) Unsigned Ballot - pursuant to the Solicitation Procedures Order, Ballots that are not signed were not tabulated.
15. Pursuant to the Solicitation Procedures Order, KCC mailed a Solicitation Package containing an official Class L Ballot to Jersey Development LLC. However, Jersey Development LLC then returned a Class H Ballot. Notwithstanding Jersey Development LLC’s submission of a Class H Ballot, the Debtors have tabulated Jersey Development LLC's Ballot in Class L.

## D. Conclusion

16. To the best of my knowledge, information and belief, the foregoing information concerning the distribution, submission, and tabulation of Ballots in connection with the Plan is true. The Ballots received by KCC are stored at KCC's office and are available for inspection by or submission to this Court.
