NOTICE OF MOTION AND HEARING

PLEASE TAKE NOTICE that, on May 8, 2012, the above-captioned debtors and debtors-in-possession (collectively, the “Debtors”) filed the *Emergency Motion of Debtors Pursuant to Sections 105(a), 363 and 365 of the Bankruptcy Code for an Order (A) Authorizing the Sale of Certain of the Debtors’ Assets Related to their Audio Business Free and Clear of Liens, Claims Encumbrances, and Other Interests; (B) Approving the Assumption and Assignment of Certain of the Debtors’ Executory Contracts Related Thereto; and (C) Granting Related Relief* [Dkt. No. 546] (the “Emergency Sale Motion”) with the United States Bankruptcy Court for the District of Delaware (the “Bankruptcy Court”).

PLEASE TAKE FURTHER NOTICE that, contemporaneously therewith, the Debtors filed the *Motion of Debtors to Shorten Notice and Objection Periods and Set Expedited Hearing on the Emergency Motion of Debtors and Debtors in Possession Pursuant to Sections 105(a), 363 and 365 of the Bankruptcy Code for an Order (A) Authorizing the Sale of Certain of the Debtors’ Assets Related to their Audio Business Free and Clear of Liens, Claims Encumbrances, and Other Interests; (B) Approving the Assumption and Assignment of Certain of the Debtors’ Executory Contracts Related Thereto; and (C) Granting Related Relief* [Dkt. No. 547] (the “Motion to Shorten”).

PLEASE TAKE FURTHER NOTICE that, pursuant to the Motion to Shorten, a hearing with respect to the Emergency Sale Motion is proposed to be held on **May 15, 2012 at 10:00 a.m. (Eastern Daylight Time)** (as such date may be continued or adjourned from time to time, the “Hearing”) before The Honorable Christopher S. Sontchi at the Bankruptcy Court, 824 North Market Street, 5th Floor, Courtroom 6, Wilmington, Delaware 19801.

PLEASE TAKE FURTHER NOTICE that the Debtors have proposed that responses Emergency Sale Motion, if any, must be (i) raised at the Hearing or (ii) filed with the Clerk of
