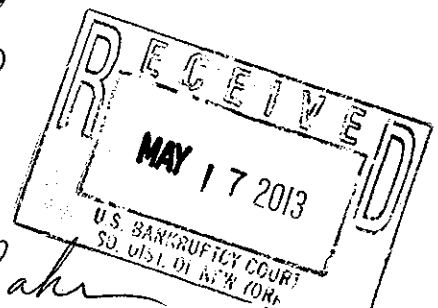
to Whom it may Concern:
