Kurtzman Carson Consultants LLC ("KCC"), administrative agent for the debtors and debtors in possession in the above-captioned cases (collectively, the "Debtors"), submits this supplement ("Supplement") to its interim application [Docket No. 1333] (the "Application")² filed on July 20, 2012 pursuant to sections 330 and 331 of the Bankruptcy Code, Rule 2016 of the Bankruptcy Rules, Rule 2016-1 of the Local Rules, the Local Guidelines, and the UST

Guidelines requesting allowance and approval of compensation for Administrative Agent
Services rendered to the Debtors during the Services Period.

SUPPLEMENT

1. This Supplement is provided to clarify certain of the services for which compensation is sought and to give greater detail with respect to certain of the time entries listed on Exhibit C to the Application. As set forth and described in the Application, the services to the Debtors during the Services Period included 232.3 hours of contract review time.

2. KCC performed ministerial and administrative level review of over 3,500 documents and coordinated the organization, electronic storage and tracking of these documents as part of the contract review services provided to the Debtors. KCC also performed quality control on the resultant data and electronic documents and worked with the Debtors' staff and counsel throughout the process. The time entries listed in Exhibit C to the Application do not include a list of every document reviewed and uploaded. Given the voluminous and repetitive nature of the administrative work it does not lend itself to the use of more specific time entries. KCC and the Debtors will provide the list of reviewed documents upon request by any party in interest.
