of Omnibus Objection and Hearing, responses to the Objection were to be filed, served and received before 4:00 p.m. (Eastern Standard Time) on January 25, 2012.

- 2. Several parties filed responses to the Objection with the Bankruptcy Court. The first such response was filed by Jennifer Harris on January 23, 2012 [Docket No. 2778] (the "Harris Response"). In the Harris Response, Ms. Harris reiterated the basis for her claim (the "Harris Claim"). On January 24, 2012, Carlos Ibanez filed his limited response to the Objection [Docket No. 2783], wherein he indicated that he has no objection to relief sought in the Objection. Finally, on January 25, 2012, Twila O'Neill, April Burkhead, Richard Burkhead, Jenna Hare, James Hare III and Cora Hare (collectively, the "PI Claimants") filed their response to the Objection [Docket No. 2785] (the "PI Claimants' Response" and together with the Harris Response, the "Filed Responses"). In the PI Claimants' Response, the PI Claimants requested that the Objection be granted with respect to their claims (together with the Harris Claim, the "Continued Claims"), subject to certain modifications to the form of order that was attached to the Objection (the "Original Order").
- 3. In addition to the Filed Responses, the Reorganized Debtors also received informal responses from two parties. The first such response was from ACE American Insurance Company ("ACE"). Such response (the "ACE Response") asked that certain clarifying language be added to the Original Order. The second such response was from Magnetar Technologies Corp. and G&T Conveyor Co. ("Magnetar"). Such response (together with the ACE Response, the "Informal Responses") asked that certain clarifying language be added to the Original Order regarding their claims.
- 4. The Reorganized Debtors have resolved the Informal Responses by revising the Original Order and, with the consent of Ms. Harris and the PI Claimants, have

continued the hearing on the Objection as it relates to the Continued Claims and the Filed Responses. Such revised form of order is attached hereto as Exhibit A (the "Revised Order"). The Revised Order has been circulated to counsel to ACE and counsel to Magnetar and each such party has confirmed that the Revised Order has resolved their respective Informal Response. Additionally, for the benefit of the Bankruptcy Court and all parties in interest, a blackline of the Revised Order against the Original Order is attached hereto as Exhibit B.

WHEREFORE, the Reorganized Debtors respectfully request that the Bankruptcy

Court enter the Revised Order, substantially the form attached hereto as Exhibit A, at its earliest convenience.

venue of this proceeding and the Objection in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and the Court having found that the relief requested in the Objection is in the best interests of the Debtors and the Debtors' estate and creditors, and other parties in interest; and the Court having found that the Reorganized Debtors have provided appropriate notice of the Objection and the opportunity for a hearing on the Objection under the circumstances; and the Court having reviewed the Objection and any responses thereto; and the Court having determined that the legal and factual bases set forth in the Objection establish just cause for the relief granted herein; and upon all of the proceedings had before the Court; and after due deliberation and sufficient cause appearing therefor, it is HEREBY ORDERED THAT:

- 1. The Objection is sustained as set forth herein.
- 2. The proofs of claim filed in connection with the Claims set forth on Exhibit 1 hereto (collectively, the "Litigation Claims") are hereby disallowed and expunged in their entirety without prejudice to the resolution of such claims in a non-bankruptcy forum to the extent set forth in the Objection.
- 3. The proofs of claims filed in connection with the Claims set forth on Exhibit 2 hereto (collectively, the "Magnetar Claims") are hereby estimated at \$0.00 solely for purposes of distributions under the Plan and shall not prejudice or impair in any way the entry of a final decree or closing of the Chapter 11 Cases if and when otherwise appropriate, without prejudice to the resolution of such claims in a non-bankruptcy forum and without prejudice to the rights of any Claimant listed on Exhibit 2 hereto to pursue and enforce collection of any judgment against the Reorganized Debtors in an appropriate non-bankruptcy forum.
- 4. For the avoidance of doubt, the Objection, including, without limitation, footnote 4 thereof, does not seek to nor does this Order in any way alter and/or impair, as

applicable, (i) any claims (as defined in section 101(5) of the Bankruptcy Code) that ACE American Insurance Company and its affiliates ("ACE") may have against the Debtors and/or the Reorganized Debtors, (ii) the terms and conditions of the Insurance Policies (as defined in the Plan) and related agreements and the obligations of the Debtors and the Reorganized Debtors thereunder, including, without limitation, their monetary and non-monetary obligations to the insurers and third party administrators relating to or arising from the Litigation Claims or the Magnetar Claims, (iii) the terms of the Plan as such terms relate to or may otherwise affect ACE, including, without limitation, section 8.7 thereof, or (iv) the terms of the Confirmation Order as such terms relate to or may otherwise affect ACE, including, without limitation, paragraph 101 thereof.

- 5. The Reorganized Debtors' rights to amend, modify, or supplement the Objection, to file additional objections to other claims (filed or not) that may be asserted against the Debtors, and to seek further reduction of any Litigation Claim to the extent such claim has been paid, are preserved.
- 6. Each Litigation Claim and Magnetar Claim and the objections by the Reorganized Debtors to each such claim, as addressed in the Objection and as set forth in Exhibits 1 and 2 hereto, constitutes a separate contested matter as contemplated by Bankruptcy Rule 9014 and Local Rule 3007-1. This Order shall be deemed a separate Order with respect to each Litigation Claim and Magnetar Claim. Any stay of this Order pending appeal by any Claimants whose Litigation Claims or Magnetar Claims are subject to this Order shall only apply to the contested matter that involves such Claimant and shall not act to stay the applicability and/or finality of this Order with respect to the other contested matters listed in the Objection or this Order.

7. Nothing herein shall be construed as a waiver of any claims, rights or defenses that the Reorganized Debtors may have with respect to any Litigation Claim, Magnetar Claim or any other claim (filed or not).

8. The Reorganized Debtors are authorized to take all actions necessary to effectuate the relief granted pursuant to this Order in accordance with the Objection.

9. The Court shall retain jurisdiction over any and all matters arising from or related to the implementation or interpretation of the Objection this Order.

28 U.S.C. § 157(b)(2); and the Court having found that venue of this proceeding and the Objection in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and the Court having found that the relief requested in the Objection is in the best interests of the Debtors and the Debtors' estate and creditors, and other parties in interest; and the Court having found that the Reorganized Debtors have provided appropriate notice of the Objection and the opportunity for a hearing on the Objection under the circumstances; and the Court having reviewed the Objection and any responses thereto; and the Court having determined that the legal and factual bases set forth in the Objection establish just cause for the relief granted herein; and upon all of the proceedings had before the Court; and after due deliberation and sufficient cause appearing therefor, it is HEREBY ORDERED THAT:

- 1. The Objection is sustained as set forth herein.
- 2. The proofs of claim filed in connection with the Litigation Claims, set forth on Exhibit 1 hereto (collectively, the "Litigation Claims") are hereby disallowed and expunged in their entirety without prejudice to the resolution of such claims in a non-bankruptcy forum to the extent set forth in the Objection.
- 3. The proofs of claims filed in connection with the Claims set forth on Exhibit 2 hereto (collectively, the "Magnetar Claims") are hereby estimated at \$0.00 solely for purposes of distributions under the Plan and shall not prejudice or impair in any way the entry of a final decree or closing of the Chapter 11 Cases if and when otherwise appropriate, without prejudice to the resolution of such claims in a non-bankruptcy forum and without prejudice to the rights of any Claimant listed on Exhibit 2 hereto to pursue and enforce collection of any judgment against the Reorganized Debtors in an appropriate non-bankruptcy forum.

- 4. For the avoidance of doubt, the Objection, including, without limitation, footnote 4 thereof, does not seek to nor does this Order in any way alter and/or impair, as applicable, (i) any claims (as defined in section 101(5) of the Bankruptcy Code) that ACE American Insurance Company and its affiliates ("ACE") may have against the Debtors and/or the Reorganized Debtors, (ii) the terms and conditions of the Insurance Policies (as defined in the Plan) and related agreements and the obligations of the Debtors and the Reorganized Debtors thereunder, including, without limitation, their monetary and non-monetary obligations to the insurers and third party administrators relating to or arising from the Litigation Claims or the Magnetar Claims, (iii) the terms of the Plan as such terms relate to or may otherwise affect ACE, including, without limitation, section 8.7 thereof, or (iv) the terms of the Confirmation Order as such terms relate to or may otherwise affect ACE, including, without limitation, paragraph 101 thereof.
- 5. 3. The Reorganized Debtors' rights to amend, modify, or supplement the Objection, to file additional objections to other claims (filed or not) that may be asserted against the Debtors, and to seek further reduction of any Litigation Claim to the extent such claim has been paid, are preserved.
- 6. 4.Each Litigation Claim and Magnetar Claim and the objections by the Reorganized Debtors to each such claim, as addressed in the Objection and as set forth in Exhibit 1 Exhibits 1 and 2 hereto, constitutes a separate contested matter as contemplated by Bankruptcy Rule 9014 and Local Rule 3007-13007-1. This Order shall be deemed a separate Order with respect to each Litigation Claim and Magnetar Claim. Any stay of this Order pending appeal by any Claimants whose Litigation Claims or Magnetar Claims are subject to this Order shall only apply to the contested matter that involves such Claimant and shall not act to stay the

applicability and/or finality of this Order with respect to the other contested matters listed in the Objection or this Order.

- 7. Nothing herein shall be construed as a waiver of any claims, rights or defenses that the Reorganized Debtors may have with respect to any Litigation Claim, Magnetar Claim or any other claim (filed or not).
- <u>8.</u> <u>5.</u>The Reorganized Debtors are authorized to take all actions necessary to effectuate the relief granted pursuant to this Order in accordance with the Objection.
- <u>9.</u> 6. The Court shall retain jurisdiction over any and all matters arising from or related to the implementation or interpretation of the Objection this Order.
