“Motion to Strike”).² The Court has jurisdiction over the Motion to Strike pursuant to 28 U.S.C. § 157. Upon consideration of the Motion to Strike and upon the record of the hearing thereon, the Court finds that good cause exists to grant in part and deny in part the Motion to Strike. Accordingly, it is hereby

ORDERED that the ICI Witness and Exhibit List is struck only to the extent that ICI seeks to recall David Fields as a witness; and it is further

ORDERED that the remainder of the ICI Witness and Exhibit List is allowed as filed.
