**ORDER FURTHER EXTENDING THE DEADLINE FOR THE REORGANIZED
DEBTOR TO OBJECT TO CLAIMS AND OLD GP/LP EQUITY INTERESTS**

Upon the motion (the “**Motion**”)² of the Reorganized Debtor for entry of an Order further extending the time by which the Reorganized Debtor may object to Claims and interests; and the Court having reviewed the Motion and having considered the statements of counsel with respect to the Motion at a hearing (if any) before the Court; and the Court having jurisdiction to consider the Motion and the relief requested therein in accordance with 28 U.S.C. §§ 157 and 1334 and the *Amended Standing Order of Reference from the United States District Court for the District of Delaware*, dated as of February 29, 2012; and the Court having found that this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2) and that this Court may enter a final order consistent with Article III of the United States Constitution; and the Court having found that venue of this proceeding and the Motion in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and it appearing that proper and adequate notice of the Motion has been given and that no other or further notice is necessary; and upon the record herein; and after due deliberation

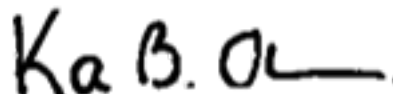

thereon; and the Court having determined that there is good and sufficient cause for the relief granted in this order, it is hereby

ORDERED, ADJUDGED, AND DECREED THAT:

1. The Motion is GRANTED as set forth herein.
2. Each of the Claims Objection Deadline and the Old GP/LP Objection Deadline is hereby extended through and including October 12, 2021.
3. This Order is without prejudice to the Reorganized Debtor's right to request additional extensions of the Claims Objection Deadline or the Old GP/LP Objection Deadline.
4. The Court shall retain exclusive jurisdiction over any and all matters arising from or related to the implementation or interpretation of this Order.
