SUPPLEMENTAL NOTICE OF POSSIBLE ASSUMPTION AND  
ASSIGNMENT OF CERTAIN EXECUTORY CONTRACTS AND UNEXPIRED  
LEASES IN CONNECTION WITH SALE

PLEASE TAKE NOTICE OF THE FOLLOWING:

1. On June 11, 2018, the United States Bankruptcy Court for the District of Delaware (the “**Bankruptcy Court**”) entered that certain *Order (I) Approving Bidding Procedures in Connection with Sale of Assets of the Debtors, (II) Approving Form and Manner of Notice, (III) Scheduling Auction and Sale Hearing, (IV) Authorizing Procedures Governing Assumption and Assignment of Certain Contracts and Unexpired Leases, and (V) Granting Related Relief* [Docket No. 168] (the “**Bidding Procedures Order**”).

2. On June 12, 2018, the above captioned debtors and debtors-in-possession (collectively, the “**Debtors**”) filed and served the *Notice of Possible Assumption and Assignment of Certain Executory Contracts and Unexpired Leases in Connection with Sale* [D.I. 184] (the “**Cure Notice**”). You were previously served with the Cure Notice.

3. Pursuant to the Bidding Procedures Order, the Debtors hereby amend and supplement the Cure Notice with this supplemental notice (the “*Previously Omitted Contract Notice*”) that they are a party to various executory contracts and unexpired leases as set forth on Exhibit 1 attached hereto (individually, a “*Potentially Assumed Contract*,” and collectively, the “*Potentially Assumed Contracts*”) and they may seek to assume and assign the Potentially Assumed Contracts to the Successful Bidders<sup>2</sup> in connection with the proposed sale of the Debtors’ assets.

4. You have been identified as a party to a Potentially Assumed Contract. At the Sale Hearing, the Debtors will seek Bankruptcy Court approval of the assumption and assignment to the Successful Bidders of only those Potentially Assumed Contracts that have actually been selected by the Successful Bidders to be assumed and assigned (collectively, the “*Selected Assumed Contracts*”). The Debtors and their estates reserve any and all rights with respect to any Potentially Assumed Contracts that are not ultimately designated as Selected Assumed Contracts.

5. The Potentially Assumed Contract with respect to which you have been identified as a non-Debtor counterparty, and the corresponding proposed amount the Debtors’ records reflect is owing to cure any and all defaults under such Potentially Assumed Contract so as to permit the assumption and assignment of such Potentially Assumed Contract (if designated for assumption and assignment by the Successful Bidders) pursuant to 11 U.S.C. § 365 (the “*Proposed Cure Cost*”), has been set forth on Exhibit 1 attached hereto. The Debtors’ records reflect, as of the date hereof, that all postpetition amounts due and owing under your Potentially

Assumed Contract have been paid and will continue to be paid. Amounts due and owing under the Potentially Assumed Contracts with respect to the period after the petition date are not included in the calculation of the Proposed Cure Cost.

6. Objections, if any, to the Proposed Cure Cost, or to the possible assumption and assignment of any Potentially Assumed Contract, must be made in writing, filed with the United States Bankruptcy Court for the District of Delaware, 824 North Market Street Wilmington, Delaware 19801, and served so as to be received on or before 4:00 p.m. on July 16, 2018 (the “*Contract Objection Deadline*”). Service should be made by mail to:

- f. those parties who have formally filed requests for notice in the Chapter 11 Cases pursuant to Bankruptcy Rule 2002.

7. An objection to any Proposed Cure Cost must (i) be in writing; (ii) conform to the applicable provisions of the Bankruptcy Rules and the Local Rules; (iii) state with particularity the legal and factual basis for the objection and the specific grounds therefor.

8. If an objection to the Proposed Cure Cost, or the possible assumption and assignment, is timely filed, a hearing with respect to the objection will be held before the Honorable Kevin Gross, United States Bankruptcy Judge, at the United States Bankruptcy Court for the District of Delaware, 824 North Market Street, 6<sup>th</sup> Floor, Courtroom No. 3, Wilmington, DE 19801, on July 20, 2018 at 10:00 a.m. or at a later hearing, as determined by the Debtors. A hearing regarding the Cure Amount, if any, may be continued at the sole discretion of the Debtors.

9. Regardless of whether a Potentially Assumed Contract will be assumed and assigned at the closing of the Sale, unless a non-debtor party to any Potentially Assumed Contract files an objection to the Cure Amount by the Contract Objection Deadline, then such counterparty shall be (i) forever barred from objecting to the Cure Amount; and (ii) forever barred and estopped from asserting or claiming any amounts under the Contracts outstanding as of the effective date of assumption and assignment to the Successful Bidders, other than the Cure Amount on Exhibit 1, against the Debtors, any Successful Bidder or any other assignee of the relevant contract.

10. At the Sale Hearing, the Debtors shall present evidence necessary to demonstrate adequate assurance of future performance by the Successful Bidders. You will have the opportunity to evaluate and, if necessary, challenge, at the Sale Hearing, the ability of any

Successful Bidder to provide adequate assurance of future performance under the Potentially Assumed Contracts.

11. The presence of a contract, lease or other agreement listed on Exhibit 1 attached hereto does not constitute an admission that such contract, lease or other agreement is an executory contract or unexpired lease or that such contract or lease will be assumed by the Debtors and assigned to any Successful Bidder. The Debtors reserve all of their rights, claims and causes of action with respect to the contracts, leases and other agreements listed on Exhibit 1 attached hereto. For the avoidance of doubt, if there are any discrepancies between the information listed on Exhibit 1 hereto and the information found in the Cure Notice, the information listed on Exhibit 1 hereto controls.
