Pursuant to Rule 1009(a) of the Federal Rules of Bankruptcy Procedure, the above-captioned debtors and debtors in possession (collectively, the “*Debtors*”) hereby provide notice that, as set forth below, (i) each of the Debtors, excluding Enduro Resource Holdings LLC (“*ERH*”) and Enduro Management Company LLC (“*EMC*”), has amended its Schedule E/F, (ii) each of the Debtors, excluding ERH, has amended its Schedule G, and (iii) each of the Debtors has amended its Statement of Financial Affairs.

AMENDED SCHEDULES

Contemporaneously herewith, each Debtor, excluding ERH and EMC, filed its amended Schedule E/F (“*Amended Schedule E/F*”) and each Debtor, excluding ERH, filed its amended Schedule G (“*Amended Schedule G*” and, together with Amended Schedule E/F, the “*Amended Schedules*”).
