ORDER GRANTING FIFTH (SUBSTANTIVE) OMNIBUS OBJECTION TO CLAIMS PURSUANT TO 11 U.S.C. § 502(b)
AND BANKRUPTCY RULE 3007 AND GRANTING RELATED RELIEF

Upon the Fifth (Substantive) Omnibus Objection to Claims pursuant to 11 U.S.C. § 502(b) and Bankruptcy Rule 3007 (the "Fifth Omnibus Objection");¹ and the Court having jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334, the Standing Order of Referral of Cases to Bankruptcy Judges, dated July 10, 1984, entered by the United States District Court for the Southern District of New York, the Joint Plan and the Confirmation Order; and the Trustee of the Trust having complied with the Procedures set forth in the Order, dated April 24, 2009 (Docket No. 459); and the Court having reviewed the Fifth Omnibus Objection; and upon the record of the July 21, 2009 hearing on the Fifth Omnibus Objection the Court finding good and sufficient cause for granting the relief requested in the Fifth Omnibus Objection to the extent provided herein, it is hereby

FOUND AND DETERMINED THAT:

A. Each holder of a Claim listed on Exhibit A hereto was properly and timely served with notice of the Fifth Omnibus Objection (Docket No. 467, Affidavit of Karen Wagner).

B. The Fifth Omnibus Objection is a core proceeding pursuant to 28 U.S.C. §157(b)(2).

NOW, THEREFORE, IT IS ORDERED THAT:

- 1. <u>Duplicate Claims to be Expunged Pursuant to 11 U.S.C. § 502(d) and Fed. R. Bank. P. 3007</u>. The Claims listed on Exhibit B hereto as "Duplicate Claim Expunged" are hereby and shall be DISALLOWED AND EXPUNGED in their entirety, and the Claims listed on Exhibit B as "Surviving Claim No." shall survive and shall be ALLOWED CLAIMS, as defined in the Joint Plan. The Trustee shall seek no further relief against the ALLOWED CLAIMS.
- 2. Claims to be Reduced for Which the Claim Differs from the Debtor's

 Books and Records. Unless otherwise set forth on Exhibit C hereto, pursuant to 11

 U.S.C. § 502(d) and Fed. R. Bank. P. 3007, the Claims listed on Exhibit C are hereby and shall be REDUCED to the amount set forth on Exhibit C as the "Amount Allowed."
- 3. Amended or Superseded Claims to be Expunged. Unless otherwise set forth on Exhibit D hereto, pursuant to 11 U.S.C. § 502(d) and Fed. R. Bank. P. 3007, the Claims listed as "Amended / Superseded Claim Expunged" on Exhibit D are hereby DISALLOWED and EXPUNGED in their entirety and the Claims listed on Exhibit D as "Surviving Claim No" shall survive and shall be ALLOWED CLAIMS, as defined in the Joint Plan. The Trustee shall seek no further relief against the ALLOWED CLAIMS.
- 4. <u>Claims with Insufficient Supporting Documentation to be Expunged.</u>
 Unless otherwise set forth on Exhibit E hereto, pursuant to 11 U.S.C. § 502(d) and Fed.
 R. Bank. P. 3007, the Claims listed on Exhibit E are hereby and shall be DISALLOWED AND EXPUNGED in their entirety.

- 5. Claims to be Reclassified and/or Reclassified and Changed in Amount.
 Unless otherwise set forth on Exhibit F hereto, pursuant to 11 U.S.C. § 502(d) and Fed.
 R. Bank. P. 3007, the Claims listed on Exhibit F are hereby and shall be
 RECLASSIFIED AND/OR RECLASSIFIED AND CHANGED IN AMOUNT as set forth on Exhibit F.
- 6. Claims to be Expunged for which the Debtor is not Believed to be Liable.

 Unless otherwise set forth on Exhibit G hereto, pursuant to 11 U.S.C. § 502(d) and Fed.

 R. Bank. P. 3007, the Claims listed on Exhibit G are hereby and shall be DISALLOWED AND EXPUNGED as set forth on Exhibit G.
- 7. Paid Claims. Unless otherwise set forth on Exhibit H hereto, pursuant to 11 U.S.C. § 502(d) and Fed. R. Bank. P. 3007, the Claims listed on Exhibit H are hereby and shall be treated as set forth on Exhibit H.
- 8. <u>Claims to be Allowed</u>. Pursuant to 11 U.S.C. § 502(d) and Fed. R. Bank. P. 3007, the Claims listed on Exhibit I shall survive and shall be ALLOWED CLAIMS, as defined in the Joint Plan. The Trustee shall seek no further relief against the ALLOWED CLAIMS set forth on Exhibit I.
- 9. Adjourned Hearing (the "Hearing") to be held. The Hearing to consider the Fifth Omnibus Objections as to the Claims set forth on Exhibit J hereto is adjourned to September 22, 2009 at 10:00 a.m for further consideration by this Court. The Hearing shall be held at the United States Bankruptcy Court for the Southern District of New York, Alexander Hamilton Custom House, Courtroom 610, One Bowling Green, New York, NY 10004-1408. The Hearing shall not be an evidentiary Hearing. No

appearances are required to be made by interested parties. The Trustee shall provide separate notice regarding any evidentiary Hearing scheduled as to any particular claim.

- 10. On or before the tenth (10th) day following entry of this Order, the Trustee shall serve, or cause to be served, notice of entry of this order upon all entities set forth on Exhibit I and Exhibit J.
- 11. The Claims Agent is hereby authorized and directed to make such revisions to the official Claims Register as are necessary to reflect the relief granted pursuant to this Order.
- 12. The Trustee's objection to each Claim addressed in the Fifth Omnibus Objection ("Disputed Claim") constitutes a separate contested matter as contemplated by Fed. R. Bank. P. 9014.
- 13. This Order shall be deemed a separate order with respect to each Disputed Claim.
- 14. Any stay of this Order by any of the claimants whose Claim is subject to this Order shall apply only to the contested matter which involves such claimant and shall not stay the applicability and/or finality of this Order with respect to any other contested matters or relief granted herein, unless otherwise expressly ordered.
- 15. This Order is without prejudice to the Trustee's right to amend, modify or supplement the Fifth Omnibus Objection, to object to any of the Claims listed on Exhibits A through H on any grounds in future objections to Claims, other than those expressly set forth herein as ALLOWED CLAIMS, and to object to any other Claims or interests filed in this Chapter 11 case.

16. This Court shall retain jurisdiction over the claimants whose Claims are subject to the Fifth Omnibus Objection with respect to any matters related to or arising from the Fifth Omnibus Objection or the implementation of this Order.
