PLAINTIFF'S MOTION FOR SUMMARY JUDGMENT ON COUNTERCLAIMS

1. - 1. Plaintiffs' Motion for Summary Judgment is GRANTED.
- 2. Summary judgment is granted on Count I of the Defendants' Counterclaims under 28 U.S.C. § 2201 because the Plaintiff has no obligation to transport crude oil using the transportation system.
- 3. Summary judgment is granted on Count II of the Defendants' Counterclaims under 28 U.S.C. § 2201 because the Plaintiff has no obligation to transport crude oil produced from the Rinn Valley Wells on the DJ South transportation system.
- 4. This Court shall retain jurisdiction with respect to all matters arising from or relating to the implementation of this Order.
