# SECOND SUPPLEMENTAL DECLARATION OF HELEN MASON IN SUPPORT OF THE DEBTORS' APPLICATION FOR AN ORDER AUTHORIZING THE RETENTION AND EMPLOYMENT OF RIVERON CONSULTING, LLC AS FINANCIAL ADVISOR EFFECTIVE AS OF JULY 24, 2020

I make and submit this second supplemental declaration (this "Second Supplemental Declaration") on behalf of Riveron to supplement the disclosures contained in the Declaration of Helen Mason in Support of Debtors' Application for Entry of an Order (I) Approving the Retention and Employment of Riveron Consulting, LLC as Accounting Advisor for the Debtors Effective as of July 24, 2020 and (II) Modifying Certain Time-Keeping Requirements (the "Original Declaration") attached as Exhibit B to the Debtors' Application for Entry of an Order (I) Authorizing the Employment and Retention of Riveron Consulting, LLC as Accounting Advisor for the Debtors Effective as of July 24, 2020 and (II) Modifying Certain Time-Keeping Requirements [Docket No. 525] (the "Application") and the Supplemental Declaration of Helen Mason in Support of the Debtors'

- 2. I am duly authorized to make and submit this Second Supplemental Declaration on behalf of Riveron in accordance with section 327(a) of the Bankruptcy Code and Bankruptcy Rule 2014(a).
- 3. Unless otherwise stated in this Second Supplemental Declaration, I have personal knowledge, upon information and belief, and upon records kept in the ordinary course of business that were reviewed by me or other employees of Riveron under my supervision and direction, of the facts set forth herein.
- 4. On August 25, 2020, the Debtors filed the Application. The Application was approved pursuant to the *Order (I) Authorizing the Employment and Retention of Riveron Consulting, LLC as Accounting Advisors to the Debtors, Effective as of July 24, 2020, and (II) Modifying Certain Time-Keeping Requirements (the "Order") entered on November 16, 2020.* [Docket No. 1096].
- 5. On or about November 12, 2020, the above captioned Debtors provided names of additional parties in interest (the "Additional Parties in Interest") in this case that were not initially identified in the Original Declaration filed with the Court on August 25, 2020
- 6. The Additional Parties in Interest are listed in **Schedule A** attached hereto and incorporated herein. Riveron searched its databases, the databases of certain affiliates, Conway

Based on the conflict review process described in the Original Declaration, the Supplemental Declaration, and this Second Supplemental Declaration, except as otherwise disclosed herein, in the Original Declaration or this Second Supplemental Declaration, including as described on Schedule B (additional connections to Riveron) and Schedule C (additional connections to Conway MacKenzie) hereto, insofar as I have been able to ascertain, Riveron does not, (a) represent entities other than the Debtors in connection with this chapter 11 case; (b) have any connection with the Debtors, their creditors, stockholders, or any other party in interest, or any of their respective attorneys and accountants, or the Office of the United States Trustee for the District of Delaware; or (c) hold any interest adverse to the Debtors or their estates.
- 8. Riveron is filing this Second Supplemental Declaration to provide notice of additional connections to the parties in interest.
- 9. Continued inquiry will be made following the filing of this Second Supplemental Declaration by undertaking the same procedures described herein, in the Original Declaration, and in the Supplemental Declaration on a periodic basis, except where otherwise specified, with additional disclosures to be filed in this Court if necessary or otherwise appropriate.
