In light of this Voluntary Dismissal, Grand Mesa requests that the Court deny as moot the Motion to Consolidate and Motion for Certification as to Grand Mesa. The other movant in the Motion to Consolidate and Motion for Certification, the Federal Energy Regulatory Commission, is not a party to this Voluntary Dismissal, and, therefore, the Motion to Consolidate and Motion for Certification remain pending as to that party.
