**ORDER SUSTAINING REORGANIZED DEBTORS' EIGHTH OMNIBUS
(SUBSTANTIVE) OBJECTION TO CERTAIN (A) OVERSTATED CLAIMS; (B)
MISCLASSIFIED CLAIMS; (C) WRONG DEBTOR CLAIMS; (D)
SUBSTANTIVE DUPLICATE CLAIMS; (E) NO LIABILITY CLAIMS; AND (F)
NO LIABILITY ROYALTY CLAIMS, PURSUANT TO SECTION 502(b) OF THE
BANKRUPTCY CODE, BANKRUPTCY RULES 3003 AND 3007, AND
BANKRUPTCY LOCAL RULE 3007-1**

Upon the objection (the “Objection”)² of the above-captioned reorganized debtors (the “Reorganized Debtors”) for entry of this Order pursuant to section 502(b) of the Bankruptcy Code, Bankruptcy Rules 3003 and 3007, and Bankruptcy Local Rule 3007-1, disallowing the Disputed Claims; and this Court having jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334 and the Amended Standing Order; and that this Court may enter a final order consistent with Article III of the United States Constitution; and this Court having found that venue of this proceeding and the Objection in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and this Court having found that the relief requested in the Objection is in the best interests of the Reorganized Debtors, the Debtors’ estates, their creditors, and other parties in interest; and this

Court having found that the Reorganized Debtors' notice of the Objection and opportunity for a hearing on the Objection were appropriate and no other notice need be provided; and this Court having reviewed the Objection and having heard the statements in support of the relief requested therein at a hearing before this Court (the "Hearing"); and upon the First Day Declaration; and upon the declaration of Thomas Behnke; and this Court having determined that the legal and factual bases set forth in the Objection and at the Hearing establish just cause for the relief granted herein; and upon all of the proceedings had before this Court; and after due deliberation and sufficient cause appearing therefor, it is HEREBY ORDERED THAT:

6. The Objection is SUSTAINED as set forth herein.
7. The Overstated Claims identified on the attached Exhibit 1 are hereby reduced as set forth therein.
8. The Misclassified Claims identified on the attached Exhibit 2 are hereby reclassified as set forth therein.
9. The Wrong Debtor Claims identified on the attached Exhibit 3 are hereby disallowed in their entirety.
10. The Substantive Duplicate Claims identified on the attached Exhibit 4 are hereby disallowed in their entirety.
11. The No Liability Claims identified on the attached Exhibit 5 are hereby disallowed in their entirety.
12. The No Liability Royalty Claims identified on the attached Exhibit 6 are hereby disallowed in their entirety.
13. The Reorganized Debtors' objection to each Disputed Claim addressed in the Objection constitutes a separate contested matter as contemplated by Bankruptcy Rule 9014. This

Order shall be deemed a separate order with respect to each claim. Any stay of this Order pending appeal by any of the claimants subject to this Order shall only apply to the contested matter that involves such claimant and shall not act to stay the applicability or finality of this Order with respect to the other contested matters covered hereby.

14. Nothing in the Objection or this Order constitutes a waiver of the Reorganized Debtors' rights to object to any claims not previously disallowed or to assert any claims, counterclaims, rights of offset or recoupment, or any other claims against the claimants listed on **Exhibits 1 – 6** hereto, all of which rights are expressly preserved. Additionally, to the extent the Objection was denied with respect to any of the Disputed Claims, the Reorganized Debtors' rights to object to such Disputed Claims on any grounds other than those set forth in the Objection are preserved.


15. The Reorganized Debtors and KCC are authorized to take any and all actions that are necessary or appropriate to give effect to this Order.
