("Extraction") by an through their respective undersigned counsel and in regard to the hearing to be conducted by the Court on December 7, 2021 at 2:00 pm ("Hearing") in regard to PDC's Motion for Order Resolving Controversies and Disputes Regarding Interpretation and Enforcement of Plan and Matters Related to the Assumption or Rejection of Executory Contracts [Docket No. 2061 in Case No. 20-11548] ("Motion") and the Reorganized Debtors' Objection to the Motion [Docket No. 20 in Case No. 20-11550] ("Objection") and PDC's Reply in Support of its Motion [Docket No. 30 in Case No. 20-11550] ("Reply") hereby stipulate to the following exhibits and evidence at the Hearing:

II. STIPULATION AS TO TESTIMONY TO BE ENTERED INTO EVIDENCE

PDC and Extraction hereby stipulate to the following:

- 1. PDC did not file a proof of claim in the bankruptcy case.
- 2. After receiving the Bar Date Notice in the Extraction bankruptcy case, PDC conducted an internal investigation and consulted with outside counsel to determine whether PDC held any claims against Extraction, which could be asserted pursuant to a proof of claim. As a result, it was determined that a claim did not exist and that a proof of claim could not be validly filed in the Extraction bankruptcy case.
- 3. PDC Energy, Inc. was not aware that, prior to the confirmation of the Plan on December 23, 2020, the Grand Mesa TSA had terminated.
- 4. At all relevant times prior to the confirmation of the Plan on December 23, 2020 it was PDC's understanding that the Exchange Agreement and Line Fill Receivable Agreement had not terminated.
