FIRST: It is my desire, and I hereby authorize, for my body to be crema for ashes to be interred with my father, mother and brothers at the Overton cemetery in Overton, Ohio.

SECOND: With respect to any real or personal property which I may the time of my death, jointly with right of survivorship with one or more per with a contractual designation of beneficiary, I do hereby confirm the sa direct that such property shall pass to the surviving joint owner(s) or benefici as the case may be.
