APPLICATION FOR INTERIM APPROVAL, ALLOWANCE, AND REIMBURSEMENT OF EXPENSES FOR THE PERIOD SEPTEMBER 1, 2019 THROUGH AND INCLUDING APRIL 30, 2020, FILED BY BAKER & HOSTETLER LLP AS COUNSEL TO THE CHAPTER 7 TRUSTEE, BRIAN A. BASH

Baker & Hostetler LLP ("Baker & Hostetler" or the "Firm"), counsel to the Chapter 7 Trustee, Brian A. Bash (the "Trustee"), in the above-captioned chapter 7 case of debtor Fair Finance Company ("Debtor"), hereby applies for Interim Approval, Allowance and Reimbursement of Expenses (the "Application"), in accordance with (a) 11 U.S.C. §§ 330 and 331, (b) Rule 2016 of the Federal Rules of Bankruptcy Procedure, (c) Rule 2016-1 of the Local Bankruptcy Rules for the Northern District of Ohio, (d) General Order 93-1, Guidelines for Compensation and Expense Reimbursement of Professionals; and (e) the Guidelines for Reviewing Applications for Compensation and Reimbursement of Expenses Filed under 11 U.S.C. §§ 330 adopted by the Executive Office for United States Trustees (the "UST Guidelines").

In support of this Application, Baker & Hostetler respectfully represents as follows:

I. INTRODUCTION

1. Baker & Hostetler files this Application to request interim allowance and payment of its out-of-pocket expenses incurred from September 1, 2019 through April 30, 2020 (the "Application Period"). This Application does not seek allowance or payment of any attorney's fees.

- 2. Baker & Hostetler seeks approval and reimbursement of out-of-pocket expenses, totaling \$170,811.10, for the Application Period. The overwhelming majority of the requested expenses were incurred and paid by the Firm in connection with the matter captioned *Bash v. Textron Financial Corp.*, Adv. Proc. No. 12-5101, Case No. 12-00987 (N.D. Ohio) (Judge Gaughan) (the "**Textron Litigation**").
- 3. A jury trial in the Textron Litigation was conducted in the District Court from February 24, 2020, through March 10, 2020. At the conclusion of the trial, the jury rendered a verdict against the Trustee. The Trustee has appealed. That appeal is pending before the Sixth Circuit Court of Appeals.

II. PROCEDURAL BACKGROUND

- 4. On February 8, 2010 (the "**Petition Date**"), creditors filed a petition for involuntary bankruptcy against the Debtor.
- 5. On the Petition Date, the creditors also filed an "Emergency Motion to Appoint Interim Trustee" [Docket No. 2] alleging that a trustee was needed to oversee the operations of the Debtor because (i) the Debtor had failed to make timely payments on its debts, including failing to redeem matured certificates and failing to pay interest on unmatured certificates; (ii) the Debtor and several affiliated companies had been raided by the Federal Bureau of Investigation in November of 2009; (iii) the Debtor had not been open to the public since the raid; and (iv) public records revealed that the Debtor had made "unusually large" loans to insiders.
- 6. On February 19, 2010, this Court entered an order directing the United States Trustee to appoint an interim trustee.
- 7. On February 24, 2010, the Debtor filed notice that it consented to the entry of an order for relief in this proceeding [Docket No. 35].

- 8. On March 2, 2010, the Court entered an Order granting the relief sought by the Petitioning Creditors *nunc pro tunc* as of February 24, 2010 [Docket No. 40].
- 9. On March 2, 2010, the United States Trustee filed the Notice of Appointment of Interim Chapter 7 Trustee *nunc pro tunc* effective February 24, 2010 [Docket No. 41]. Trustee Bash is the duly-appointed, qualified and acting Trustee in the within proceedings.
- 10. On February 23, 2010, the Trustee filed an Application Under § 327(a) of the Bankruptcy Code to Retain and Employ Baker & Hostetler LLP as Counsel [Docket No. 32].
- 11. Baker & Hostetler was authorized to serve as counsel for the Trustee, effective as of February 23, 2010, pursuant to this Court's Order Authorizing Appointment of Attorneys for Trustee, dated March 10, 2010 [Docket No. 53].

III. SUMMARY OF EXPENSE REIMBURSEMENT REQUESTED

- 12. In this Application, Baker & Hostetler seeks interim allowance and payment of out-of-pocket expenses incurred during the Application Period. Baker & Hostetler has not received a retainer in connection with its engagement as counsel for the Trustee.
- 13. Baker & Hostetler has underwritten the expenses associated with preparing for and prosecuting the trial against Textron Financial Corp. in the Textron Litigation. The trial began on February 24, 2020 and concluded on March 10, 2020. The Textron Litigation represented the estate's last opportunity to meaningfully increase distributions to creditors. Thus, during the trial, and during the months leading up to the trial, the Trustee's Textron Litigation team worked around-the-clock in an effort to obtain the best result for the estate. The requested expenses reflect that effort.
 - 14. The expenses may be generally summarized as follows:
 - (a) Copying and binding costs associated with preparing exhibits for use during trial and trial preparation;

- (b) Court reporter costs;
- (c) Vendor costs relating to synchronization and digitization of trial deposition videos to be played to the jury at trial. Numerous witnesses that testified at trial were unavailable and outside the subpoena power of the District Court. Thus, those witnesses' testimony was presented via their video trial depositions. Invoices regarding this category are appended to **Exhibit A**.
- (d) Electronic document management costs associated with hosting an online platform to enable the Textron Litigation trial team to access the Trustee's complete repository of documents at trial. Invoices regarding this category are appended to **Exhibit A**.
- (e) Lodging, travel and meal expenses for the Trustee's trial counsel and experts during trial. During the course of the trial, the Trustee's trial counsel worked late into the evening each day (often all night), including weekends, to prepare for direct and cross examination of live witnesses, and to prepare for numerous arguments conducted during the course of the trial. Because certain members of the Textron Litigation trial team were working around-the-clock, it was not practical for them to return home before attending the next day of trial. As a result, the Firm provided hotel accommodations and after-hours meals to those individuals.
 - (f) Vendor costs relating to certain mock jury services and expert investigation costs;
- (g) Expert fees and expenses of ANR Partners LLC ("ANR"). ANR was retained by the Trustee as an expert [Docket Nos. 2293 and 2299]. Baker & Hostetler inadvertently paid certain fees and expenses of ANR upon receipt of ANR's invoice, as described in **Exhibit A**, instead of processing those fees for payment by the estate under the Court's expert compensation procedures order [Docket Nos. 2291 and 2298]. ANR's invoice is appended to **Exhibit A** for review and approval in connection with this Application;
- (h) Fees and costs associated with the Trustee's trial technology vendor, PresentationView. PresentationView assisted the Trustee with all technological needs with respect

to the trial, including services necessary to ensure that the Trustee's trial materials could be presented seamlessly through the District Court's system. PresentationView's invoice is appended to **Exhibit A**.

- 15. The amounts set forth herein for which Baker & Hostetler seeks allowance do not include any expenses incurred by the Trustee.
- 16. Baker & Hostetler has received no promise of payment for professional services rendered in these cases other than in accordance with the provisions of the Bankruptcy Code.
- 17. Set forth in **Exhibit A** is a chart showing the actual and necessary expenses incurred by Baker & Hostetler in the amount of \$170,811.10.

IV. REIMBURSEMENT OF EXPENSES

A. Expenses Incurred During The Application Period.

- 18. Baker & Hostetler incurred actual and necessary out-of-pocket expenses in connection with rendering professional services to the Trustee in the sums indicated on **Exhibit A**, for which Baker & Hostetler respectfully requests full reimbursement. The expenses are primarily attributable to the costs of litigation. The disbursements and expenses have been incurred in accordance with the Firm's normal practice of charging clients for expenses clearly related to and required by particular matters. Baker & Hostetler has endeavored to minimize these expenses to the fullest extent possible. Baker & Hostetler also has carefully reviewed and reduced expenses to the extent of meals that exceed a reasonable cost, and for any alcoholic beverages.
- 19. Baker & Hostetler's billing rates do not include charges for photocopying, telephone and telecopier toll charges, computerized research, travel expenses, "working meals," secretarial overtime, postage, and certain other office services, because the needs of each client for such services differ. Instead, Baker & Hostetler charges each client only for the services actually used in performing services for that client. In these proceedings, Baker & Hostetler charges \$.10

per page for internal duplicating and actual phone charge for outgoing facsimile transfers. The firm does not charge for incoming facsimile transfers. The expenses incurred by Baker & Hostetler are in compliance with the UST Guidelines.

V. CONCLUSION

- 20. No agreement or understanding exists between Baker & Hostetler and any other person for the sharing of any compensation to be received for professional services rendered or to be rendered in connection with these cases.
- 21. Except as set forth herein, no prior application has been made in this or in any other Court for the relief requested herein for the Application Period.

WHEREFORE, Baker & Hostetler respectfully requests that this Court enter an Order:

- 1. Approving on an interim basis, the allowance and reimbursement of Baker & Hostetler's out-of-pocket expenses incurred from September 1, 2019 through and including April 30, 2020, in the sum of \$170,811.10;
- 2. Authorizing and directing the Trustee, on an interim basis, to pay Baker & Hostetler's out-of-pocket expenses incurred during the Application Period totaling \$170,811.10; and
 - 3. Granting such other and further relief as this Court may deem just and proper.
