This matter is before the Court on the *Debtors' Motion for Expedited Hearing on Motion Seeking Approval of Modifications to the Debtors' Confirmed Second Amended and Restated Plan of Liquidation Without the Need for Further Disclosure or Solicitation of Votes* (the "Motion")² filed by the above-captioned debtors (collectively, the "Debtors"). The Court has considered the Motion and the other matters reflected in the record. It appears that the Court has jurisdiction over this proceeding; that this is a core proceeding; that no further notice is necessary; and this Court having determined that the relief sought in the Motion is in the best interests of the Debtors' estates, their creditors, and other parties in interest; and upon all of the proceedings had before this Court; and after due deliberation and sufficient cause appearing therefor,

IT IS HEREBY ORDERED THAT:

1. The Motion is GRANTED, as set forth in this Order.
2. A hearing regarding the Modifications Motion will be held on the 16th day of SOB December, 2019 at noon a.m./p.m. (Eastern Time) at the Federal Justice Center, Plaza Bldg, 600 James Brown Blvd (9th St), Augusta, GA 30901.
3. Immediately after the entry of this Order, counsel for the Debtors shall serve a copy of this Order and notice of the Motion on parties originally served with the Modifications Motion in the manner described in the Motion, and such parties as the Court directs. SOB
4. The Debtors shall file a certificate of service with the Clerk of the Court certifying the above-directed service.
5. This Court shall retain jurisdiction to hear and determine all matters arising from or related to the implementation or interpretation of this Order.
