and 2016 of the Federal Rules of Bankruptcy Procedure (the "<u>Bankruptcy Rules</u>") and Rules 2014-1 and 2016-1 of the Local Bankruptcy Rules for the Southern District of New York (the "<u>Local</u> <u>Rules</u>"), authorizing the Equity Committee to employ and retain Glenn Agre Bergman & Fuentes LLP ("<u>Glenn Agre</u>") as counsel to the Equity Committee, substituting Kasowitz Benson Torres LLP ("<u>Kasowitz</u>"), *nunc pro tunc* to February 1, 2021. In support of this Application, the Equity Committee relies upon the declaration of Andrew K. Glenn (the "<u>Glenn Declaration</u>"), managing partner at Glenn Agre, attached hereto as <u>Exhibit B</u>, and the declaration of Gregory S. Williams on behalf of the Equity Committee Chairperson Mountaineer Master Fund, Ltd. c/o Mountaineer Partners Management, LLC ("<u>Mountaineer</u>"), attached hereto as <u>Exhibit C</u> (the "<u>Williams</u> <u>Declaration</u>"), both incorporated herein by reference, and respectfully states as follows:

#### JURISDICTION AND VENUE

1. The Court has jurisdiction to consider this matter pursuant to 28 U.S.C. §§ 157 and 1334. Venue is proper in the Court pursuant to 28 U.S.C. §§ 1408 and 1409. This matter is a core proceeding pursuant to 28 U.S.C. § 157(b).

2. The statutory predicates for the relief requested herein are Sections 328(a), 330 and 1103 of the Bankruptcy Code, Bankruptcy Rules 2014 and 2016, and Local Rules 2014-1 and 2016-1.

#### **BACKGROUND**

3. On September 20, 2020, each of the Debtors filed with this Court a voluntary petition for relief under Chapter 11 of the Bankruptcy Code.

4. The Debtors continue to operate their businesses and manage their properties as debtors in possession pursuant to Sections 1107(a) and 1108 of the Bankruptcy Code. As of the date hereof, no trustee or examiner has been appointed in the Chapter 11 Cases. Joint

administration of these Chapter 11 Cases was authorized by the Court by entry of an order on September 21, 2020 [Docket No. 27].

5. On October 23, 2020, a letter was sent [Docket No. 271] to the United States Trustee for Region 2 (the "<u>U.S. Trustee</u>") on behalf of certain shareholders of the Debtors, seeking that the U.S. Trustee appoint a committee of equity securities holders pursuant to Section 1102(a) of the Bankruptcy Code. On behalf of the shareholders, the letter explained that because the Debtors were rapidly pursuing two competing emergence transactions that each offered shareholders distributable value and significantly impacted their rights, shareholders were entitled to be represented by an independent fiduciary body charged solely with protecting shareholder interests.

6. On November 18, 2020, the U.S. Trustee appointed Mountaineer, Gem Partners LP, and S. Muoio & Company LLC, as members of the Equity Committee. *See Notice of Appointment of Official Committee of Equity Securities Holders* [Docket No. 404]. The Equity Committee selected Mountaineer as Chairperson of the Equity Committee.

7. On November 19, 2020, the Equity Committee selected Kasowitz as its bankruptcy counsel in the Chapter 11 Cases. On February 1, 2021, the Equity Committee selected Glenn Agre as its counsel when key attorneys left Kasowitz to form Glenn Agre. The Equity Committee terminated Kasowitz as its counsel as of February 1, 2021.

#### **<u>RELIEF REQUESTED</u>**

8. By this Application, the Equity Committee seeks entry of an order, pursuant to Sections 328(a) and 1103(a) of the Bankruptcy Code, authorizing the employment and retention of Glenn Agre as counsel to the Equity Committee, to perform necessary legal services pertaining to the Chapter 11 Cases, *nunc pro tunc* to February 1, 2021. Glenn Agre's retention should be

effective as of February 1, 2021 (the date on which the Equity Committee selected Glenn Agre as its counsel in these Chapter 11 Cases) so that Glenn Agre may be compensated for work performed on behalf of the Equity Committee on and after that date but prior to the Court's consideration and approval of this Application.

#### **GLENN AGRE'S QUALIFICATIONS**

9. Glenn Agre is a new law firm with its principal office in New York, New York, and a second office in San Francisco, California. The Equity Committee has selected Glenn Agre as its counsel because of Glenn Agre attorneys' extensive experience and knowledge in the field of debtors' and creditors' rights, business reorganizations, their past representation of the Equity Committee and other official and *ad hoc* creditor and equity committees, and their expertise, experience, and knowledge practicing before bankruptcy courts, including this Court.

10. Attorneys at Glenn Agre have served as counsel to debtors, trustees, creditors' committees and creditors in many of the country's largest bankruptcy proceedings. *See, e.g., In re Covia Holdings, Inc.* (Bankr. S.D. Tex. 2020) (special counsel to creditors' committee); *In re MTE Holdings,LLC*, Case No. 19-12269 (CSS) (Bankr. D. Del 2019) (counsel for the debtors); *In re Exco Resources*, Case No. 18-30155 (MI) (Bankr. S.D. Tex. 2018) (counsel for senior secured lenders); *In re SunEdison Inc.*, Case No. 16-10992 (SMB) (Bankr. S.D.N.Y. 2016) (counsel for ad hoc committee of second lien lenders); *In re ESML Holdings Inc. et al.*, Case No. 16-11626 (BLS) (Bankr. D. 11. Accordingly, Glenn Agre has the necessary capabilities and expertise to serve as counsel and deal effectively with many of the potential legal issues and difficulties that may arise in the context of the Chapter 11 Cases. The Equity Committee believes that Glenn Agre is both well qualified and uniquely able to represent it in an efficient and timely manner.

#### SERVICES TO BE PROVIDED

12. The Equity Committee requests approval of the retention and employment of Glenn Agre for rendering the following necessary legal services required in the Chapter 11 Cases, including, among others:

- a) advise the Equity Committee in connection with its rights, powers and duties under the Bankruptcy Code, the Bankruptcy Rules, and the Local Rules;
- b) assist and advise the Equity Committee in its consultations with the Debtors in connection with the administration of the Chapter 11 Cases;
- c) prepare on behalf of the Equity Committee all necessary motions, applications, answers, orders, reports, and papers in support of positions taken by the Equity Committee;
- d) attend meetings and negotiate with representatives of the Debtors and other parties in interest;
- e) assist and advise the Equity Committee in its examination and analysis of the conduct of the Debtors' affairs;
- f) advise the Equity Committee on the proprietary of any restructuring transaction;
- g) advise the Equity Committee on the review, analysis, and negotiation of any Chapter 11 plan(s) of reorganization that may be filed and assist the Equity Committee in the review, analysis, and negotiation of the disclosure statement(s) accompanying any such plan(s);

- h) take all necessary action to protect and preserve the interests of the Equity Committee, including, if appropriate, by (i) pursuing a stand-alone Chapter 11 plan of reorganization; (ii) prosecuting actions against third parties; (iii) negotiating the resolution of any litigation in which the Debtors are involved; and (iv) reviewing and analyzing claims filed against the Debtors' estates;
- i) appear, as appropriate, before this Court and any other court to protect the interests of the Equity Committee;
- j) communicate with the Equity Committee's constituents in furtherance of its responsibilities, including, but not limited to, communications required under Section 1102 of the Bankruptcy Code;
- k) perform all of the Equity Committee's duties and powers under the Bankruptcy Code and the Bankruptcy Rules and performing such other services as are in the interests of those represented by the Equity Committee; and
- 1) perform all other necessary legal services on behalf of the Equity Committee in the Chapter 11 Cases.

#### PROFESSIONAL COMPENSATION

13. The Equity Committee, subject to the provisions of the Bankruptcy Code, the Bankruptcy Rules, the Local Rules, and further order of the Court, proposes to compensate Glenn Agre at its regular hourly rates for legal and non-legal personnel, and to reimburse Glenn Agre for all reasonable and necessary expenses pursuant to the provisions of Sections 330 and 331 of the Bankruptcy Code. The hourly rates and corresponding rate structure that Glenn Agre will use in these Chapter 11 Cases, which are commensurate with rates charged by similarly situated firms, are the same as those Glenn Agre uses in other restructuring matters, as well as in similarly complex nonbankruptcy matters, whether in court or otherwise, regardless of whether a fee application is required.

14. Glenn Agre did not receive a retainer from the Equity Committee.

15. Glenn Agre's hourly rates are set at a level designed to compensate Glenn Agre fairly for the work of its attorneys and paraprofessionals and to cover fixed and routine expenses.

Hourly rates vary with the experience and seniority of the individuals assigned.

16. Glenn Agre's current hourly billing rates, which are charged the same for both bankruptcy and non-bankruptcy clients, are as follows:

Partners	\$900 - \$1,250
Associates	\$475 - \$875
Staff Attorneys	\$375 - \$475
Paralegals	\$275 - \$350

17. These rates may change from time to time in accordance with Glenn Agre's established billing practices and procedures to reflect economic and other conditions, and, generally, are adjusted in January of each year. Glenn Agre will provide notice of any rate increases to the Debtors, the U.S. Trustee, and the Official Committee of Unsecured Creditors in the Chapter 11 Cases.

#### **GLENN AGRE'S DISINTERESTEDNESS**

18. To the best of the Equity Committee's knowledge, the members of, counsel to, and associates of Glenn Agre do not have any connection with, or any interest adverse to, the Debtors, their creditors, or any other party in interest, or their respective attorneys and accountants, except as forth in the Glenn Declaration.

19. Based upon the Glenn Declaration, Glenn Agre is a "disinterested person" as that term is defined in Section 101(14) of the Bankruptcy Code. The Equity Committee has been informed that Glenn Agre will conduct an ongoing review of its files to ensure that no disqualifying circumstances arise. If any new relevant facts or relationships are discovered, Glenn Agre will supplement its disclosure to the Court accordingly.

#### **BASIS FOR RELIEF**

20. The Equity Committee seeks to appoint Glenn Agre as its counsel in accordance

with Sections 328(a) and 1103 of the Bankruptcy Code. Section 328(a) authorizes a committee appointed under Section 1102 of the Bankruptcy Code, with the court's approval, to employ a "professional person under section 327 or 1103 of this title, as the case may be, on any reasonable terms and conditions of employment, including on a retainer, on an hourly basis, on a fixed or percentage fee basis, or on a contingent fee basis." 11 U.S.C. § 328(a). Section 1103, in turn, requires that an attorney employed to represent a committee "may not, while employed by such committee, represent any other entity having an adverse interest in connection with the case." 11 U.S.C. § 1103.

21. The Equity Committee submits that for all the reasons stated above and in the Glenn Declaration and Williams Declaration, the retention and employment of Glenn Agre as counsel to the Equity Committee is warranted under Sections 328(a) and 1103 of the Bankruptcy Code. Further, as described in the Glenn Declaration, Glenn Agre does not represent any other entity in connection with the Chapter 11 Cases other than the Equity Committee, is a "disinterested person" as that term is defined in Section 101(14) of the Bankruptcy Code, and does not represent or hold any interest adverse to the interests of the Debtors' estates with respect to the matters for which it is to be employed.

Application; and the Court being satisfied, based on therepresentations made in the Application, the Glenn Declaration and the Williams Declaration, that (i) Glenn Agre does not hold or represent any interest adverse to the Debtors' estates, and (ii) Glenn Agre is a "disinterested person" as that phrase is defined in Section 101(14) of the Bankruptcy Code; and the Court having jurisdiction to consider the Application and the relief requested therein in accordance with 28 U.S.C. §§ 157 and 1334; and consideration of the Application and the relief requested therein being a core proceeding pursuant to 28 U.S.C. § 157(b); and venue being proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and due and proper notice of the Application having been provided, and it appearing that no other or further notice need be provided; and the Court having reviewed the Application, the Glenn Declaration and the Williams Declaration; and the Court having found and determined that the relief sought in the Application is in the best interests of the Debtors' estates and all parties in interest and that the legal and factual bases set forth in the Application establish just cause for therelief granted herein; and after due deliberation and sufficient cause appearing therefore,

It is hereby ORDERED that:

1. The Application is granted to the extent set forth herein.

2. Prior to any increase in Glenn Agre's rates, Glenn Agre shall file a supplemental affidavitwith the Court and provide ten business days' notice to the Debtors, the United States Trustee and the Official Committee of Unsecured Creditors. The supplemental affidavit shall explain the basis for the requested rate increases in accordance with Section 330(a)(3)(F) of the Bankruptcy Code and state whether the Equity Committee has consented to the rate increase. The U.S. Trustee retains all rights toobject to any rate increase on all grounds including, but not limited to, the reasonableness standard provided for in Section 330 of the Bankruptcy Code, and the Court retains the authority to review any rate increase pursuant to Section 330 of the Bankruptcy Code.

6. Notwithstanding the possible applicability of Bankruptcy Rule 6004(h), the terms and conditions of this Order shall be effective and enforceable immediately upon its entry.

7. The Court shall retain jurisdiction with respect to all matters arising from or related to the implementation of this Order.

8. Nothing contained herein shall be construed to approve any provision of any agreement between Glenn Agre and the Debtors' estates for indemnification, arbitration, choice of venue, jurisdiction, jury waiver, limitation of damages, or any similar provision.

Inc., *et al.* (collectively, the "<u>Debtors</u>") in the above-captioned Chapter 11 cases (the "<u>Chapter 11</u> <u>Cases</u>") for authorization to retain and employ Glenn Agre as its counsel *nunc pro tunc* to February 1, 2021, at its normal hourly rates in effect from time to time and in accordance with its normal reimbursement policies, and to provide the disclosures required under Sections 328 and 1103 of title 11 of the United States Code (the "<u>Bankruptcy Code</u>"), Rules 2014 and 2016(b) of the Federal Rules of Bankruptcy Procedure (the "<u>Bankruptcy Rules</u>") and Rules 2014-1 and 2016-1 of the Local Bankruptcy Rules for the Southern District of New York (the "<u>Local Rules</u>").

4. Unless otherwise stated in this Declaration, I have personal knowledge of the facts set forth herein. To the extent any information disclosed herein requires amendment or modification upon Glenn Agre's completion of further review, or as additional information regarding parties in interest becomes available, a supplemental declaration will be submitted to the Court reflecting such amended, supplemented, or otherwise modified information.

#### **GLENN AGRE'S QUALIFICATIONS**

5. Glenn Agre is a new law firm with its principal office in New York, New York, and a second office in San Francisco, California. The Equity Committee has selected Glenn Agre as its counsel because of Glenn Agre attorneys' extensive experience and knowledge in the field of debtors' and creditors' rights, business reorganizations, their past representation of the Equity Committee and other official and *ad hoc* creditor and equity committees, and their expertise, experience, and knowledge practicing before bankruptcy courts, including this Court.

6. Attorneys at Glenn Agre have served as counsel to debtors, trustees, creditors' committees and creditors in many of the country's largest bankruptcy proceedings. *See, e.g., In re Covia Holdings, Inc.* (Bankr. - e) assist and advise the Equity Committee in its examination and analysis of the conduct of the Debtors' affairs;
- f) advise the Equity Committee on the proprietary of any restructuring transaction;
- g) advise the Equity Committee on the review, analysis, and negotiation of any Chapter 11 plan(s) of reorganization that may be filed and assist the Equity Committee in the review, analysis, and negotiation of the disclosure statement(s) accompanying any such plan(s);
- h) take all necessary action to protect and preserve the interests of the Equity Committee, including, if appropriate, by (i) pursuing a stand-alone Chapter 11 plan of reorganization; (ii) prosecuting actions against third parties; (iii) negotiating the resolution of any litigation in which the Debtors are involved; and (iv) reviewing and analyzing claims filed against the Debtors' estates;
- i) appear, as appropriate, before this Court and any other court on behalf of the Equity Committee;
- j) communicate with the Equity Committee's constituents in furtherance of its responsibilities, including, but not limited to, communications required under Section 1102 of the Bankruptcy Code;
- k) perform all of the Equity Committee's duties and powers under the Bankruptcy Code and the Bankruptcy Rules and performing such other services as are in the interests of those represented by the Equity Committee; and
- 1) perform all other necessary legal services on behalf of the Equity Committee in the Chapter 11 Cases.

#### **GLENN AGRE'S CONNECTIONS WITH THESE CHAPTER 11 CASES**

9. Glenn Agre utilizes a number of procedures (the "<u>Procedures</u>") to determine its

relationships, if any, to parties that may have connections to parties in interest in the Chapter 11

Cases. In implementing the Procedures, Glenn Agre took the following actions to identify parties

- Glenn Agre compared the Retention Checklist with the names of its clients in its electronic database. This database generally includes the name of each client of Glenn Agre, the contact person at each corporate client, and the names of each party known to be adverse or potentially adverse to the client.
- I then caused the Retention Checklist to be circulated by electronic mail to all Glenn Agre attorneys to determine whether any attorney has any relationship with any such party in interest in these Chapter 11 Cases, including any connections with the U.S. Trustee and the Bankruptcy Judge assigned to these Chapter 11 Cases.
- 10. As part of its practice, Glenn Agre appears in cases, proceedings, and transactions

involving many different creditors, shareholders, attorneys, accountants, financial consultants, investment bankers and other entities, some of which may be or may represent claimants and parties-in-interest in these Chapter 11 Cases. Glenn Agre does not represent any such entity in connection with these Chapter 11 Cases or have a relationship with any such entity or professionals which would imperil its disinterestedness.

11. In addition, if Glenn Agre has or hires professionals who worked at a prior firm on any matter in a material way for any party actually or potentially adverse to these Chapter 11 Cases, Glenn Agre will procedurally "wall off" such professionals from those that work on these Chapter 11 Cases.

12. If Glenn Agre discovers additional information that requires disclosure, Glenn Agre will file a supplemental disclosure statement with the Court.

#### SPECIFIC DISCLOSURES

13. The list attached hereto as <u>Schedule 2</u> (the "<u>Match List</u>") is the product of implementing the Procedures. Glenn Agre previously has represented, currently represents, and may represent in the future the entities described on the Match List (or their affiliates) in matters completely unrelated to the Chapter 11 Cases. An entity is listed as a "Client" on the Match List if Glenn Agre has any open matters for such entity or a known affiliate of such entity and attorney time charges have been recorded on any such matters within the past year.

14. Neither I, nor Glenn Agre, nor any member, counsel or associate thereof, insofar as I have been able to ascertain, or have been informed, has any current connection with the Debtors' creditors or any other party in interest herein, or their respective attorneys, other than the parties listed in the Match List. In addition to the foregoing, through diligent inquiry, I have ascertained no connection, as such term is used in Section 101(14)(C) of the Bankruptcy Code and Bankruptcy Rule 2014(a), between Glenn Agre and (i) the U.S. Trustee or any person employed by the Office of the U.S. Trustee, (ii) any attorneys, accountants, or financial consultants in the Chapter 11 Cases, or (iii) any claimants or other parties in interest in these Chapter 11 Cases.

#### **GLENN AGRE'S DISINTERESTEDNESS**

15. Based upon the above, I believe that Glenn Agre is a "disinterested person" as that term is defined in Section 101(14) of the Bankruptcy Code and as required by Section 1103 of the Bankruptcy Code and that Glenn Agre, its partners, associates, and counsel are not creditors, equity security holders or insiders of the Debtors, and do not hold any interest adverse to the interests of their estates; are not and were not within two years before the commencement of the Chapter 11 Cases, managers or employees of the Debtors or other parties-in-interest; and do not have an

interest materially adverse to the interest of the Debtors' estates or of any class of creditors or equity security holders, by reason of any direct or indirect relationship to, connection with, or interest in, the Debtors or these Chapter 11 Cases, or for any other reason.

#### PROFESSIONAL COMPENSATION

16. Glenn Agre has agreed to receive compensation and reimbursement of expenses in accordance with its standard billing practices and subject to this Court's approval, pursuant to the Bankruptcy Code, the Bankruptcy Rules, the Local Rules, and any procedures or orders of the Court as are applicable to these Chapter 11 Cases.

17. The Equity Committee, subject to the provisions of the Bankruptcy Code, the Bankruptcy Rules, the Local Rules, and further orders of the Court, proposes to compensate Glenn Agre at Glenn Agre's regular hourly rates for legal and non-legal personnel, and to reimburse reasonable and necessary expenses pursuant to Sections 330 and 331 of the Bankruptcy Code.

18. Glenn Agre did not receive a retainer from the Equity Committee.

19. Glenn Agre's hourly rates are set at a level designed to compensate Glenn Agre fairly for the work of its attorneys and paraprofessionals and to cover fixed routine expenses. Hourly rates vary with the experience and seniority of the individuals assigned. The hourly rates and corresponding rate structure Glenn Agre will use in these Chapter 11 Cases are the same as those Glenn Agre uses in other restructuring matters, as well as in similarly complex nonbankruptcy matters, whether in court or otherwise, regardless of whether a fee application is required. Current hourly rates range as follows:

Partners	\$900 - \$1,250
Associates	\$475 - \$875
Staff Attorneys	\$375 - \$475
Paralegals	\$275 - \$350

20. These rates may change from time to time in accordance with Glenn Agre's established billing practices and procedures to reflect economic and other conditions, and, generally, are adjusted in January of each year. Glenn Agre will provide notice of any rate increases to the Debtors, the U.S. Trustee, and the Official Committee of Unsecured Creditors in the Chapter 11 Cases.

21. Glenn Agre, subject to orders of this Court, the Bankruptcy Code, the Bankruptcy Rules, the Local Rules, and the guidelines promulgated by the U.S. Trustee (the "<u>U.S. Trustee</u> <u>Guidelines</u>"), shall seek reimbursement of its expenses incurred in connection with its representation of the Equity Committee in accordance with Glenn Agre's normal reimbursement policies. Glenn Agre's disbursement policies pass through all out-of-pocket expenses at actual cost or an estimated actual cost when the actual cost is difficult to determine. Other reimbursable expenses (whether the service is performed by Glenn Agre in house or through a third-party vendor) include, but are not limited to, facsimiles, overtime meals, deliveries, court costs, transcript fees, travel, and clerk fees.

22. No promises have been received by Glenn Agre, or any member, counsel, or associate thereof, as to payment or compensation in connection with these Chapter 11 Cases other than in accordance with the provisions of the Bankruptcy Code, the Bankruptcy Rules, the Local Rules, the U.S. Trustee Guidelines, and such other procedures that have been or may be fixed by order of this Court. Glenn Agre has no agreement with any other entity to share with such entity any compensation received by Glenn Agre or by such entity.

#### **STATEMENT REGARDING U.S. TRUSTEE GUIDELINES**

23. Glenn Agre shall apply for compensation for professional services rendered and reimbursement of expenses incurred in connection with the Chapter 11 Cases in compliance with

Glenn Agre also intends to make a reasonable effort to comply with the U.S. Trustee's requests for information and additional disclosures as set forth in the *Guidelines for Reviewing Applications for Compensation and Reimbursement of Expenses Filed Under 11 U.S.C. § 330 by Attorneys in Larger Chapter 11 Cases Effective As of November 1, 2013* (the "Revised UST Guidelines"), both in connection with the Application and the interim and final fee applications to be filed by Glenn Agre in these Chapter 11 Cases.

#### ATTORNEY STATEMENT REGARDING U.S. TRUSTEE GUIDELINES

24. Pursuant to paragraph D, section 1 of the Revised UST Guidelines, Glenn Agre responds to the questions set forth therein as follows:

- **Question:** Did you agree to any variations from, or alternatives to, your standard or customary billing arrangements for this engagement?
- Response: No.
- **<u>Question</u>**: Do any of the professionals included in this engagement vary their rate based on the geographic location of the bankruptcy case?
- **<u>Response</u>**: No. The hourly rates used by Glenn Agre in representing the Equity Committee are consistent with the rates that Glenn Agre charges other comparable Chapter 11 clients, regardless of the location of the Chapter 11 case.
- **Question:** If you represented the client in the twelve (12) months prepetition, disclose your billing rates and material financial terms for the prepetition engagement, including any adjustments during the 12 months prepetition. If your billing rates and material financial terms have changed postpetition, explain the difference and the reasons for the difference.
- **<u>Response</u>**: Glenn Agre did not represent the Equity Committee or any of its members in the 12 months prepetition.

- **<u>Question</u>**: Has your client approved your prospective budget and staffing plan, and, if so, for what budget period?
- **Response:** Glenn Agre is in the process of developing and sharing with the Equity Committee a budget and staffing plan for all the professionals retained by the Equity Committee to comply with the U.S. Trustee's requests for information and additional disclosures, and any orders of this Court. Should these Chapter 11 Cases continue beyond the initial budgeted period, Glenn Agre intends to work with the Equity Committee to develop a prospective budget and staffing plan to comply with the U.S. Trustee's requests for information and additional disclosures through the conclusion of these Chapter 11 Cases.

#### **COORDINATION WITH OTHER PROFESSIONALS OF THE EQUITY COMMITTEE**

25. Glenn Agre intends to carefully monitor and coordinate efforts with the Equity Committee's other professionals throughout these Chapter 11 Cases and will clearly delineate its respective duties so as to prevent duplication of effort whenever possible.

#### **CONCLUSION**

26. The Application requests approval of the Equity Committee's retention of Glenn Agre at Glenn Agre's normal hourly rates in effect at the time the services are rendered and in accordance with Glenn Agre's normal reimbursement policies, subject to any modifications to such policies that Glenn Agre may be required to make to comply with orders of this Court, the Bankruptcy Code, the Bankruptcy Rules, the Local Rules, and the U.S. Trustee Guidelines. Subject to these terms and conditions, Glenn Agre intends to apply, pursuant to Section 330 of the Bankruptcy Code, for allowances of compensation for professional services rendered in these Chapter 11 Cases and for reimbursement of actual and necessary expenses incurred in connection therewith in accordance with the provisions of the Bankruptcy Code, the Bankruptcy Rules, the Local Rules, and the U.S. Trustee Guidelines.

#### DECLARATION OF GREGORY S. WILLIAMS IN SUPPORT OF APPLICATION OF OFFICIAL COMMITTEE OF EQUITY SECURITIES HOLDERS OF GARRET MOTION INC. FOR ORDER AUTHORIZING THE RETENTION AND EMPLOYMENT OF GLENN AGRE BERGMAN & FUENTES LLP AS COUNSEL NUNC PRO TUNC TO FEBRUARY 1, 2021

I, Gregory S. Williams being duly sworn, state the following under penalty of perjury:

1. I am a member and representative of Mountaineer Master Fund, Ltd. c/o Mountaineering Partners Management, LLC ("<u>Mountaineer</u>"), Chairperson of the Official Committee of Equity Securities Holders (the "<u>Equity Committee</u>") of Garret Motion Inc., *et al.* (collectively, the "<u>Debtors</u>") in the above-captioned Chapter 11 cases (the "<u>Chapter 11 Cases</u>"), and I am authorized to make this declaration (the "<u>Declaration</u>") in support of the Equity Committee's application (the "<u>Application</u>") for authorization to retain Glenn Agre Bergman & Fuentes LLP ("<u>Glenn Agre</u>") as bankruptcy counsel to the Equity Committee pursuant to Sections 328(a) and 1103(a) of the Bankruptcy Code, Bankruptcy Rules 2014 and 2016, and Local Rules 2014-1 and 2016-1.<sup>2</sup>

2. This Declaration is provided pursuant to the *Guidelines for Reviewing Applications for Compensation and Reimbursement of Expenses Filed under 11 U.S.C. § 330 by Attorneys in Larger Chapter 11 Cases Effective as of November 1, 2013* (the "<u>Revised UST</u> <u>Guidelines</u>"). Except as otherwise noted herein, all facts in this Declaration are based on my personal knowledge of thematters set forth herein, information gathered from my review of relevant documents, and information supplied to me by Glenn Agre.

3. I am informed by Glenn Agre that Paragraph (D)(2) of the Revised UST Guidelines requires that any application for employment of an attorney under Section 1103 of the Bankruptcy Code be accompanied by a verified statement from the client that addresses the following:

- a. The identity and position of the person making the verification. The person ordinarily should be the general counsel of the client or another officer responsible for supervising outside counsel and monitoring and controlling legal costs.
- b. The steps taken by the client to ensure that the applicant's billing rates and material terms for the engagement are comparable to the applicant's billing rates and terms for other non-bankruptcy engagements and to the billing rates and terms of other comparably skilled professionals.
- c. The number of firms the client interviewed.
- d. If the billing rates are not comparable to the applicant's billing rates for other non-bankruptcy engagements and to the billing rates of other comparably-skilled professionals, the circumstances warranting the retention of that firm.
- e. The procedures the client has established to supervise the applicant's fees and expenses and to manage costs. If the procedures for the budgeting, review and approval of fees and expenses differ from those the client regularly employs in non-bankruptcy cases to supervise outside counsel, explain how and why. In addition, describe any efforts to negotiate rates, including rates for routine matters, or in the alternative to delegate such matters to less expensive counsel.

#### **IDENTITY OF DECLARANT**

4. On November 18, 2020, the U.S. Trustee appointed Mountaineer, Gem Partners LP, and S. Muoio & Company LLC to serve on the Equity Committee. *See Notice of Appointment of Official Committee of EquitySecurities Holders* [Docket No. 404]. The Equity Committee selected Mountaineer as Chairperson of the Equity Committee.

5. As a member and representative of the Equity Committee Chairperson, I was directly involved in the Equity Committee's decision to retain Glenn Agre and actively participated in negotiating the terms of Glenn Agre's employment together with the other members of the Equity Committee

#### STEPS TAKEN TO ENSURE THE COMPARABILITY OF ENGAGEMENT TERMS

6. Glenn Agre has informed the Equity Committee that its rates for bankruptcy representations are comparable to the rates Glenn Agre charges for non-bankruptcy representations, and that Glenn Agre endeavors to set its hourly rates for attorneys and paraprofessionals at levels competitive to those charged by peer firms. The Equity Committee has also determined that Glenn Agre's rates are reasonable based on the hourly rates of other retained professionals in these Chapter 11 Cases.

#### THE EQUITY COMMITTEE'S SELECTION OF COUNSEL

7. The Equity Committee recognizes that a comprehensive review process is necessary when selecting counsel in Chapter 11 cases to ensure that professionals are subject to the same client-driven market forces, scrutiny, and accountability as professionals in nonbankruptcy engagements.

8. To that end, the review process utilized by the Equity Committee assessed potential counsel based on their expertise in the relevant legal issues and in similar proceedings.

Following its appointment, the Equity Committee selected four law firms to interview to represent the Equity Committee as counsel in these Chapter 11 Cases. The Equity Committee selected Kasowitz Benson Torres LLP ("Kasowitz") as its counsel in these Chapter 11 Cases, and subsequently selected Glenn Agre when key attorneys left Kasowitz to form Glenn Agre. The Equity Committee selected Glenn Agre after careful deliberation based on, among other things, Glenn Agre attorneys' experience and knowledge in creditors' rights, in business reorganizations and liquidations under Chapter 11, their expertise, experience, and knowledge in the area of bankruptcy law, their ability to respond quickly to emergency hearings and other emergency matters in this Court, and for the reasons further stated in the Application. I believe that Glenn Agre is both well qualified and uniquely able to represent the Equity Committee in these Chapter 11 Cases in an efficient and timely manner.

#### **RATE STRUCTURE**

9. In my capacity as a member and representative of the Chairperson, Mountaineer, I am responsible for hiring the counsel retained by the Equity Committee. Glenn Agre has informed the Equity Committee that its rates for bankruptcy representations are comparable to the rates Glenn Agre charges for nonbankruptcy representations. Glenn Agre charges the Equity Committee using the rates below:

Partners	\$900 - \$1,250
Associates	\$475 - \$875
Staff Attorneys	\$375 - \$475
Paralegals	\$275 - \$350

#### **COST SUPERVISION**

10. The Equity Committee recognizes its responsibility to closely monitor Glenn Agre's billing practices to ensure the fees and expenses charged are consistent with the Equity

Committee's expectations and the exigencies of these Chapter 11 Cases. Accordingly, the Equity Committee will work with Glenn Agre to develop a prospective budget and staffing plan, which the Equity Committee intends to review on an ongoing basis, as necessary. The Equity Committee will also review Glenn Agre's invoices and any applications for payment of fees and reimbursement of expenses that it submits to the Court. In addition, Glenn Agre's fees and expenses will be subject to review, comment, objection (if warranted), and Court approval pursuant to any procedures that may be or have already been established by the Court in these Chapter 11 Cases.

11. The Equity Committee has been advised Glenn Agre will work closely with any other advisors retained to prevent unnecessary or inefficient duplication of services, and will utilize their respective skills and experience and take all necessary and appropriate steps to avoid any such duplication.

12. Nothing contained herein is intended to limit Glenn Agre's ability to request allowance and payment of fees and expenses pursuant to Sections 330 and 331 of the Bankruptcy Code, or to restrict Glenn Agre's right to defend against any objection raised to the allowance or payment of such fees, or to restrict the Equity Committee's right to use conflicts counsel to prosecute any such fee objection to the extent it is not resolved informally by the parties or raised by another party-in-interest, such as the U.S. Trustee.

13. The Equity Committee will continue to bring discipline, predictability, client involvement, and accountability to the counsel fees and expenses-reimbursement process. While every Chapter 11 case is unique, the budget developed jointly by Glenn Agre and the Equity Committee will provide guidance on the periods of time involved, the level of the attorneys and
