## ORDER ESTABLISHING DEADLINES FOR FILING PROOFS OF CLAIM AGAINST CERTAIN DEBTORS AND APPROVING FORM AND MANNER OF NOTICE THEREOF

Jointly Administered

Upon the motion (the "Motion")<sup>2</sup> of Garrett Motion Inc., and its affiliated debtors and debtors-in-possession (collectively, the "Debtors"), for entry of an order (this "Order") establishing deadlines for filing proofs of claim against the Seller Debtors and approving the form and manner of notice thereof; and this Court having jurisdiction to consider the Motion pursuant to 28 U.S.C. §§ 157 and 1334; and venue of these Chapter 11 Cases and the Motion in this district being proper pursuant to 28 U.S.C. §§ 1408 and 1409; and this matter being a core proceeding pursuant to 28 U.S.C. § 157(b); and this Court having found that proper and adequate notice of the Motion and the relief requested therein has been provided in accordance with the Bankruptcy Rules and the Local Rules, and that, except as otherwise ordered herein, no other or further notice is necessary; and any objections (if any) to the Motion having been withdrawn, resolved or overruled on the merits; and a hearing having been held to consider the relief

requested in the Motion; and upon the record of the hearing and all of the proceedings had before this Court; and this Court having found and determined that the relief sought in the Motion is in the best interests of the Debtors, their estates, their creditors and all other parties-in-interest; and that the legal and factual bases set forth in the Motion establish just cause for the relief granted herein; and after due deliberation and sufficient cause appearing therefor;

#### IT IS HEREBY ORDERED THAT:

- 1. The Motion is GRANTED to the extent set forth herein.
- 2. The General Bar Date, Amended Schedule Bar Date, and Governmental Bar Date; the Bar Date Notice Package; and the manner of providing notice of the Bar Dates and filing of proofs of claim as proposed in the Motion are approved. The Debtors are hereby authorized to serve the Bar Date Notice Package as set forth in this Order.
- 3. Except as otherwise provided herein, all persons and entities, (including, without limitation, individuals, partnerships, corporations, joint ventures, and trusts) that assert a claim, as defined in section 101(5) of the Bankruptcy Code, against the Seller Debtors which arose on or prior to the Petition Date, *including* claims pursuant to section 503(b)(9) of the Bankruptcy Code (each, a "503(b)(9) Claim"), shall file a proof of such claim so that it is actually received by the Bankruptcy Court or KCC LLC ("KCC", or the "Claims and Noticing Agent") pursuant to paragraph 5 herein on or before **December 18, 2020 at 4:00 p.m.** (Eastern Time).
- 4. Notwithstanding any other provision hereof, proofs of claim filed by governmental units (as defined in section 101(27) of the Bankruptcy Code) must be filed so as to be actually received by the Claims and Noticing Agent on or before **May 3, 2021 at 4:00 p.m.**

(**Eastern Time**) (the first business day following the date that is 180 days after the date of this Order).

- 5. The following procedures for the filing of proofs of claim shall apply:
  - a. Proofs of claim must be submitted on the proof of claim form attached hereto as Exhibit 2 (the "<u>Proof of Claim Form</u>") or on a form that otherwise conforms substantially to Official Bankruptcy Form No. 410:
  - b. Proofs of claim must be filed (a) electronically through the website of the Debtors' Court-approved claims and noticing agent, KCC, using the interface available on such website located at <a href="http://www.kccllc.net/garrettmotion">http://www.kccllc.net/garrettmotion</a>, under the link entitled "Submit Electronic Proof of Claim (ePOC)," (b) by hand delivery or mailing the original proof of claim form either by U.S. Postal Service mail or overnight delivery on or before the applicable Bar Date to Garrett Motion Claims Processing Center, c/o KCC, 222 N. Pacific Coast Highway, Suite 300, El Segundo, CA 90245, or (c) by delivering the original proof of claim by hand to the United States Bankruptcy Court, Southern District of New York, One Bowling Green, Room 614, New York, NY 10004-1408.
  - c. Proofs of claim shall be deemed filed only when actually <u>received</u> by the Claims and Noticing Agent on or before the applicable Bar Date.
  - d. Proofs of claim must (i) be written in English; (ii) include a claim amount denominated in United States dollars; (iii) include supporting documentation (or, if such documentation is voluminous, a summary) or an explanation as to why such documentation is not available; (iv) conform substantially with the Proof of Claim Form provided by the Debtors or Official Bankruptcy Form No. 410; and (v) be signed by the claimant or the claimant's authorized agent.
  - e. In addition to the requirements set forth in (d) above, any proof of claim asserting a 503(b)(9) Claim must also: (i) include the value of the goods delivered to and received by the Seller Debtors in the 20 days prior to the Petition Date; (ii) attach any documentation identifying the particular invoices for which the 503(b)(9) Claim is being asserted; and (iii) set forth whether any portion of the 503(b)(9) Claim was satisfied by payments made by the Seller Debtors pursuant to any order of this Court authorizing the Seller Debtors to pay prepetition claims.
  - f. Proofs of claim must specify by name and case number of the Seller Debtor against which the claim is filed. If the holder asserts a claim

against more than one Seller Debtor or has claims against different Seller Debtors, a separate proof of claim form must be filed with respect to each Seller Debtor.

- 6. Proofs of Claim need not be filed as to the following types of claims:
  - a. any claim as to which the holder has already filed a proof of claim against the applicable Seller Debtor with the Clerk of the Bankruptcy Court for the Southern District of New York or with KCC in a form substantially similar to Official Bankruptcy Form No. 410 adopted by the Court so long as the claimant does not wish to assert such claim against a Seller Debtor who was not named in the original claim, in which case another Proof of Claim must be filed;
  - b. any claim that is listed on the Schedules filed by the Seller Debtors unless: (i) such claim is scheduled as "disputed," "contingent" or "unliquidated," (ii) the claimant disagrees with the amount, nature or priority of the claim as set forth in the Seller Debtors' Schedules, or (iii) the claimant believes its claim is an obligation of one or more Seller Debtors other than (or in addition to) the Seller Debtor against which the claim is listed on the Schedules;
  - c. any claim that has been allowed by order of this Court;
  - d. any claim that has been paid in full by any of the Seller Debtors;
  - e. any claim for which a different specific deadline has previously been fixed by this Court;
  - f. any claim by a Debtor against a Seller Debtor, or any claim by any of the non-debtor subsidiaries of Garrett Motion Inc. having a claim against any of the Debtors;
  - g. any claim allowable under § 503(b) and § 507(a)(2) of the Bankruptcy Code as an administrative expense (other than a claim arising under section 503(b)(9) of the Bankruptcy Code);
  - h. any claim for which the holder thereof is not required to file a proof of claim pursuant to an order of the Court; and
  - i. any claim limited exclusively to the repayment of principal, interest and/or other applicable fees and charges (a "<u>Debt Claim</u>") owed under any credit agreement, bond or note issued or guaranteed by the Seller Debtors pursuant to an indenture (the "<u>Debt Instrument</u>"); <u>provided</u> that (i) an indenture trustee or agent under a Debt Instrument must file one proof of claim, on or before the General Bar Date, with respect to all of the amounts owed under each of the Debt Instruments and (ii) any holder of a Debt Claim wishing to assert a claim, other than a Debt

Claim, arising out of or relating to a Debt Instrument must file a proof of claim on or before the General Bar Date, unless another exception in the Bar Date Notice applies.

- 7. Any person or entity that holds a claim that arises from the rejection of an executory contract or unexpired lease, as to which the order authorizing such rejection is dated on or before the date of entry of this Order, must file a proof of claim based on such rejection on or before the Bar Date, and any person or entity that holds a claim that arises from the rejection of an executory contract or unexpired lease, as to which an order authorizing such rejection is dated after the date of entry of this Order, must file a proof of claim on or before such date as the Court may fix in the applicable order authorizing such rejection.
- 8. Holders of equity security interests in the Seller Debtors need not file proofs of interest with respect to the ownership of such equity interests; provided, however, that if any such holder asserts a claim against any of the Seller Debtors (including a claim relating to an equity interest or the purchase or sale of such equity interest), a proof of such claim must be filed on or prior to the applicable Bar Date pursuant to the procedures set forth in this Order.
- 9. If the Seller Debtors amend or supplement the Schedules subsequent to the date hereof, the Seller Debtors shall give notice of any amendment or supplement (a "Schedule Amendment") to the holders of claims affected thereby. The terms of this Order shall apply to all persons and entities affected by a Schedule Amendment, except that the last date by which such person or entity may file a proof of claim with respect to a claim affected by a Schedule Amendment shall be *the later of*: (a) the General Bar Date or the Governmental Bar Date, as is applicable and (b) 4:00 p.m., Eastern Time, on the date that is 30 days after the date that notice of the applicable amendment or supplement to the Schedules is served on such entity (the "Amended Schedule Bar Date"). Any such holders of claims shall be given notice of such deadline.

- 10. Nothing in this Order shall prejudice any right of the Debtors or any other party-in-interest to dispute or assert offsets or defenses to any claim included in the Schedules.
- 11. Pursuant to Bankruptcy Rule 3003(c)(2), all holders of claims that fail to comply with this Order by timely filing a proof of claim in appropriate form, if required, shall not be treated as a creditor with respect to such claim for purposes of voting on or receiving any distribution under any plan of reorganization in these Chapter 11 Cases.
- 12. A copy of the notice substantially in the form attached hereto as Exhibit 1 (the "Bar Date Notice") hereby is approved and shall be deemed adequate and sufficient if served by email, where practicable, and by first-class mail as soon as possible but in no event later than November 6, 2020 on:
  - a. the U.S. Trustee;
  - b. counsel to the Official Committee of Unsecured Creditors appointed in these Chapter 11 Cases (the "<u>Committee</u>") and counsel to any other similarly appointed official committee;
  - c. all persons or entities that have requested notice in these Chapter 11 Cases;
  - d. all persons or entities that have previously filed a proof of claim in these Chapter 11 Cases;
  - e. all known creditors and potential holders of claims as of the date of this Order, including those listed in the Seller Debtors' Schedules as holding potential claims against the Seller Debtors;
  - f. all parties to executory contracts and unexpired leases of the Seller Debtors;
  - g. all parties to pending litigation with the Seller Debtors;
  - h. the Internal Revenue Service, the Securities and Exchange Commission, and all known applicable taxing authorities and other governmental units; and
  - i. such additional persons and entities as deemed appropriate by the Debtors.

- shall mail or electronically serve one or more proof of claim forms (as appropriate) substantially similar to the Proof of Claim Form, indicating on such form how the Debtors have scheduled such claim in the Seller Debtors' Schedules (including: (a) the identity of the Seller Debtor against which the claim is scheduled; (b) the amount of the scheduled claim, if any; (c) whether the claim is scheduled as disputed, contingent or unliquidated and (d) whether the claim is scheduled as a secured, unsecured priority or unsecured nonpriority claim).
- 14. Pursuant to Bankruptcy Rule 2002(*l*), the Debtors shall publish notice of the Bar Dates, in substantially the form attached hereto as Exhibit 3 (the "Publication Notice"), in the *Financial Times* and in the *New York Times*, in each case once as soon as practicable but in any event no later than 28 days prior to the General Bar Date, which publication is hereby approved and shall be deemed good, adequate and sufficient publication notice of the Bar Dates. The Debtors, after consultation with the Committee, may publish the Publication Notice in other newspapers, trade journals or similar publications as the Debtors deem appropriate.
- 15. The Debtors and KCC are authorized and empowered to execute and deliver such documents, and to take and perform all actions necessary to implement and effectuate the relief granted in this Order.
- 16. The entry of this Order is without prejudice to the right of the Debtors to seek a further order of this Court fixing a date by which holders of claims or interests not subject to the Bar Dates established herein must file such proofs of claim or interest or be barred from doing so.

#### 1. WHO MUST FILE A PROOF OF CLAIM

You MUST file a proof of claim to vote on a chapter 11 plan or to share in distributions from the Debtors' bankruptcy estates if you have a claim against a Seller Debtor, including any such claim asserting administrative expense status under section 503(b)(9) of the Bankruptcy Code, that arose prior to **September 20, 2020** (the "Petition Date"), and it is not one of the types of claim described in Section 4 below. Claims based on acts or omissions of the Seller Debtors that occurred before the Petition Date must be filed on or prior to the General Bar Date (or, if applicable, one of the other deadlines described below), even if such claims are not now fixed, liquidated or certain or did not mature or become fixed, liquidated or certain before the Petition Date.

The Bar Date Order establishes the following bar dates for filing proofs of claim against the Seller Debtors in these Chapter 11 Cases (collectively, the "<u>Bar Dates</u>"):

- a. General Bar Date. Except as otherwise described in this Notice, all persons and entities that hold a claim against any of the Seller Debtors that arose prior to the Petition Date shall file a proof of claim as described in this Notice by December 18, 2020 at 4:00 p.m., Eastern Time. For the avoidance of doubt, the General Bar Date applies to all 503(b)(9) Claims against the Seller Debtors.
- b. Amended Schedule Bar Date. If any of the Seller Debtors amends or supplements its schedules of assets and liabilities filed in these cases (the "Schedules"), the last date by which any claimant affected by such amendment or supplement may file a proof of claim or make any amendments to a previously filed proof of claim shall be the date that is the later of (i) the General Bar Date or the Governmental Bar Date (as defined below), as is applicable and (ii) 4:00 p.m., Eastern Time, on the date that is 30 days after the date that notice of the applicable amendment or supplement to the Seller Debtors' Schedules is served on the claimant (the "Amended Schedule Bar Date").
- c. Governmental Bar Date. All governmental units (as defined in section 101(27) of the Bankruptcy Code (as defined below)) holding claims against any of the Debtors that arose or are deemed to have arisen prior to the Petition Date must file proofs of claim by May 3, 2021 at 4:00 p.m., Eastern Time (the "Governmental Bar Date"). This Governmental Bar Date applies to all types of claims by any governmental unit against any of the Seller Debtors arising prior to the Petition Date, including secured claims, unsecured priority claims and unsecured nonpriority claims, subject to the exceptions described in Section 4 below.

The Bar Dates listed above only apply with respect to claims against the Seller Debtors and do not apply with respect to claims against any Debtors other than the Seller Debtors.

Section 101(5) of title 11 of the United States Code, 11 U.S.C. §§ 101 *et seq*. You will receive a different proof of claim form for each claim scheduled in your name by the Seller Debtors. You may utilize the claim form(s) provided by the Debtors to file your claim. Additional proof of claim forms may be obtained at <a href="http://www.uscourts.gov/forms/bankruptcy-forms">http://www.uscourts.gov/forms/bankruptcy-forms</a>.

All proof of claim forms **must be signed** by the claimant or, if the claimant is not an individual, by an authorized agent of the claimant. Your signature may be digitally signed if your claim is filed electronically. Each proof of claim form must be written in English and be denominated in United States currency. You should attach to your completed proof of claim form any documents on which the claim is based (or, if such documents are voluminous, attach a summary) or an explanation as to why the documents are not available.

In addition to the requirements set forth in the immediately preceding paragraph, any proof of claim asserting a 503(b)(9) Claim must also: (i) include the value of the goods delivered to and received by the Seller Debtors in the 20 days prior to the Petition Date; (ii) attach any documentation identifying the particular invoices for which the 503(b)(9) Claim is being asserted; and (iii) set forth whether any portion of the 503(b)(9) Claim was satisfied by payments made by the Seller Debtors pursuant to any order of the Court authorizing the Seller Debtors to pay prepetition claims.

Your proof of claim form must not contain complete social security numbers or taxpayer identification numbers (only the last four digits), a complete birth date (only the year), the name of a minor (only the minor's initials) or a financial account number (only the last four digits of such financial account).

Proofs of claim must specify by name and case number of the Seller Debtor against which the claim is filed. If the holder asserts a claim against more than one Seller Debtor or has claims against different Seller Debtors, a separate proof of claim form must be filed with respect to each Seller Debtor. Proofs of claim will be deemed filed only when <u>received</u> at the address listed above or filed electronically on or before the applicable Bar Date. Proofs of claim may NOT be delivered by facsimile, telecopy or electronic mail transmission.

#### 4. CLAIMS FOR WHICH PROOFS OF CLAIM NEED NOT BE FILED

You do <u>not</u> need to file a proof of claim on or prior to the applicable Bar Date described in this Notice if the claim falls into one of the following categories:

- a. Any claim as to which the holder has already filed a proof of claim against the applicable Seller Debtor with the Clerk of the Bankruptcy Court for the Southern District of New York or with KCC in a form substantially similar to Official Bankruptcy Form No. 410 adopted by the Court so long as the claimant does not wish to assert such claim against a Seller Debtor who was not named in the original claim, in which case another Proof of Claim must be filed;
- b. Any claim that is listed on the Schedules filed by the Seller Debtors unless: (i) such claim is scheduled as "disputed," "contingent" or "unliquidated," (ii) the claimant disagrees with the amount, nature or priority of the claim as set forth in the Seller Debtors' Schedules, or (iii) the claimant believes its claim is an obligation of one or more Seller Debtors other than (or in addition to) the Seller Debtor against which the claim is listed on the Schedules;
- c. Any claim that has been allowed by order of this Court;
- d. Any claim that has been paid in full by any of the Seller Debtors;

- e. Any claim for which a different specific deadline has previously been fixed by this Court;
- f. Any claim by a Debtor against a Seller Debtor, or any claim by any of the non-debtor subsidiaries of Garrett Motion Inc. having a claim against any of the Debtors;
- g. Any claim allowable under § 503(b) and § 507(a)(2) of the Bankruptcy Code as an administrative expense (other than a claim arising under section 503(b)(9) of the Bankruptcy Code);
- h. Any claim for which the holder thereof is not required to file a proof of claim pursuant to an order of the Court; andAny claim limited exclusively to the repayment of principal, interest and/or other applicable fees and charges (a "Debt Claim") owed under any credit agreement, bond or note issued or guaranteed by the Seller Debtors pursuant to an indenture (the "Debt Instrument"); provided that (i) an indenture trustee or agent under a Debt Instrument must file one proof of claim, on or before the General Bar Date, with respect to all of the amounts owed under each of the Debt Instruments and (ii) any holder of a Debt Claim wishing to assert a claim, other than a Debt Claim, arising out of or relating to a Debt Instrument must file a proof of claim on or before the General Bar Date, unless another exception in the Bar Date Notice applies.

If you are a holder of an equity interest in any of the Seller Debtors, you need not file a proof of interest with respect to the ownership of such equity interest at this time. However, if you assert a claim against any of the Seller Debtors, including a claim relating to such equity interest or the purchase or sale of such interest, a proof of such claim must be filed on or prior to the applicable Bar Date pursuant to the procedures set forth in this Notice.

This Notice is being sent to many persons and entities that have had some relationship with or have done business with the Seller Debtors but may not have an unpaid claim against the Seller Debtors. The fact that you have received this Notice does not mean that you have a claim or that the Seller Debtors or the Court believe that you have a claim against the Seller Debtors.

### 5. EXECUTORY CONTRACTS AND UNEXPIRED LEASES
