# GENERAL UNSECURED CLAIMS LITIGATION TRUST'S SECOND OMNIBUS OBJECTION TO CONVENIENCE CLAIMS (PAID/SATISFIED CLAIMS)

NOW COMES the General Unsecured Claims Litigation Trust (the "GUC Trust") by and through the undersigned counsel, and states:

### General Case Background

- 1. On October 1, 2013, Groeb Farms, Inc. ("Groeb", or the "Debtor") filed a voluntary petition for relief under chapter 11 of title 11 of the United States Code, 11 U.S.C. §101, et seq. (the "Bankruptcy Code").
- 2. On November 8, 2013, the Debtor filed its Second Amended Plan of Groeb Farms, Inc., Pursuant to Chapter 11 of the Bankruptcy Code (the "Plan") [D.I. 213]. On December 20, 2013, this Court entered the Order Confirming The Second Amended Plan of Reorganization of Groeb Farms, Inc., Pursuant to Chapter 11 of the Bankruptcy Code (the "Confirmation Order") [D.I. 375]. The Plan became effective on December 31, 2013 (the "Effective Date").
- 3. In accordance with the terms of the Plan, on the Effective Date, the GUC Trust was created for purposes including, among other things, pursuing and/or liquidating the GUC Trust Assets (as defined in the Plan), distributing the GUC Trust Distributable Proceeds (as defined in the Plan), if any, and reconciling and objecting to General Unsecured Claims as provided for in the Plan. The GUC Trustee has the power to act on behalf of the GUC Trust.

### Objection

4. Under the Plan, any Allowed General Unsecured Claim other than Trade Claims that are \$7,500 or less were classified as Unsecured Convenience Class Claims (the "Convenience Claims") under Class 5C of the Plan (the "Convenience

- <u>Class</u>"). See Plan at Art. III.C.7. Further, holders of Allowed General Unsecured Claims in excess of \$7,500 could "opt in" to the Convenience Class.
- 5. Set forth on **Exhibit A** hereto and incorporated by reference are the scheduled or proofs of claims on account of the Convenience Claims.
- 6. Upon the Effective Date of the Plan or as soon as reasonably practicable thereafter, holders of Convenience Claims received payment in full in Cash pursuant to the Convenience Class Distribution from the reorganized Debtor, unless such other lesser favorable treatment was agreed upon by the claimant. *See id*.
- 7. Accordingly, the Convenience Claims have been satisfied in full under the Plan, the GUC Trust requests entry of an Order marking such claims as satisfied under the Plan and not entitled to receive a distribution from the GUC Trust.
- 8. Section 502 of the Bankruptcy Code, and other applicable non-bankruptcy law set forth below, provide the bases for the relief sought in this Objection. Section 502(b) states in relevant part that:

[T]he court, after notice and a hearing, shall determine the amount of [a] claim in lawful currency of the United States as of the date of the filing of the petition, and shall allow such claim in such amount, except to the extent that—

(1) such claim is unenforceable against the debtor or property of the debtor, under any agreement or applicable law for a reason other than because such claim is contingent or unmatured ...

11 U.S.C. § 502(b).

WHEREFORE, for the reasons set forth above, the GUC Trust requests that the Court enter an Order directing that the Convenience Claims be marked as satisfied on the Court's claims register for purposes of distribution by the GUC Trust as set forth in the attached proposed Order.
