
SUPPLEMENTAL AFFIDAVIT OF SERVICE

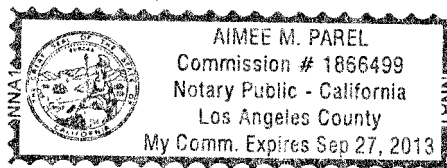
