Participants will have the option to disable the video and use the audio option only. However, attorneys who anticipate giving extensive legal argument or examining witnesses are strongly encouraged to utilize the video function. Witnesses are required to use the video function if possible.

NOTE: If you are experiencing audio issues with the WebEx application, you may use the "Call Me At" selection under "Audio Connection" to move just the audio portion of the WebEx conference to your telephone.

HELPFUL HINTS AND ETIQUETTE

- 1. Please use the mute function when you are not speaking. Please be aware that sometimes the court mutes everyone when there is background noise. When you want to speak, make sure you are not on mute. Participants who use the call-in option may dial *6 to unmute.
- 2. Remember to state your name for the record each time before speaking.
- 3. Use headphones whenever possible, especially if using a desktop PC with external speakers.
- 4. During examination, attorneys and witnesses should use a separate camera and microphone.
- 5. WebEx participants may use the "share" button to easily share their screen or document with the court or other WebEx participants.
- 6. Suggestions for those participating in a WebEx from home: If you are having connectivity problems, turn off devices that may be using bandwidth on your home network. Devices or applications such as Facetime, Roku, streaming media players, video games, or large downloads can negatively impact the audio and video quality of the WebEx meeting.
