No. 988] for allowance of compensation to Foley & Lardner LLP ("Foley") for professional services rendered in the above-captioned Chapter 11 Case during the period from April 1, 2020 through and including July 31, 2020 (the "<u>Second Interim Period</u>").

Based on the Agreement of the Debtor, Foley and the office of the United States Trustee, the Application is granted in part as set forth herein and it is HEREBY ORDERED THAT:

1. Foley has agreed, on an interim basis only, to reduce the fees sought in the Second Interim Application by \$9,000.00, reserving its rights to seek such amount in its final fee application which reduces the full amount of fees set forth in the Second Interim Application from \$87,931.00 to \$78, 931.00;

2. Foley is granted interim allowance of such fees in the amount of **\$63,144.80** (80% of \$78,931.00) for the Second Interim Period;

3. Foley is granted interim allowance of reimbursement for 100% of its expenses incurred in the amount of **\$833.49** for the Second Interim Period;

4. The Debtor is authorized to pay Foley the total of **\$63,978.29** as an interim payment for the Second Interim Period;

5. All parties reserve their rights to object to the final allowance of any fees and expenses in conjunction with the final fee application filed by Foley in this case; and

6. This Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation, interpretation, and enforcement of this Order.
