Proc. 21-3005, Docket No. 86] (the "<u>NexPoint Motion</u>") filed by NexPoint Advisors, L.P. ("<u>NexPoint</u>"); (b) *Defendant Highland Capital Management Services, Inc.'s Motion to Extend Expert Disclosure and Discovery Deadlines* [Adv. Proc. 21-3006, Docket No. 91] (the "<u>HCMS Motion</u>") filed by Highland Capital Management Services, Inc. ("<u>HCMS</u>"); and (c) *Defendant HCRE Partners, LLC's Motion to Extend Expert Disclosure and Discovery Deadlines* [Adv. Proc. 21-3007, Docket No. 86] (the "<u>HCRE</u> <u>Motion</u>," and collectively with the NexPoint Motion and the HCMS Motion, the "<u>Motions</u>") filed by HCRE Partners, LLC ("<u>HCRE</u>," and collectively with NexPoint and HCMS, "<u>Defendants</u>"); and this Court having considered (i) the Motions; (ii) *Highland's Objection to Motion of Defendant NexPoint Advisors, L.P. to Extend Expert Disclosure and Discovery Deadlines* [Adv. Proc. 21-3005, Docket No. 104; Adv. Proc. 21-3006, Docket No. 109; Adv. Proc. 21-3007, Docket No. 104] (the "Objection") filed by Highland Capital Management, L.P. ("Highland"); (iii) the (a) Reply of Defendant NexPoint Advisors, L.P. in Support of Motion to Extend Expert Disclosure and Discovery Deadlines [Adv. Proc. 21-3005, Docket No. 115] (the "<u>NexPoint Reply</u>") filed by NexPoint; and (b) Highland Capital Management Services, Inc. and HCRE partners, LLC's Reply in Support of Defendants' Motion to Extend Expert Disclosure and Discovery Deadlines [Adv.
