Appellants The Charitable DAF Fund, L.P., CLO Holdco, Ltd., Mark Patrick, Sbaiti & Company, PLLC, Mazin A. Sbaiti, and Jonathan Bridges (collectively, "Appellants"), respectfully request that the Court extend their deadline to file their reply brief, which is currently due by February 28, 2022. For the reasons set forth below, Appellants request that the Court extend this deadline by 21 days, to March 21, 2022. The Parties have conferred, and Appellee does not oppose the relief requested in this Motion.

There is good cause to grant this Motion. In this matter, Appellants challenge an August 4, 2021 bankruptcy court order. Appellants filed their opening brief on December 13, 2021. *See* ECF No. 19. Counsel for Appellants are currently reviewing Appellee's brief and working on Appellants' reply brief. However, undersigned counsel for Appellants must balance the deadlines in this case with several other competing deadlines, including substantial discovery deadlines, oral argument preparation, and several dispositive motions in other matters due in the upcoming weeks.

To allow counsel to devote sufficient time to those matters, while also ensuring that there is sufficient time to prepare the reply in this matter, Appellants respectfully request that the Court enter the accompanying Proposed Order, which provides that Appellants' reply brief shall be filed by March 21, 2022. Additionally, the proposed order provides that co-Appellant Dondero's reply brief would also be due by March 21, 2022, thereby allowing all parties to file their reply briefs at the same time. Granting the requested relief will not prejudice any Party to this action and will not unreasonably delay these proceedings as there are no other pending deadlines that would be delayed by granting this Motion.
