**ORDER EXTENDING THE DEBTOR’S EXCLUSIVITY PERIOD
TO FILE A CHAPTER 11 PLAN, SOLICITING VOTES THEREON,
AND EXTENDING RELATED DEADLINES**

Upon the motion (the “Motion”)¹ of the above-captioned debtor and debtor in possession (the “Debtor”) for an Order Extending the Debtor’s Exclusivity Period to File a Chapter 11 Plan, Soliciting Votes Thereon, and Extending Related Deadlines; it appearing that the relief requested is in the best interest of the Debtor’s estate; it appearing that the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334; it appearing that this proceeding is a core proceeding pursuant to 28 U.S.C. § 157(b)(2); it appearing that venue of this proceeding and this Motion in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409; it appears that notice of this Motion and the opportunity for a hearing on this Motion was appropriate under the particular circumstances and that no other or

further notice need by given; and after due deliberation and sufficient cause appearing therefor, it is hereby ORDERED

1. The Motion is granted as set forth herein.
2. The Plan Proposal Period is extended by 186 days from February 25, 2021 to August 31, 2021.
3. The Solicitation Period is extended by 186 days from April 12, 2021 to October 15, 2021.
4. This relief is without prejudice to the Debtor's right to seek a further extension of the Exclusivity Periods.
5. The Case Management Deadlines are extended by an additional 186 days. The Court will issue an amended Case Management Order for consistency with this Order.
6. The Debtors are authorized to take all actions necessary to effectuate the relief granted pursuant to this Order in accordance with the Motion.
7. The terms and conditions of this Order shall be immediately effective and enforceable upon its entry.
8. The Court retains jurisdiction with respect to all matters arising from or related to the implementation of this Order.
