OBJECTION OF RS ENERGY GROUP, INC. TO PROPOSED CURE AMOUNT

COMES NOW, RS Energy Group, Inc. ("RS Energy"), a creditor and party-in-interest herein, and by and through its undersigned counsel, files its Objection of RS Energy Group, Inc. to Proposed Cure Amounts ("Objection"). In support of this Objection, RS Energy respectfully states as follows:

RELEVANT FACTS AND RESERVATION OF RIGHTS

- 1. July 12, 2020 ("Petition Date"), the Debtors filed voluntary petitions under Chapter 11 of Title 11 of the United States Code. The Debtors' cases are being jointly administered.
- 2. The Debtors and RS Energy are parties to a certain Information Services Subscription Agreement, dated 03/26/2019 ("Agreement"), whereby RS Energy provides access to certain software and information services to support the Debtors' operations.
- 3. On September 4, 2020, the Debtors filed a Notice of Cure Amounts in Connection with Contracts and Leases ("Cure Notice") [ECF 344]. The Agreement is listed in the Cure Notice, showing a "Cure Amount" of \$0.00.
- 4. On March 25, 2020, RS Energy invoiced the Debtors in the amount of \$18,750.00 for obligations under the Agreement. A true and correct copy of the March 25, 2020 invoice is attached hereto as **Exhibit A**. The due date of the March 25, 2020 invoice was April 24, 2020.
 - 5. Section 365(a)(1)(A) of the Bankruptcy Code permits a debtor to assume an

executory contract, if the debtor "cures" defaults at the time of assumption. As part of the Debtors' proposed assumption of the Agreement, the March 25, 2020 invoice must be paid in full.

WHEREFORE, PREMISES CONSIDERED RS Energy respectfully requests that the Court enter an order conditioning the Debtors' assumption of the Agreement upon the payment by the Debtors of all amounts due and owing thereunder, including the March 25, 2020 invoice, and grant RS Energy such other and further relief as this Court may deem just and proper.
