Pursuant to the *Order Approving Claim Objection and Settlement Procedures* (the “***Claims Procedures Order***”) [Docket No. 1354] entered by the Court on February 1, 2024, the undersigned counsel for the above-captioned debtors and debtors in possession (collectively, the “***Debtors***”) certifies as follows:

2. On March 13, 2024, the Debtors filed the *Sixth Omnibus Notice of Satisfaction of Claims* [Docket No. 1540] (the “***Sixth Omnibus Notice***”). The Sixth Omnibus Notice provided for a 30-day response period for relevant parties who did not believe their claim(s) have been satisfied.

3. On March 22, 2024, the Debtors’ Claims and Noticing Agent, Kurtzman Carson Consultants (“***KCC***”), filed a Certificate of Service on the Sixth Omnibus Notice [Docket No. 1569]. Pursuant to paragraph 6 of the Claims Procedures Order, KCC served the Sixth Omnibus Notice via electronic mail and first-class mail to parties on the Debtors’ Master Service List on March 13, 2024. Governmental entities on the Debtors’ Master Service List were serviced via first-class mail on March 14, 2023. Responses to the Sixth Omnibus Notice were required to be filed on or prior to April 12, 2024 (the “***Response Deadline***”).
