MOTION OF DEBTORS FOR ENTRY OF ORDERS: (A)(I) APPROVING BID PROCEDURES RELATING TO THE SALE OF SUBSTANTIALLY ALL OF THE DEBTORS' ASSETS, (II) APPROVING STALKING HORSE BID PROTECTIONS, (III) SCHEDULING A HEARING TO CONSIDER THE SALE, (IV) APPROVING THE FORM AND MANNER OF NOTICE OF SALE BY AUCTION, (V) ESTABLISHING NOTICE AND PROCEDURES FOR THE ASSUMPTION AND ASSIGNMENT OF CONTRACTS AND LEASES, AND (VI) GRANTING RELATED RELIEF; AND (B)(I) APPROVING ASSET PURCHASE AGREEMENT AND AUTHORIZING THE SALE OF CERTAIN ASSETS OF THE DEBTORS OUTSIDE THE ORDINARY COURSE OF BUSINESS, (II) AUTHORIZING THE SALE OF ASSETS FREE AND CLEAR OF ALL LIENS, CLAIMS, ENCUMBRANCES AND INTERESTS, (III) AUTHORIZING THE ASSUMPTION AND ASSIGNMENT OF CERTAIN EXECUTORY CONTRACTS AND UNEXPIRED LEASES, AND (IV) GRANTING RELATED RELIEF

The above-captioned debtors and debtors-in-possession (together, the "<u>Debtors</u>"), by and through their proposed undersigned counsel, hereby file this motion (the "<u>Motion</u>") pursuant to sections 105(a), 363, 365, 503 and 507 of title 11 of the United States Code (as amended or modified, the "<u>Bankruptcy Code</u>"); rules 2002, 6003, 6004, 6006, 9007 and 9008 of the Federal Rules of Bankruptcy Procedure (the "<u>Bankruptcy Rules</u>"); and rule 6004-1 of the Local Rules of Bankruptcy Practice and Procedure of the United States Bankruptcy Court for the District of Delaware (the "<u>Local Rules</u>"), for entry of two orders: (a) the first order, substantially in the form attached hereto as **Exhibit A** (the "Bid Procedures Order") (i) approving the procedures (the

"Bid Procedures")² in connection with the solicitation and acceptance of bids with respect to the proposed sale (the "Sale") of substantially all of the Debtors' remaining assets (in other words, all assets of the Debtors relating to the Debtors' NSS Implant (as defined herein) development program) (the "Assets" and each Sale of Assets, a "Sale Transaction"); (ii) approving Stalking Horse Bid Protections (as defined below); (iii) scheduling a hearing for approval of the Sale (the "Sale Hearing") and setting objection deadlines with respect to the Sale; (iv) approving the form and manner of notice (the "Sale Notice")³ of the Sale and related auction (the "Auction") for the Assets; (v) establishing procedures to determine cure amounts and deadlines for objections to the potential assumption and assignment of executory contracts and unexpired leases; and (vi) granting related relief; and (b) the second order, substantially in the form attached hereto as Exhibit B (the "Sale Order")⁴ (i) authorizing the Sale free and clear of Encumbrances⁵ with such Encumbrances to attach to the Sale Proceeds (if any); (ii) authorizing the assumption and assignment of certain executory contracts and unexpired leases; and (iii) granting related relief. In support of the Motion, the Debtors respectfully state as follows:

JURISDICTION AND VENUE

1. The U.S. Bankruptcy Court for the District of Delaware (the "Court") has jurisdiction over this Motion pursuant to 28 U.S.C. §§ 157 and 1334 and the *Amended Standing Order of Reference* from the United States District Court for the District of Delaware dated February 29, 2012. This matter is a core proceeding within the meaning of 28 U.S.C. § 157(b)(2)

and the Court may enter a final order consistent with Article III of the United States Constitution.⁶ Venue is proper in this district pursuant to 28 U.S.C. §§ 1408 and 1409.

2. The predicates for the relief sought herein are Bankruptcy Code sections 105(a), 363, 365, 503, and 507, Bankruptcy Rules 2002, 6003, 6004, 6006, 9007, and 9008, and Local Rule 6004-1.

BACKGROUND

A. General

- 3. On the date hereof (the "<u>Petition Date</u>"), the Debtors commenced the above-captioned chapter 11 cases (the "Chapter 11 Cases") by filing a voluntary petition for relief under chapter 11 of the Bankruptcy Code with the Court.
- 4. The Debtors continue to operate their businesses and manage their properties as debtors-in-possession pursuant to Bankruptcy Code sections 1107(a) and 1108. As of the date of this Motion, no trustee, examiner or statutory committee (a "Committee") has been appointed in these Chapter 11 Cases.
- 5. Additional information regarding the circumstances leading to the commencement of these Chapter 11 Cases and information regarding the Debtors' business and capital structure is set forth in the *Declaration of Richard Christopher in Support of the Debtors' Chapter 11 Petition and First Day Pleadings* (the "First Day Declaration") filed contemporaneously with this Motion and incorporated herein by reference.

i. Business Operations

- 6. The Debtors are, collectively, a research and clinical-stage biomaterials and biotechnology company with a focus on treatment of spinal cord injuries ("SCI"), with the goal of developing treatment options intended to provide meaningful improvement in patient outcomes following SCI. As described in the First Day Declaration, the Debtors' only remaining potentially monetizable assets relate to their investigational Neuro-Spinal Scaffold implant (the "NSS Implant"), which, until recently, had been the subject of active clinical trials that produced promising results.
- 7. Prior to the Petition Date, InVivo pursued development of its investigational Neuro-Spinal Scaffold implant (the "NSS Implant"), a bioresorbable polymer scaffold that is designed for implantation at the site of injury within a spinal cord and is intended to treat acute SCI. The NSS Implant is intended to promote side-by-side healing by supporting the surrounding tissue after injury, minimizing expansion of areas of necrosis, and providing a biomaterial substrate for the body's own healing and repair processes.
- 8. The NSS Implant incorporates intellectual property licensed under an exclusive, worldwide license from Boston Children's Hospital ("BCH") and the Massachusetts Institute of Technology ("MIT"), the term of which expires in 2027 or the life of the last patent expiration, whichever is later, unless terminated earlier by BCH (the "BCH License"). In connection with InVivo's acquisition of the BCH License, InVivo agreed to a development plan that includes certain targets and projections related to the timing of product development and regulatory approvals, as well as InVivo's payment of certain milestone payments, royalties and other fees.
- 9. Despite significant investment and promising results in initial clinical trials, InVivo is unable to continue clinical development of the NSS Implant due to setbacks in subsequent clinical trials and financial constraints. In particular, in March of 2023, InVivo announced that

data from its most recent and only active clinical trial had failed to meet the pre-defined success criteria and primary endpoint for the study. Having no other program assets besides the NSS Implant that could support continued operations or attract new financing opportunities prior to the Petition Date, InVivo terminated the development of the NSS Implant and pivoted to a wind-down and asset monetization strategy in order to maximize the value of its enterprise for its constituents. Development of the NSS Implant could be reinitiated by a buyer, moving forward the positive developmental momentum generated by the Debtors to date.

B. Events Leading to the Chapter 11 Cases

i. NSS Implant Setbacks and Decision to Suspend Development

10. In 2014, the Debtors initiated a first clinical study of the NSS Implant in patients with acute spinal cord injury ("INSPIRE 1.0 Study"), which was designed to enroll 20 patients. Despite encouraging data from the first 19 patients enrolled into the INSPIRE 1.0 Study, the study was halted in mid-2017 due to three patient deaths, which were deemed unrelated to the NSS Implant by the Principal Investigators of the applicable clinical sites. The Debtors subsequently worked with the FDA to initiate a second study ("INSPIRE 2.0 Study"), which included risk mitigation criteria for the challenges it faced in the INSPIRE 1.0 Study. In 2023, the Debtors announced that the data from the INSPIRE 2.0 Study had failed to meet the pre-defined success criteria and primary endpoint for the study. In March 2023, InVivo ultimately determined it was in the best interests of the company and its stakeholders to halt further development of the NSS Implant in light of the INSPIRE 2.0 Study's unfavorable results and the anticipated time and resources it would take to conduct another clinical trial.

ii. Sale & Marketing Process

11. Beginning in March of 2023, InVivo began exploring strategic alternatives to maximize value for all stakeholders, including marketing efforts for the NSS Implant and the [1394.001-W0074285.]

exploration of a sale of InVivo's whole business. For the NSS Implant, InVivo conducted a broad outreach effort to existing therapeutic companies, universities and advocacy organizations that it was aware of or had relationships within the spinal cord injury space. Such inquiries were directed to companies or groups who InVivo believed may be interested in potentially purchasing the NSS Implant as a stand-alone development opportunity or in combination with other therapeutics that such companies have in development. InVivo had similar outreaches and dialogues with firms who were also specialized in ex-U.S. partnering efforts for its NSS Implant that had previously expressed interest in working with InVivo. InVivo also attended various partnering conferences to meet with companies of these profiles. Despite various conversations and meetings with representatives from the entities who responded, no entity has expressed interest in acquiring the NSS Implant for continued development or research.

- 12. Also starting in March 2023, InVivo conducted outreach efforts to several investment banks regarding the potential sale of its business or other strategic opportunities for InVivo, including reverse mergers. All of the banks noted the significant challenges that InVivo could potentially face in the pursuit of a reverse merger or other strategic transaction and the small likelihood of success given a variety of external factors, including the impact of the recent economic downturn in the U.S. and global financial markets. As a result, the banks were unwilling to formally engage with InVivo to search for a strategic partner. Despite the Debtors' diligent search and marketing efforts to date, no credible or realistic opportunities have materialized as a potential alternative to InVivo seeking relief under chapter 11 of the Bankruptcy Code.
- 13. In order to maximize the outreach to potential purchasers of its assets, on July 12, 2023, InVivo retained SSG Advisors, LLC ("SSG") to continue the marketing process previously commenced by InVivo. SSG undertook a robust process of searching for asset purchasers in the

summer and fall of 2023, contacting a total of 205 target potential purchasers and executing one non-disclosure agreement with an interested party. Unfortunately, no potential purchasers submitted bids to purchase InVivo's assets at that time.

- 14. Notwithstanding the challenges faced by the company to date, InVivo remains hopeful that the terms of the Sale, specifically the "free and clear" protections provided by a bankruptcy sale process, will attract buyers who indicated some prior interest but did not submit bids prior to the Petition Date. SSG remains retained by the Debtors to continue its efforts to find a purchaser for InVivo's assets, with the understanding that in some cases previously interested purchasers will submit bids for assets only after a seller's chapter 11 proceedings have commenced.
- 15. Subject to approval of and pursuant to the Bid Procedures, SSG will continue its efforts in marketing the NSS Implant assets with the assistance, knowledge, and experience of the Debtors' continuing management. The Debtors believe, in the exercise of their business judgment, that the proposed Sale and auction structure will foster an open and competitive process and provide the best option to maximize value for all of their stakeholders. Indeed, given that the Debtors have no product candidates presently undergoing clinical trials and therefore no realistic opportunity to obtain additional financing from the public or private markets, the only alternative to the Sale would be conversion to Chapter 7 and liquidation. In the Debtors' view, a Chapter 7 liquidation would be exceedingly value destructive and wasteful, as the Debtors would immediately lose substantial value as they attempt to monetize their unique assets and distribute value to stakeholders. Specifically, in a Chapter 7 liquidation, the Debtors would likely lose the support of their remaining employees—the only people with the requisite knowledge to market and sell the NSS Implant program—in the sale process, and, as a result, any material potential sale

proceeds would be substantially diminished or would disappear. Thus, and in sum, the only potential value to be derived from the NSS Implant program is through a sale of that program to a party that could, with the assistance of the Debtors' remaining management and advisors, reinitiate the program and conduct further program studies on more cost-efficient and well-funded platforms.

C. Proposed Bid Procedures

- 16. While the pre-bankruptcy efforts of the Debtors and SSG to date have not yet identified any preferred buyer for the NSS Implant program, the Debtors believe, based on the attributes of the NSS Implant program assets and the nature of the market for those assets, that buyers may come forward through a bankruptcy auction process as described here. The Debtors seek to conduct an open and transparent sale process pursuant to which the Successful Bidder (defined below) will enter into an asset purchase agreement for the purchase of a portion of or substantially all of the Debtors' assets (which is essentially equivalent at this stage to the assets related to the NSS Implant program) free and clear of all Encumbrances, with such Encumbrances attaching to the proceeds of the Sale.
- 17. The Bid Procedures, as summarized below, were developed consistent with the Debtors' need to proceed with an expeditious sale process to minimize administrative costs, maximize the value of the Debtors' assets, and promote active bidding that will result in the highest or otherwise best offer for such assets. Moreover, the Bid Procedures reflect the Debtors' objective of conducting the Auction in a controlled, fair and open fashion that promotes interest in the Debtors' assets by financially-capable, motivated bidders who are likely to close the Sale on the timetable necessitated in these Chapter 11 Cases.

- 18. The following paragraphs in this section summarize key provisions of the bid procedures, and are qualified in their entirety by reference to the actual Bid Procedures:
 - a. Access to Due Diligence Materials. The Debtors have posted copies of all material documents related to the Debtors' assets to the Debtors' confidential electronic data room (the "Data Room"). To access the Data Room, a party must submit to the Debtors' advisors:
 - i. an executed confidentiality agreement in form and substance reasonably satisfactory to the Debtors (unless such party is already a party to an existing confidentiality agreement with the Debtors that is acceptable to the Debtors for this due diligence process, in which case such agreement shall govern); and
 - ii. sufficient information, as reasonably requested by the Debtors, to allow the Debtors to determine that the interested party (i) has the financial wherewithal to consummate a Sale Transaction, and (ii) intends to access the Data Room for a purpose consistent with these Bid Procedures.
 - b. Qualified Bidder. A bid is a signed document from a Potential Bidder received by the Bid Deadline that identifies the purchaser by its legal name and any other party that will be participating in connection with the bid, and includes the material terms of the offer to purchase a portion of or substantially all of the Debtors' assets (a "Bid"). To constitute a "Qualified Bid" a Bid must include, at a minimum, the following:
 - i. <u>Acquired Assets</u>. Each Bid must clearly identify, in writing and as applicable, the particular assets the Potential Bidder seeks to acquire from the Debtors, including any contracts and leases of the Debtors that would be assumed and assigned in connection with a proposed Sale Transaction.⁸ For the avoidance of doubt, a Qualified Bid may include a Bid for less than all or substantially all of the Debtors' assets.
 - ii. <u>Purchase Price; Form of Consideration; Cash Requirements; Assumed Liabilities</u>. Each Bid must clearly set forth, as applicable:
 - (A) <u>Purchase Price</u>. Each Bid must clearly identify the purchase price to be paid (the "<u>Purchase Price</u>"), and whether the Bid

- is based on an all-cash offer or consists of certain non-cash components, including, without limitation, and/or the assumption of liabilities;
- (B) <u>Cash Requirements</u>. Each Bid must provide sufficient cash consideration for the payment of any applicable Termination Payment in cash in full; and
- (C) <u>Assumed Liabilities</u>. Each Bid must clearly identify, in writing and as applicable, the particular liabilities, if any, including executory contracts, the Bidder seeks to assume. For the avoidance of doubt, a Qualified Bid may include a bid for less than all or substantially all of the Debtors' liabilities.
- iii. <u>Proposed APA</u>. Each Bid must include an executed asset purchase agreement (the "<u>Proposed APA</u>") for the assets included in such Bid, together with a redline comparing the Proposed APA to the form APA attached to the Bid Procedures as Exhibit A.
- iv. <u>Unconditional Offer</u>. A statement that the Bid is formal, binding, and unconditional, is not subject to any further due diligence or financing contingency, and is irrevocable until the Debtors notify the Potential Bidder that such Bid is not a Successful Bid or a Back-Up Bid, or until the first business day after the close of a Sale Transaction.
- Proof of Financial Ability to Perform. Each Bid must contain such v. financial and other information that allows the Debtors to make a reasonable determination as to the Potential Bidder's financial and other capabilities to consummate a Sale Transaction including, without limitation, such financial and other information setting forth adequate assurance of future performance in satisfaction of the requirements under section 365(f)(2)(B) of the Bankruptcy Code, and the Potential Bidder's willingness to perform under any contracts that are assumed and assigned to such party. Without limiting the foregoing, such information must include current financial statements or similar financial information certified to be true and correct as of the date thereof, proof of financing commitments if needed to consummate the transaction (not subject to, in the Debtors' discretion, any unreasonable conditions), contact information for verification of such information, including any financing sources, and any other information reasonably requested by the Debtors necessary to demonstrate that such Potential Bidder has the ability to consummate a Sale Transaction in a timely manner.
- vi. <u>Designation of Contracts and Leases</u>. Each Bid must identify, with particularity, each and every executory contract and unexpired lease, the

assumption and assignment of which is a condition to closing a Sale Transaction; provided, however, that the Bid may allow for the Potential Bidder to remove executory contracts and unexpired leases from the list of contracts to be assumed and assigned any time prior to the closing of a Sale Transaction; provided, further, however, that to the extent the Debtors identify any additional executory contracts or unexpired leases after the Bid is submitted, the Bid may allow for the Potential Bidder to add such executory contracts and unexpired leases to the list of contracts to be assumed and assigned any time from and after the Bid is submitted.

- vii. Required Approvals. A statement or evidence (1) of the Potential Bidder's plan and ability to obtain all requisite governmental, regulatory, or other third-party approvals; and (2) that the Bid is reasonably likely to be consummated, if selected as the Successful Bid, within a time frame required by the Bid Procedures Order and otherwise acceptable to the Debtors.
- viii. <u>Authorization</u>. Each Bid must include evidence of corporate authorization and approval from the Potential Bidder's board of directors (or comparable governing body) with respect to the submission, execution, and delivery of a Bid, participation in the Auction, and closing of the transactions contemplated by the Potential Bidder's Proposed APA in accordance with the terms of the Bid and these Bid Procedures.
 - ix. No Entitlement to Expense Reimbursement or Other Amounts. With the exception of any Stalking Horse Bid, expressly state that the Bid does not entitle the Potential Bidder to any break-up fee, termination fee, expense reimbursement or similar type of payment or reimbursement, and a waiver of any substantial contribution administrative expense claims under section 503(b) of the Bankruptcy Code related to the bidding process.
 - x. <u>Joint Bids</u>. The Debtors may approve joint Bids in their reasonable discretion on a case-by-case basis.
 - xi. <u>Representations and Warranties</u>. Each Bid must include the following representations and warranties:
 - (A) a statement that the Potential Bidder has had an opportunity to conduct any and all due diligence regarding the applicable assets prior to submitting its Bid;
 - (B) a statement that the Potential Bidder has relied solely upon its own independent review, investigation, and/or inspection

of any relevant documents and the assets in making its Bid and did not rely on any written or oral statements, representations, promises, warranties, or guaranties whatsoever, whether express or implied, by operation of law or otherwise, regarding the assets or the completeness of any information provided in connection therewith, except as expressly stated in the representations and warranties contained in the Potential Bidder's Proposed APA ultimately accepted and executed by the Debtors;

- (C) a statement that the Potential Bidder agrees to serve as Back-Up Bidder, if its Bid is selected as the next or highest or next best bid after the Successful Bid with respect to the applicable assets;
- (D) a statement that the Potential Bidder has not engaged in any collusion with respect to the submission of its Bid; and
- (E) a statement that the Potential Bidder agrees to be bound by the terms of the Bid Procedures.
- xii. A Potential Bidder must also accompany its Bid with:
 - (A) a cash deposit in the amount of ten percent (10%) of the Purchase Price (a "Good Faith Deposit");
 - (B) the contact information of the specific person(s) whom the Debtors or their advisors should contact in the event that the Debtors have any questions or wishes to discuss the Bid submitted by the Potential Bidder;
 - (C) a covenant to cooperate with the Debtors to provide pertinent factual information regarding the Potential Bidder's operations reasonably required to analyze issues arising with respect to any applicable regulatory requirements; and
 - (D) if the value of a Bid includes additional non-cash components, a detailed analysis of the value of any additional non-cash component of the Bid and back-up documentation to support such value.
- c. <u>Good Faith Deposit</u>. A Good Faith Deposit must be deposited, prior to the Bid Deadline, with an escrow agent selected by the Debtors or with the Debtors' counsel, as agreed by the Debtors (the "<u>Escrow Agent</u>") pursuant to an escrow agreement or other documentation to be provided by the Debtors. To the extent a Qualified Bid is modified before, during, or after the Auction, the Debtors reserve the right to require that such Qualified Bidder adjust its Good Faith Deposit so that it equals ten percent (10%) of the Purchase Price. If a Qualified

- Bidder is required to adjust its Good Faith Deposit, its status as a Qualified Bidder shall be suspended pending satisfaction of such adjustment.
- d. <u>Bid Deadline</u>. The Bid Deadline for a Potential Bidder to submit a Bid shall be March 29, 2024 at 4:00 p.m. (EST). No Bid received after the Bid Deadline shall be considered a Qualified Bid.
 - i. The Debtors, in consultation with the Committee, if any, will evaluate Bids that are timely submitted and may engage in negotiations with Potential Bidders who submitted Bids as the Debtors deem appropriate in the exercise of their business judgment, based upon the Debtors' evaluation of the content of each Bid.
 - ii. A Bid received for assets that is determined by the Debtors (in consultation with the Committee, if any) to meet the requirements set forth herein will be considered a "Qualified Bid" and any bidder that submits a Qualified Bid (including any Stalking Horse Bid) will be considered a "Qualified Bidder."
 - iii. By no later than April 1, 2024 (the "Qualified Bid Deadline"), the Debtors shall determine, in their reasonable judgment (after consultation with the Committee, if any) which of the Bids received by the Bid Deadline qualifies as a Qualified Bid. The Debtors shall notify each Bidder who submits a Qualified Bid of its status as a Qualified Bidder by the Qualified Bid Deadline.
- e. Auction. If the Debtors receive two or more Qualified Bids for substantially the same assets, the Debtors may, in their business judgment, conduct the Auction in person or by remote audio and video link on April 3, 2024, beginning at 10:00 a.m. (ET) at the offices of Landis Rath & Cobb LLP, 919 N. Market Street, Wilmington, DE 19801. Only a Qualified Bidder will be eligible to participate at the Auction, subject to such limitations as the Debtors may impose in good faith. In addition, professionals and/or other representatives of the Debtors and the Committee (if any) shall be permitted to attend and observe the Auction along with any other party in interest so permitted by the Debtors or the Court upon request. Each Qualified Bidder shall be required to confirm, both before and after the Auction, that it has not engaged in any collusion with respect to the submission of any bid, the bidding, or the Auction.
 - i. The Debtors, in consultation with the Committee, if any, may adopt rules for the Auction at any time that the Debtors reasonably determine to be appropriate to promote a value-maximizing auction. Any rules developed by the Debtors will provide that all bids in the Auction will be made and received on an open basis, and all other bidders participating in the Auction will be entitled to be present for all bidding with the understanding that the true identity of each bidder placing a bid at the Auction will be fully disclosed to all other bidders participating

- in the Auction and that all material terms of a bid submitted in response to any successive bids made at the Auction will be disclosed to all other bidders. Each Qualified Bidder will be permitted what the Debtors reasonably determine to be an appropriate amount of time to respond to the previous bid at the Auction. The Auction will be conducted openly and shall be transcribed or recorded.
- ii. The Debtors may, in their discretion and in consultation with the Committee, if any, identify the highest or otherwise best Qualified Bid as the successful bid (a "Successful Bid" and the bidder submitting such bid, a "Successful Bidder"). The Debtors may also identify a Qualified Bidder that submitted the next highest or otherwise best Qualified Bid as a back-up bid (a "Back-Up Bid" and the bidder submitting such bid, a "Back-Up Bidder"). A Back-Up Bid shall remain open and irrevocable until the earliest to occur of (i) consummation of a Sale Transaction with the Successful Bidder and (ii) the release of such Back-Up Bid by the Debtors in writing (such date, the "Back-Up Bid Expiration Date"). If a Sale Transaction with a Successful Bidder is terminated prior to the Back-Up Bid Expiration Date, the Back-Up Bidder shall be deemed a Successful Bidder and shall be obligated to consummate the Back-Up Bid as if it were a Successful Bid, provided however, that the Debtors are not required to accept any Bid or designate a Successful Bidder or Back-Up Bidder.
- iii. Within one (1) business day after the Auction, a Successful Bidder shall submit to the Debtors fully executed documentation memorializing the terms of a Successful Bid. A Successful Bid may not be assigned to any party without the consent of the Debtors.
- iv. At any time before entry of an order approving an applicable Sale Transaction envisioned by a Qualified Bid the Debtors reserve the right to and may reject such Qualified Bid if such Qualified Bid, in the Debtors' judgment (after consultation with the any Committee), is: (i) inadequate or insufficient; (ii) not in conformity with the requirements of the Bankruptcy Code, these Bid Procedures, or the terms and conditions of the applicable Sale Transaction; or (iii) contrary to the best interests of the Debtors and their estates.
- f. <u>Post-Auction Process</u>. Within one (1) business day after the conclusion of the Auction, or as soon as reasonably practicable thereafter, the Debtors shall file with the Court a notice of a Successful Bid, Successful Bidder, Back-Up Bid, and Back-Up Bidder. Unless otherwise required pursuant to the Debtors' fiduciary duties, the Debtors shall not consider any bids submitted after the conclusion of the Auction.
 - i. Within seven (7) days after the Auction, the Debtors shall direct the Escrow Agent to return the deposit of any bidder, who is not declared a

Successful Bidder or Back-Up Bidder. Within five (5) days after the Back-Up Bid Expiration Date, the Debtors shall direct the Escrow Agent to return the deposit of a Back-Up Bidder. Upon the authorized return of any such deposit, the bid of such Potential Bidder, Qualified Bidder or Back-Up Bidder, as applicable, shall be deemed revoked and no longer enforceable.

- ii. A Successful Bidder's deposit shall be applied against the cash portion of the purchase price of such bidder's Successful Bid upon the consummation of a Sale Transaction. In addition to the foregoing, the deposit of a Qualified Bidder will be forfeited to the Debtors if (i) the Qualified Bidder attempts to modify, amend, or withdraw its Qualified Bid, except as permitted herein, during the time the Qualified Bid remains binding and irrevocable or (ii) the Qualified Bidder is selected as a Successful Bidder or Back-Up Bidder and refuses or fails to enter into the required definitive documentation or to consummate a Sale Transaction according to the Bid Procedures.
- g. Sale Hearing. If the Debtors elect to proceed with a Sale Transaction, the Debtors will seek the entry of an order authorizing and approving the Sale Transaction at a hearing before the Court on April 5, 2024 (or other such date as the Court may determine) (the "Sale Hearing"). The Debtors, in the exercise of their business judgment, may adjourn the Sale Hearing without notice or with limited and shortened notice to parties, including by (i) an announcement of such adjournment at the Sale Hearing or at the Auction or (ii) the filing of a notice of adjournment with the Court prior to the commencement of the Sale Hearing.
 - i. Objections to a Sale Transaction, including any objection to the sale of the Debtors' assets free and clear of liens, claims, encumbrances, and other interests pursuant to section 363(f) of the Bankruptcy Code (each, a "Sale Objection"), shall (i) be in writing; (ii) state the name and address of the objecting party and the amount and nature of the Claim or Interest of such party; (iii) state with particularity the basis and nature of any objection, and provide proposed language that, if accepted and incorporated by the Debtors, would obviate such objection; (iv) conform to the Bankruptcy Rules and the Local Rules; (v) be filed with the Court; and (vi) be served upon the Notice Parties (as defined in the in the Bid Procedures Order) by March 29, 2024 at 4:00 p.m. (ET) (the "Sale Objection Deadline"); provided that, the Debtors may extend the Sale Objection Deadline, as the Debtors deem appropriate in the exercise of their reasonable business judgment. If a timely Sale Objection cannot otherwise be resolved by the parties, such objection shall be heard by the Court at the Sale Hearing.
- h. <u>Consent to Jurisdiction</u>. All bidders that participate in the bidding process shall be deemed to have: (i) consented to the core jurisdiction of the Court to enter

any order or orders, which shall be binding in all respects, in any way related to these Bid Procedures, the bid process, the Auction, the Sale Hearing, or the construction and enforcement of any agreement or any other document relating to an applicable Sale Transaction; (ii) waived any right to a jury trial in connection with any disputes relating to these Bid Procedures, the bid process, the Auction, the Sale Hearing, or the construction and enforcement of any agreement or any other document relating to a Sale Transaction; and (iii) consented to the entry of a final order or judgment in any way related to these Bid Procedures, the bid process, the Auction, the Sale Hearing, or the construction and enforcement of any agreement or any other document relating to an applicable Sale Transaction if it is determined that the Court would lack Article III jurisdiction to enter such a final order or judgment absent the consent of the parties.

- 19. Pursuant to Local Rule 6004-1: (i) each bidder participating at the Auction will be required to make a non-collusion representation (a "Non-Collusion Representation"); (ii) the Auction will be conducted openly and may be attended by the Debtors' professionals, the Committee, if any, and its professionals and the Auction participants; (iii) the only persons or entities who will be permitted to bid at the Auction are the authorized representatives of each Qualified Bidder; and (iv) the Auction will be transcribed.
- 20. Other than as expressly set forth in the Bid Procedures, the Debtors reserve the right to: (a) impose additional terms and conditions with respect to any or all Potential Bidders; (b) extend the deadlines set forth herein or the date for the Auction; (c) cancel or extend the sale of the Assets and/or Sale Hearing in open court; and/or (d) amend the Bid Procedures, in each case, so long as the exercise of any such right is consistent with the Debtors' fiduciary duties and the best interests of the Debtors' estate.

D. <u>Designation of Stalking Horse Bidders</u>

21. As set forth in the Bid Procedures, the Debtors request authority to (a) designate one or more Stalking Horse Bidders for one or more of the Debtors' assets; (b) enter into Stalking Horse Agreements with the Stalking Horse Bidders; and (c) provide the Stalking Horse Bidders will Stalking Horse Bid Protections (as defined below), where the Debtors determine, in the

exercise of their reasonable business judgment, that setting a floor price for the Assets is in the best interest of the Debtors' estate.

- 22. Having flexibility to designate Stalking Horse Bidders for certain or substantially all of the Debtors' assets will enhance the Debtors' ability of maximize value of the Assets and, accordingly, is in the best interest of the Debtors' estate.
- 23. Specifically, the Debtors may: (a) establish initial overbid minimum and subsequent bidding increment requirements; (b) offer each Stalking Horse Bidder a break-up fee and/or expense reimbursement in an amount agreed to by the Debtors and consistent with market practices (a "Termination Payment"); (c) provide that, if the Stalking Horse Bidder bids on certain assets at the Auction, the Stalking Horse Bidder will be entitled to a credit in the amount of its Termination Payment against the increased purchase price for the assets; and (d) provide other appropriate and customary protections to a Stalking Horse Bidder (the Termination Payment and the other bid protection described in this paragraph collectively are referred to as the "Stalking Horse Bid Protections").
- 24. To the extent the Debtors designate a Stalking Horse Bidder with respect to any of the assets, the Debtors shall promptly upon execution of a Stalking Horse Agreement (and in no event more than one (1) calendar day following such execution) file with the Court and cause to be published on the website maintained by the Debtors' claims and noticing agent in this Chapter 11 Case, located at Debtors' claims agent's website at https://www.kccllc.net/invivo, a notice that contains information about the Stalking Horse Bidder, the Stalking Horse Bid, and attaches the proposed Stalking Horse Agreement (the "Notice of Stalking Horse Bidder").
- 25. Any objections (each, a "<u>Stalking Horse Objection</u>") to the designation of a Stalking Horse Bidder, including any Stalking Horse Bid Protections pursuant to the terms and

provisions of a Stalking Horse Agreement, must: (a) be in writing; (b) state the name and address of the objecting party and the amount and nature of the Claim or Interest of such party; (c) state with particularity the basis and nature of any objection; (d) conform to the Bankruptcy Rules and the Local Rules; and (e) be served upon the Sale Notice Parties (as defined herein) within five (5) calendar days after the filing of the relevant Notice of Stalking Horse Bidder. If a timely Stalking Horse Objection is filed and served in accordance with the preceding paragraph, the proposed Stalking Horse Bid Protections will not be deemed approved until either the Stalking Horse Objection is resolved by agreement of the objecting party and the Debtors or by order of the Court. If no timely Stalking Horse Objection is filed and served with respect to an applicable Stalking Horse Agreement in accordance with the Bid Procedures, the Stalking Horse Bid Protections shall be deemed approved without further order of the Court upon the expiration of the objection deadline.

- 26. Given the Debtors' need to maximize value for creditors through a timely and efficient marketing and sale process, the ability to designate Stalking Horse Bidders and offer such bidders Stalking Horse Bid Protections is justified, appropriate and essential.
- 27. For reference, the material terms of the Proposed APA required to be highlighted pursuant to Local Rule 6004-1 are as follows: 10

E. Notice of Auction and Sale

28. The Debtors seek to have the Auction scheduled to commence in person or by telephonic and/or video conference at 10:00 a.m. (ET) on April 3, 2024 at the offices of Landis Rath & Cobb LLP, 919 Market Street, Suite 1800, Wilmington, Delaware 19801. Within two (2) days of the entry of the Bid Procedures Order, the Debtors will serve by first class mail, postage prepaid, copies of: (a) the Bid Procedures Order; and (b) the Sale Notice upon the following entities: (i) the Office of the United States Trustee for the District of Delaware; (ii) counsel to the Committee, if any, or, if none formed, the creditors holding the twenty (20) largest unsecured claims as set forth on the list filed with the Debtors' petitions; (iii) all taxing authorities having jurisdiction over any of the Assets subject to the Sale, including the Internal Revenue Service; (iv) the Environmental Protection Agency; (v) the Securities Exchange Commission; (vi) the Food and Drug Administration; (vii) the state/local environmental agencies in the jurisdictions where the Debtors own or lease real property; (viii) all of the Debtors' known creditors; (ix) all parties that have requested notice pursuant to Bankruptcy Rule 2002 as of the date prior to the date of entry of the Bid Procedures Order; (x) all persons or entities known to the Debtors that have or have asserted a lien on, or security interest in, all or any portion of the Assets; and (xi) any Potential Bidders previously identified or otherwise known to the Debtors (collectively, the "Sale Notice Parties"). In addition, the Debtors will publish notice of the Sale in the national edition of either the Wall Street Journal National Edition or USA Today or similar publication.

29. The Debtors further request, pursuant to Bankruptcy Rule 9014, that objections, if any, to the proposed Sale: (a) be in writing; (b) comply with the Bankruptcy Rules and the Local Rules; (c) be filed with the Clerk of the Court, 824 Market Street, 3rd Floor, Wilmington, Delaware 19801; and (d) be served on: (i) counsel for the Debtors, Landis Rath & Cobb LLP, 919 Market Street, Suite 1800, Wilmington, Delaware 19801 (Attn: Matthew B. McGuire, Esq. (e-mail: mcguire@Irclaw.com) and Joshua B. Brooks, Esq. (e-mail: brooks@Irclaw.com)); and Wilmer Cutler Pickering Hale and Dorr LLP, 7 World Trade Center, 250 Greenwich Street, New York, New York, 10007 (Attn: George Shuster, Esq. (e-mail: george.shuster@wilmerhale.com) and Benjamin Loveland, Esq. (email: Benjamin.loveland@wilmerhale.com)); (ii) counsel to the Committee, if any; and (iii) the Office of the United States Trustee, 844 King Street, Suite 2207, Wilmington, Delaware 19801 (Attn: Joseph Cudia, Esq. (email: Joseph.Cudia@usdoj.gov)).

F. <u>Procedures Relating to Executory Contracts and Unexpired Leases, Including Determination of Cure Amounts and Deadlines for Objection to Assumption and Assignment of All Contracts</u>

- 30. Given the number of executory contracts and unexpired leases to which the Debtors are a party, the Debtors seek to establish (a) procedures for determining the Cure Amounts and (b) the deadline for objections to the Cure Amounts and/or the proposed assumption and assignment of executory contracts and unexpired leases (collectively, the "Contract Procedures"). The contracts that may be assumed and assigned by the Debtors will be listed on a schedule filed with the Court not less than fourteen (14) days prior to the Sale Objection Deadline (the "Contract Schedule").
- 31. Not less than fourteen (14) days prior to the Sale Objection Deadline, the Debtors shall serve by mail a notice, substantially in the form annexed as Exhibit 3 to the Bid Procedures Order (a "<u>Cure Notice</u>"), on the non-Debtor counterparties to all Contracts (collectively, the

"Contract Parties") that the Debtors may assume and assign as a part of any Sale Transaction. To the extent the Contracts Schedule is amended after the Sale Order, the Debtors shall promptly file and serve by mail a supplemental Cure Notice (the "Additional Cure Notice") on the affected non-Debtor counterparties, substantially in the form attached as Exhibit 4 to the Bid Procedures Order.

i. Contract Objections

- 32. To facilitate a prompt resolution of (a) disputes relating to the Cure Amounts and (b) any other objections relating to the assumption and assignment of the Contracts, the Debtors propose the following deadlines and procedures:
 - a. The Contract Parties shall have until 4:00 p.m. (ET) on the date that is fourteen (14) days following service of the Cure Notice (the "Contract Objection Deadline"), which deadline may be extended in the sole discretion of the Debtors, to object (a "Contract Objection") to (i) the Cure Amounts listed by the Debtors and to propose alternative Cure Amounts, and/or (ii) the proposed assumption and assignment of the Contracts in connection with the Sale, including, without limitation, the Debtors' ability to assign the Contracts without the Contract Parties' consent;
 - i. **provided, however,** that any objections related to the adequate assurance of future performance to be provided by the Successful Bidder (or any designee thereof) may be raised at the Sale Hearing or at a later-scheduled hearing as the Court deems appropriate;
 - ii. <u>provided, further, however,</u> if the Debtors amend the Cure Notice after the Contract Objection Deadline to add a contract or lease, the non-Debtor party to the added contract or lease shall have until the earlier of (a) fourteen (14) days after service of notice of adding a contract or lease; or (b) the Sale Hearing to submit a Contract Objection with respect to the contract or lease added by the Debtors' amendment (the "Amended Contract Objection Deadline");
 - iii. **provided, further, however,** that if the Debtors amend the Cure Notice after the Contract Objection Deadline to reduce the Cure Amount of a Contract, except where such reduction was upon mutual agreement of the parties, the non-Debtor party to the reduced Cure Amount contract or lease shall have until the Amended Contract Objection Deadline to object to the Cure Amount with respect to the contract or lease with the Cure Amount that has been reduced by the Debtors' amendment.

- b. The Debtors, the Contract Party, and the Successful Bidder may consensually resolve the Contract Objection prior to, or after, the Sale Hearing. In the event the Contract Objection is not resolved, such Contract Objection will be heard at the Sale Hearing or thereafter. To the extent it is determined that the Cure Amount exceeds the amount set forth in the Contract Schedule, or an objection to assumption or assumption and assignment is sustained with regard to an Assigned Contract the Successful Bidder may determine to not have such Assigned Contract assumed and assigned to it.
- c. Unless a Contract Objection is filed and served before the Contract Objection Deadline or the Amended Contract Objection Deadline, as applicable, all Contract Parties shall be:
 - i. forever barred from objecting to the proposed Cure Amounts and from asserting any additional cure or other amounts (other than as may be asserted in an Additional Cure Notice), and the Debtors and the Successful Bidder shall be entitled to rely solely upon the proposed Cure Amounts set forth in the Cure Notice or the Additional Cure Notice, as applicable;
 - ii. deemed to have consented to the assumption or assumption and assignment of the applicable Contracts;
 - iii. forever barred and estopped from asserting or claiming against the Debtors or the Successful Bidder that any additional amounts are due or other defaults exist (other than as may be asserted in an Additional Cure Notice), that conditions to assignment must be satisfied under such Contracts, including, without limitation, any consent rights, or that there is any objection or defense to the assumption and assignment of such Contracts, including without limitation, adequate assurance of future performance;
 - iv. precluded from objecting to the Cure Amounts (if any) and the assumption and assignment; and
 - v. barred and estopped from asserting or claiming that an Assigned Contract contains an enforceable consent right.

ii. Designation by Qualified Bidders

33. On or before the Bid Deadline, any Qualified Bidder shall, by delivering written notice to the Debtors, provide their initial designation of Contracts on the Contracts Schedule it wishes to become an Assigned Contract. The Successful Bidder may remove any Assigned Contract from such schedule prior to the Closing.

- 34. Immediately prior to the Sale Hearing, the Debtors shall file the list of Assigned Contracts as of such date.
 - 35. The Debtors request that the Sale Order, among other things:
 - a. authorize and approve the assumption and assignment of the Assigned Contracts to the Successful Bidder upon the Closing, without the need for any further action by any party, pursuant to Bankruptcy Code section 365;
 - b. provide that where the Debtors is unable to establish that a default exists under a Contract, the Cure Amount relating to such Assigned Contract shall be set at \$0.00; and
 - c. find that the Successful Bidder has established adequate assurance of future performance necessary to satisfy the requirements of Bankruptcy Code section 365 in respect of the assignment to the Successful Bidder of the Assigned Contracts.

RELIEF REQUESTED

- 36. By this Motion, the Debtors seek the entry of two orders of the Court: (a) the Bid Procedures Order: (i) approving the Bid Procedures relating to the sale of substantially all of the Debtors' assets; (ii) approving the Stalking Horse Bid Protections; (iii) scheduling the Sale Hearing and setting objection deadlines with respect to the sale; (iv) approving the form and manner of notice of the Sale and related Auction; (v) establishing procedures to determine Cure Amounts and deadlines for objections to the potential assumption and assignment of executory contracts and unexpired leases; and (vi) granting related relief; and (b) the Sale Order: (i) authorizing and approving the Sale; (ii) authorizing the Sale free and clear of Encumbrances pursuant to the Successful Bidder; (iii) authorizing the assumption and assignment of the Assigned Contract; and (iv) granting related relief.
- 37. The Debtors believe that the proposed Bid Procedures and Sale will maximize the value of the Debtors' assets for all stakeholders by fostering an environment for open and robust bidding on the Debtors' assets.

BASIS FOR RELIEF REQUESTED

A. The Bid Procedures Are Fair and Reasonable and Designed to Not Chill Bidding

- 38. Maximization of proceeds received by the estate is one of the dominant goals of any proposed sale of estate property. *See In re Mushroom Transp. Co.*, 382 F.3d 325, 339 (3d Cir. 2004) (debtor-in-possession "had a fiduciary duty to protect and maximize the estate's assets"). In the hope of maximizing the value received by bankruptcy estates, courts typically establish procedures that are intended to enhance competitive bidding by, among other things, setting forth the rules that will govern the auction process. *See, e.g., In re Fin. News Network, Inc.*, 126 B.R. 152, 156 (Bankr. S.D.N.Y. 1991) ("court-imposed rules for the disposition of assets . . . [should] provide an adequate basis for comparison of offers, and [should] provide for a fair and efficient resolution of bankrupt estates"); *In re Edwards*, 228 B.R. 552, 561 (Bankr. E.D. Pa. 1998) (bid procedures should allow for "an open and fair public sale designed to maximize value for the estate").
- 39. The Debtors believe that the Bid Procedures are designed to maximize the value received for the Assets and prevent any chilling of potential bids by establishing a competitive and fair bidding process. The process set forth in the Bid Procedures allows for a timely and efficient auction process given the circumstances facing the Debtors, while providing Potential Bidders with ample time and information to submit a timely bid and perform diligence. The Bid Procedures are designed to ensure that the Assets will be sold for the highest or otherwise best possible purchase price by subjecting the value of the Assets to market testing and permitting prospective buyers to bid on the Assets. Accordingly, the Debtors and all parties in interest can be assured that the consideration received for the Assets will be fair and reasonable and that the proposed Bid Procedures will not chill bidding by any Potential Bidders. Moreover, the proposed Bid

Procedures are fair and appropriate in light of the extensive prepetition marketing process undertaken by the Debtors and their professionals.

40. Procedures to dispose of assets similar to the proposed Bid Procedures have been approved in many other chapter 11 cases in this District. See, e.g., In re EdgeMarc Energy Holdings, LLC, Case No. 19-11104 (BLS) (Bankr. D. Del. June 21, 2019); In re Things Remembered, Inc., Case No. 19-10234 (KG) (Bankr. D. Del. Feb. 21, 2019); In re Argos Therapeutics, Inc., Case No. 18-12714 (KJC) (Bankr. D. Del. Dec. 20, 2018); In re Bertucci's Holdings, Inc., Case No. 18-10894 (MFW) (Bankr. D. Del. May 7, 2018); In re Seastar Holdings, Inc., Case No. 18-10039 (CSS) (Bankr. D. Del. Jan. 29, 2018); In re Peekay Acquisition, LLC, Case No. 17-11722 (BLS) (Bankr. D. Del. Sep. 7, 2017); In re Jumio, Inc., Case No. 16-10682 (BLS) (Bankr. D. Del. Apr. 21, 2016); In re City Sports, Inc., Case No. 15-12054 (KG) (Bankr. D. Del. Oct. 23, 2015); In re Saladworks, Case No. 15-10327 (LSS) (Bankr. D. Del. Mar. 11, 2015); In re iGPS Co. LLC, Case No. 13-11459 (KG) (Bankr. D. Del. July 31, 2013); Tri-Valley Corp., Case No. 12-12291 (MFW) (Bankr. D. Del. Sep. 5, 2012); WP Steel Venture LLC, Case No. 1211661 (KJC) (Bankr. D. Del. June 21, 2012). The Debtors thus believe that the proposed Bid Procedures provide an appropriate framework for establishing that the Debtors will receive the best and highest offer for the Assets. Accordingly, the proposed Bid Procedures are reasonable, appropriate and within the Debtors' sound business judgment under the circumstances.

B. The Stalking Horse Bid Protections Are Reasonable and Appropriate

41. Bid incentives such as the Stalking Horse Bid Protections encourage a potential buyer to invest the time, money and effort required to negotiate with a debtor, and perform the necessary due diligence attendant to the acquisition of a debtor, despite the inherent risks and uncertainties of the chapter 11 process. The Debtors submit that approval of the Stalking Horse

Bid Protections, subject to the procedures for such approval as are described herein, is justified by the facts and circumstances of this case, whether considered under the business judgment rule or as an administrative expense of the estate. Similar procedures for the selection of stalking horse bidders have been approved in this District in many other chapter 11 cases. See, e.g., In re Allena Pharmaceuticals, Inc., Case No. 22-10842 (KBO) (Bankr. D. Del. Sep. 28, 2022) (approving bid procedures and authorizing debtors to select a stalking horse bidder and grant stalking horse bid protections upon notice to certain parties-in-interest); In re Armstrong Flooring, Inc., Case No. 22-10426 (MFW) (Bankr. D. Del. May 31, 2022) (same); In re BC Hospitality Group Inc., Case No. 20-13103 (BLS) (Bankr. D. Del. Jan. 7, 2021) (approving bid procedures and authorizing debtors to select a stalking horse bidder and grant stalking horse bid protections upon notice to certain parties-in-interest and submission of an order, under certification of counsel, approving such decisions); In re Templar Energy LLC, Case No. 20-11441 (BLS) (Bankr. D. Del. June 23, 2020) (same); In re Carbonlite Holdings LLC, Case No. 21-10527 (JTD) (Bankr. D. Del. Apr. 9, 2021) (same); In re Klausner Lumber One, LLC, Case No. 20-11033 (KBO) (Bankr. D. Del. June 8, 2020) (same); In re Southland Royalty Company LLC, Case No. 20-10158 (KBO) (Bankr. D. Del. Apr. 29, 2020) (same).

42. Approval of the Stalking Horse Bid Protections is governed by standards for determining the appropriateness of bidding incentives in the bankruptcy context established by the Third Circuit in *Calpine Corp. v. O'Brien Envtl. Energy, Inc. (In re O'Brien Envtl. Energy, Inc.)*, 181 F.3d 527 (3d Cir. 1999). In *O'Brien*, the Third Circuit concluded that "the determination whether break-up fees or expenses are allowable under section 503(b) must be made in reference to general administrative expense jurisprudence. In other words, the allowability of [these fees] depend upon the requesting party's ability to show that the fees were actually necessary to preserve

the value of the estate." *O'Brien*, 181 F.3d at 535. Here, the Break-Up Fee and Expense Reimbursement should be approved because they will provide a benefit to the Debtors' estates. The Third Circuit identified at least two instances in which bidding incentives may benefit the estate. First, a break-up fee may be necessary to preserve the value of the estate if assurance of the fee "promote[s] more competitive bidding, such as by inducing a bid that otherwise would not have been made and without which bidding would have been limited." *Id.* at 537. Second, "if the availability of. . . [reimbursement of] expenses were to induce a bidder to research the value of the debtor and convert that value to a dollar figure on which other bidders can rely, the bidder may have provided a benefit to the estate by increasing the likelihood that the price at which the debtor is sold will reflect its true worth." *Id.*

- 43. The Stalking Horse Bid Protections only will be provided after good faith, arm's length negotiations between a prospective bidder and the Debtors (after consultation with any Committee), which are acting in the best interest of their estates, consistent with their fiduciary duties. Moreover, the Stalking Horse Bid Protections only will be provided if a Stalking Horse Bidder requires such protections as a condition to the Stalking Horse Bidder's obligation to proceed with a Sale Transaction. *See In re Reliant Energy Channelview, LP*, 594 F.3d 200 (3d Cir. 2010).
- 44. The Debtors will only provide Stalking Horse Bid Protections if doing so will promote the interests of the Debtors' estates to maximize value. The Termination Payment will promote more competitive bidding for the Debtors' assets by inducing a Stalking Horse Bidder to hold its offer open as a minimum bid on which other bidders and the Debtors can rely. In doing so, any Stalking Horse Bidder will help lay the foundation for the Debtors' sale process and will serve as a catalyst for other Qualified Bids. Accordingly, the Termination Payment is appropriate

and any Stalking Horse Bidder is entitled to be compensated for the risk it is assuming and the substantial value it is conferring on the Debtors' estates.

45. Finally, the Stalking Horse Bid Protections are reasonable in view of the substantial benefits the Debtors would receive from having a Stalking Horse Bid (as defined in the Bid Procedures) serve as a floor for potential bidders, which would confirm that the Debtors receive the highest and best purchase price for the applicable Assets. A Stalking Horse Bid will provide the Debtors with an opportunity to move forward with a Sale Transaction that has a high likelihood of consummation with a contractually committed party at a fair and reasonable purchase price. Accordingly, the Stalking Horse Bid Protections will not deter or chill bidding, are reasonable, and their availability to the Debtors will enable the Debtors to maximize the value of their estates. Finally, approval of any Stalking Horse Agreement will be subject to the procedures described herein.

C. The Proposed Sale Notice, the Proposed Date for the Sale Objection Deadline, the Cure Objection Deadline and the Sale Hearing Are Appropriate

- 46. The Debtors submit that the Sale Objection Deadline is reasonable and appropriate under the circumstances. Pursuant to Local Rule 9006-1 (c)(ii), [w]here a motion is filed and served in accordance with Local Rule 9006-1 (c)(i), the deadline for objection(s) shall be no later than seven (7) days before the hearing date." Del. Bankr. L.R. 9006-l(c)(ii). As noted above, the Sale Hearing is more than twenty-one (21) days from notice of this Motion and the Sale Objection Deadline has been scheduled seven (7) days in advance thereof. As such, the Debtors submit that the proposed Sale Objection Deadline meets the requirements of the Bankruptcy Rules and the Local Rules.
- 47. The Debtors submit that the notice to be provided through the Sale Notice and the method of service proposed herein fully complies with the requirements set forth in Bankruptcy

Rule 2002 and constitutes good and adequate notice of the Bid Procedures and the subsequent proceedings related thereto, including the proposed dates for: (a) the Bid Deadline; (b) the Sale Objection Deadline; (c) the Contract Objection Deadline; and (d) the Sale Hearing. Therefore, the Debtors respectfully request that the Court approve the proposed notice procedures.

D. The Contract Procedures Provide Adequate Notice and Opportunity to Object and Should Be Approved

- 48. Bankruptcy Code section 365(a) provides, in pertinent part, that a debtor-in-possession "subject to the courts approval, may assume or reject any executory contract or [unexpired] lease of the debtor." 11 U.S.C. § 365(a). As discussed in greater detail below, the standard governing bankruptcy court approval of a debtor's decision to assume or reject an executory contract or unexpired lease is whether the debtor's reasonable business judgment supports assumption or rejection. *See, e.g., In re Stable Mews Assoc., Inc.*, 41 B.R. 594, 596 (Bankr. S.D.N.Y. 1984).
- 49. The Debtors respectfully submit that the proposed Contract Procedures are appropriate and reasonably tailored to provide the Contract Parties with adequate notice of the proposed assumption and assignment of the applicable Contract, as well as proposed Cure Amounts, if applicable. Such Contract Parties then will be given an opportunity to object to such notice. The Contract Procedures further provide that, in the event an objection is not resolved, the Court will determine related disputed issues (including any adequate assurance of future performance issues). Accordingly, the Debtors submit that implementation of the proposed Contract Procedures is appropriate in these Chapter 11 Cases.
- 50. The Contract Procedures comport with the requirements of Bankruptcy Code section 365 (as described fully below) and Bankruptcy Rule 6006, and the non-Debtor contract counterparties' rights to adequate assurance are unaffected and fully preserved. The Debtors

respectfully submit that the notices required by the Contract Procedures are sufficient to assume and assign the Assigned Contracts because they are reasonably tailored to provide notice and an opportunity to object to the proposed assumption and assignment. Thus, the Debtors submit that the Contract Procedures should be approved.

E. The Sale Is Within the Sound Business Judgment of the Debtors and Should Be Approved

- 51. Ample authority exists for approval of a proposed Sale to a Successful Bidder. Bankruptcy Code section 363(b)(1) provides, in relevant part, that a debtor-in-possession, "after notice and a hearing, may use, sell, or lease, other than in the ordinary course of business, property of the estate." 11 U.S.C. § 363(b)(1). Bankruptcy Code section 363 does not set forth a standard for determining when it is appropriate for a court to authorize the sale or disposition of a debtor's assets prior to confirmation of a plan. However, courts in the Third Circuit and others have required that the decision to sell assets outside the ordinary course of business be based upon the sound business judgment of the debtor. See, e.g., Myers v. Martin (In re Martin), 91 F.3d 389, 395 (3d Cir. 1996) (internal citation omitted); Comm. of Equity Sec. Holders v. Lionel Corp. (In re Lionel Corp.), 722 F.2d 1063, 1070-71 (2d Cir. 1983); In re Abbotts Dairies of Pennsylvania, Inc., 788 F.2d 143, 147-48 (3d Cir. 1986) (implicitly adopting the "sound business judgment" test of In re Lionel Corp.); In re Delaware & Hudson Ry. Co., 124 B.R. 169, 175-76 (D. Del. 1991) (holding that the Third Circuit adopted the "sound business judgment" test in Abbotts Dairies); Dai-Ichi Kangyo Bank, Ltd. V. Montgomery Ward Holding Corp. (In re Montgomery Ward Holding Corp.), 242 B.R. 147, 153 (D. Del. 1999) (same).
- 52. The "sound business judgment" test requires a debtor to establish four elements in order to justify the sale or lease of property outside the ordinary course of business, namely: (a) that a "sound business purpose" justifies the sale of assets outside the ordinary course of business;

- (b) that adequate and reasonable notice has been provided to interested persons; (c) that the debtor has obtained a fair and reasonable price; and (d) good faith. Abbotts Dairies, 788 F.2d at 143; Titusville Country Club v. Pennbank (In re Titusville Country Club), 128 B.R. 396, 399 (Bankr. W.D. Pa. 1991); In re Sovereign Estates, Ltd., 104 B.R. 702, 704 (Bankr. E.D. Pa. 1989). A debtor's showing of a sound business purpose need not be unduly exhaustive but, rather, a debtor is "simply required to justify the proposed disposition with sound business reasons." *In re Baldwin* United Corp., 43 B.R. 888, 906 (Bankr. S.D. Ohio 1984). Whether or not there are sufficient business reasons to justify a transaction depends upon the facts and circumstances of each case. Lionel, 722 F.2d at 1071; Montgomery Ward, 242 B.R. at 155 (approving funding of employee incentive and severance program and holding that the business purpose requirement was fulfilled, because stabilizing turnover rate and increasing morale were necessary to successful reorganization). The demonstration of a valid business justification by the debtor leads to a strong presumption "that in making [the] business decision the directors of a corporation acted on an informed basis, in good faith and in the honest belief that the action taken was in the best interests of the company." Official Comm. of Subordinated Bondholders v. Integrated Res., Inc. (In re Integrated Res., Inc.), 147 B.R. 650, 656 (S.D.N.Y. 1992) (quoting Smith v. Van Gorkom, 488 A.2d 858, 872 (Del. 1985)).
- 53. Additionally, Bankruptcy Code section 105(a) provides a bankruptcy court with broad powers in the administration of a case under the Bankruptcy Code. Section 105(a) provides that "[t]he court may issue any order, process, or judgment that is necessary or appropriate to carry out the provisions of [the Bankruptcy Code]." 11 U.S.C. § 105(a). Provided that a bankruptcy court does not employ its equitable powers to achieve a result not contemplated by the Bankruptcy Code, the exercise of its section 105(a) power is proper. *In re Fesco Plastics Corp.*, 996 F.2d 152,

154 (7th Cir. 1993); *Pincus* v. *Graduate Loan Ctr. (In re Pincus)*, 280 B.R. 303, 312 (Bankr. S.D.N.Y. 2002).

F. A "Sound Business Purpose" Supports the Sale

54. As set forth in the First Day Declaration, in light of the lack of realistic stand-alone restructuring options, the Debtors have determined, in the exercise of their reasonable business judgment, that the most effective way to maximize the value of their estates for the benefit of their constituents is to sell the Assets pursuant to Bankruptcy Code section 363 to the highest or otherwise best bidder. To that end, the Debtors, with the assistance of their professionals, have designed the Bid Procedures to promote a fair and open atmosphere for bidding on the Debtors' assets, with the goal of maximizing value to be distributed to creditors of the Debtors' estates.

G. Sufficient Notice of the Proposed Sale Has Been Provided to Interested Parties

- 55. Pursuant to the Bid Procedures and the notice procedures set forth herein, the Debtors will employ various methods of notification to ensure that all interested and potentially affected parties will be informed of the Sale. In order to generate the greatest number of bidders possible for the Sale and to satisfy the requirements of Bankruptcy Rule 2002, the Debtors will serve the Sale Notice upon the Sale Notice Parties.
- 56. Additionally, the Debtors will file and serve the Cure Notice on all non-Debtor counterparties to the Contracts providing them with notice of this Motion, the potential assumption and assignment of Contracts and the Debtors' proposed Cure Amount. The Debtors submit that more than ample notice of the Sale has been provided to interested parties under the facts and circumstances of these Chapter 11 Cases.

H. The Proposed Sale Is for a Fair and Reasonable Price

- 57. At the Sale Hearing, the Debtors will establish that the purchase price for the Assets is fair and reasonable. The Bid Procedures have been designed to ensure that the highest or otherwise best offer for the Assets will be attained. With the assistance of SSG, the Debtors continue to: (a) conduct a comprehensive marketing process in order to maximize value; (b) solicit the interest of various potential strategic and financial buyers; and (c) entertain offers for an alternative sale transaction that will maximize the value of the Debtors' business. The Debtors expect that their continued marketing efforts will result in the submission of one or more competing bids prior to the proposed Bid Deadline of March 29, 2024.
- 58. Because the ultimate purchase price for the Assets will be determined in accordance with the Court-approved Bid Procedures at an Auction, it will be fair and reasonable as contemplated by Bankruptcy Code section 363. *See, e.g., In re Abbotts Dairies of Pa., Inc.*, 788 F.2d at 149 (finding that "[g]enerally speaking, an auction may be sufficient to establish that one has paid 'value' for the assets of a bankrupt"); *In re Nat'l. Health & Safety Corp.*, 1999 Bankr. LEXIS 1126 (Bankr. E.D. Pa. Sept. 2, 1999) (citing *Abbotts Dairies* for the proposition that an auction may be sufficient to establish that one has paid value for the assets of a debtor, and relying upon auction results to verify that the purchase price represented value).

I. The Proposed Sale Has Been Negotiated at Arm's Length and in Good Faith

59. The "good faith" prong of *Abbotts Dairies* standard is also satisfied. The Debtors request that the Court find that the Successful Bidder is entitled to the benefits and protections provided by Bankruptcy Code section 363(m) in connection with the Sale. Bankruptcy Code section 363(m) provides, in pertinent part:

The reversal or modification on appeal of an authorization under subsection (b) . . . of this section of a sale . . . of property does not

affect the validity of a sale . . . under such authorization to an entity that purchased . . . such property in good faith, whether or not such entity knew of the pendency of the appeal, unless such authorization and such sale . . . were stayed pending appeal.

11 U.S.C. § 363(m).

- 60. Bankruptcy Code section 363(m) thus protects the buyer of assets sold pursuant to Bankruptcy Code section 363 from the risk that it will lose its interest in the Assets if the order allowing the sale is reversed on appeal. By its terms, Bankruptcy Code section 363(m) applies to sales of interests in tangible assets, such as the Assets.
- 61. The Debtors submit, and will present evidence at the Sale Hearing, if necessary, that as set forth above, the Successful Bidder's purchase agreement will be an arm's-length transaction, in which the Successful Bidder acted in good faith. The Debtors and the Successful Bidder will have negotiated the Successful Bidder's purchase agreement in good faith and without collusion or fraud of any kind. The Successful Bidder will not have engaged in collusion or any conduct that would otherwise control or tend to control the sale price as between or among Potential Bidders. The Bid Procedures are designed to maximize rather than chill competitive bidding and the Auction promotes an open and competitive sale process. The Debtors will have their own legal counsel in negotiations over the Successful Bid and will have their own legal counsel to negotiate on their behalf throughout the Auction and the Sale. Accordingly, the Debtors request that the Court make the finding at the Sale Hearing that the Successful Bidder, including, if applicable, the Stalking Horse Bidder, has purchased the Assets in good faith within the meaning of Bankruptcy Code section 363(m).

J. All Pertinent Information Regarding the Proposed Sale Has Been Fully Disclosed

62. The Debtors have presented the proposed asset sale openly and in good faith. The Debtors have fully disclosed and requested the Court approval of all of the terms and conditions

of the proposed Sale. Sufficient and adequate notice of this Motion has been provided to interested parties and such parties will receive further notice of the Sale and all relevant dates and deadlines related thereto through the Court-approved Sale Notice.

63. The Debtors will be prepared to introduce evidence at the Sale Hearing regarding the arm's-length, good faith nature of the Auction and the negotiation of any agreement with a Successful Bidder. Indeed, the Debtors will be able to demonstrate that the Bid from the Successful Bidder represents the highest or otherwise best bid available to the Debtors for the Assets following a robust marketing and competitive bidding process. Accordingly, any proposed Sale will be proposed and fully disclosed in good faith and represents the sound business judgment of the Debtors; and, as such, is entitled to Court approval.

K. The Sale Satisfies the Requirements of Bankruptcy Code Section 363(1)

- 64. Under Bankruptcy Code section 363(f), a debtor-in-possession may sell all or any part of its property free and clear of any and all liens, claims or interests in such property if: (a) such a sale is permitted under applicable non-bankruptcy law; (b) the party asserting such a lien, claim or interest consents to such sale; (c) the interest is a lien and the purchase price for the property is greater than the aggregate amount of all liens on the property; (d) the interest is the subject of a bona fide dispute; or (e) the party asserting the lien, claim or interest could be compelled, in a legal or equitable proceeding, to accept a money satisfaction for such interest. 11 U.S.C. § 363(f); *In re Trans World Airlines, Inc.*, 322 F.3d 283 (3d Cir. 2003); *Citicorp Homeowners Serv., Inc.* v. *Elliot (In re Elliot)*, 94 B.R. 343, 345 (E.D. Pa. 1988).
- 65. Here, the Sale satisfies the criteria set forth in Bankruptcy Code section 363(f). The Debtors believe that, at a minimum, it satisfies the fifth prong of section 363(f) because the holders of any liens, claims, encumbrances, or interests could be compelled, in a legal or equitable

proceeding, to accept a monetary satisfaction equal to the amount of their lien, claim, encumbrance, or interest.

L. The Assumption and Assignment of Executory Contracts and Unexpired Leases Should Be Authorized

As explained above, Bankruptcy Code section 365(a) provides, in pertinent part, 66. that a debtor-in-possession "subject to the court's approval, may assume or reject any executory contract or [unexpired] lease of the debtor." 11 U.S.C. § 365(a). The standard governing bankruptcy court approval of a debtor's decision to assume or reject an executory contract or unexpired lease is whether the debtor's reasonable business judgment supports assumption or rejection. See. e.g., Stable Mews Assoc., 41 B.R. at 596. If the debtor's business judgment has been reasonably exercised, a court should approve the assumption or rejection of an unexpired lease or executory contract. See Group of Institutional Investors v. Chicago M St. P. & P.R.R. Co., 318 U.S. 523 (1943); Sharon Steel Corp., 872 F.2d 36, 39-40 (3d Cir. 1989). The business judgment test "requires only that the trustee [or debtor-in-possession] demonstrate that [assumption or] rejection of the contract will benefit the estate." Wheeling-Pittsburgh Steel Corp. v. West Penn Power Co. (In re Wheeling-Pittsburgh Steel Corp.), 72 B.R. 845, 846 (Bankr. W.D. Pa. 1987) (quoting Stable Mews Assoc., 41 B.R. at 596). Any more exacting scrutiny would slow the administration of a debtor's estate and increase costs, interfere with the Bankruptcy Code's provision for private control of administration of the estate, and threaten the court's ability to control a case impartially. See Richmond Leasing Co. v. Capital Bank, NA., 762 F.2d 1303, 1311 (5th Cir. 1985). Moreover, pursuant to Bankruptcy Code section 365(b)(1), for a debtor to assume an executory contract, it must "cure, or provide adequate assurance that the debtor will promptly cure," any default, including compensation for any "actual pecuniary loss" relating to such default. 11 U.S.C. § 365(b)(1).

- 67. Once an executory contract is assumed, the trustee or debtor-in-possession may elect to assign such contract. *See In re Rickel Home Centers, Inc.*, 209 F.3d 291, 299 (3d Cir. 2000) ("[t]he Code generally favors free assignability as a means to maximize the value of the debtor's estate"); *see also In re Headquarters Dodge, Inc.*, 13 F.3d 674, 682 (3d Cir. 1994) (noting purpose of section 365(f) is to assist trustee in realizing the full value of the debtor's assets).
- 68. Bankruptcy Code section 365(f) provides, in pertinent part, that a trustee may assign an executory contract or unexpired lease of a debtor only if:
 - (A) the trustee assumes such contract or lease in accordance with the provisions of this section; and
 - (B) adequate assurance of future performance by the assignee of such contract or lease is provided, whether or not there has been a default in such contract or lease.

11 U.S.C. § 365(f)(2).

- 69. Bankruptcy Code section 365(a) provides that a debtor, "subject to the court's approval, may assume or reject any executory contract or unexpired lease of the debtor." 11 U.S.C. § 365(a). Moreover, Bankruptcy Code section 365(b) codifies the requirements for assuming an executory contract of a debtor. This provision provides that:
 - (b)(1) If there has been a default in an executory contract or unexpired lease of the debtor, the trustee may not assume such contract or lease unless, at the time of assumption of such contract or lease, the trustee —
 - (A) cures, or provides adequate assurance that the trustee will promptly cure, such default. . . ;
 - (B) compensates, or provides adequate assurance that the trustee will promptly compensate, a party other than the debtor to such contract or lease, for any actual pecuniary loss to such party resulting from such default; and
 - (C) provides adequate assurance of future performance under such contract or lease.

11 U.S.C. § 365(b)(1).

- 70. The meaning of "adequate assurance of future performance" depends on the facts and circumstances of each case, but should be given "practical, pragmatic construction." *See Carlisle Homes, Inc.* v. *Arrari (In re Carlisle Homes, Inc.)*, 103 B.R. 524, 538 (Bankr. D.N.J. 1989); *see also In re Natco Indus., Inc.*, 54 B.R. 436, 440 (Bankr. S.D.N.Y. 1985) (adequate assurance of future performance does not mean absolute assurance that debtor will thrive and pay rent). Among other things, adequate assurance may be given by demonstrating the assignee's financial health and experience in managing the type of enterprise or property assigned. *Accord In re Bygaph, Inc.*, 56 B.R. 596, 605-06 (Bankr. S.D.N.Y. 1986) (adequate assurance of future performance is present when prospective assignee of lease from debtors has financial resources and has expressed willingness to devote sufficient funding to business in order to give it strong likelihood of succeeding).
- 71. To the extent any defaults exist under any Assigned Contract sought to be assumed by the Debtors and assigned to the Successful Bidder such defaults will be cured as required under Bankruptcy Code section 365(b)(1).
- 72. The Debtors and/or the Successful Bidder will establish at the Sale Hearing that the Successful Bidder has the financial capability to satisfy any and all obligations they will incur in connection with the Assigned Contracts. In addition, to be a Qualified Bid, any Qualified Bidder must establish it has the financial capability to satisfy any and all obligations it will incur in connection with the Assigned Contracts. Further, facts will be further adduced at the Sale Hearing to show the financial wherewithal of the Successful Bidder, its experience in the industry and its willingness and ability to satisfy obligations under the Assigned Contracts. Because the Sale Hearing will provide the Court with an opportunity to evaluate the ability of the Successful Bidder to provide adequate assurance of future performance under the Assigned Contracts, as required by

Bankruptcy Code section 365(b)(1)(C), the Debtors submit that the Court should authorize the assumption and assignment of the Assigned Contracts by the Debtors, effective upon the Closing of the proposed Sale.

73. Additionally, the contract procedures set forth herein provide that all of the counterparties to Contracts with the Debtors will be given notice of this Sale Motion and through the Cure Notice and any Additional Cure Notice have been provided with notice of the potential assumption and assignment of their Contract and the Debtors' proposed Cure Amounts associated therewith. Based on the foregoing, the Debtors respectfully submit that their assumption and assignment of the Assigned Contracts satisfies the requirements under Bankruptcy Code section 365(f)(2)(A) and (B).

M. Relief from the Fourteen Day Waiting Period Under Bankruptcy Rules 6004(h) and 6006(d) is Appropriate

- 74. The Debtors seek a waiver of any stay of the effectiveness of the order approving this Motion. Pursuant to Bankruptcy Rule 6004(h), "[an] order authorizing the use, sale, or lease of property other than cash collateral is stayed until the expiration of fourteen (14) days after entry of the order, unless the court orders otherwise." *See* Fed. R. Bankr. P. 6004(h). As set forth above, the relief requested herein is essential to maximize the value of the Debtors' business for the benefit of all stakeholders.
- 75. Pursuant to Bankruptcy Rule 6004(h), unless the court orders otherwise, all orders authorizing the sale of property pursuant to Bankruptcy Code section 363 are automatically stayed for fourteen (14) days after entry of the order. *See id.* The purpose of Bankruptcy Rule 6004(h) is to provide sufficient time for an objecting party to request a stay pending appeal before the order can be implemented. *See* Advisory Committee Notes to Fed. R. Bankr. P. 6004(g).

- 76. Similarly, Bankruptcy Rule 6006(d) stays all orders authorizing a debtor to assign an executory contract or unexpired lease pursuant to Bankruptcy Code section 365(f) for fourteen (14) days, unless the court orders otherwise. *See* Fed. R. Bankr. P. 6006(d).
- 77. To preserve the value of the Assets and limit the costs of administering and preserving such assets, it is critical that the Debtors close the Sale as soon as possible after all closing conditions have been achieved or waived. Accordingly, the Debtors hereby request that the Court waive the fourteen (14) day stay periods under Bankruptcy Rules 6004(h) and 6006(d).
- 78. Based upon the foregoing, the Debtors submit that the relief requested herein is necessary and appropriate, is in the best interests of the Debtors and their estates, and should be granted in all respects.

NOTICE AND NO PRIOR REQUEST

- 79. Notice of this Motion has been given to the Sale Notice Parties, but excluding the Debtors' known creditors. Notice of the Motion as it relates to the approval of the Sale and related requests will be given to the Sale Notice Parties. In light of the nature of the relief requested herein, the Debtors submit that no other or further notice is necessary.
- 80. No prior Motion for the relief requested herein has been made to this or any other court.
- 81. WHEREFORE, the Debtors respectfully request: (i) entry of the proposed Bid Procedures Order; (ii) entry of the proposed Sale Order; and (iii) such other and further relief as the Court deems just and proper.

as <u>Exhibit 2</u> (the "<u>Sale Notice</u>"), (iv) establishing procedures to determine cure amounts and deadlines for objections to the assumption and assignment of executory contracts and unexpired leases as set forth in the Motion (collectively, the "<u>Contract Procedures</u>"); and (v) granting related relief; and it appearing that the notice of the Motion provided is appropriate and sufficient under the circumstances and that no other or further notice need be given; and it appearing that the relief requested is in the best interests of the Debtors' estates, their creditors and other parties in interest; and after due deliberation and good and sufficient cause appearing therefor:

THE COURT HEREBY FINDS AND CONCLUDES THAT:3

- A. This Court has jurisdiction over this matter and over the properties of the Debtors and their estates pursuant to 28 U.S.C. §§ 157 and 1334. This proceeding is a core proceeding pursuant to 28 U.S.C. § 157. Venue is proper in this district and in this Court pursuant to 28 U.S.C. §§ 1408 and 1409.
- B. The statutory and rule-based predicates for the relief requested in the Motion are Bankruptcy Code sections 105(a), 363, 365, 503 and 507, Bankruptcy Rules 2002, 6003, 6004, 6006, 9007, 9008 and Local Rule 6004-1.
- C. Notice of the Motion having been given as set forth in the Motion is sufficient in light of the circumstances and the nature of the relief requested in the Motion and no other or further notice is necessary or required, except as otherwise set forth herein.
- D. The Debtors have articulated good and sufficient reasons for this Court to grant the relief requested in the Motion regarding the Sale process, including, without limitation: (i)

approving the Bid Procedures; (ii) approving the Stalking Horse Bid Protections; (iii) scheduling the Auction and the Sale Hearing; (iv) approving the Sale Notice; and (v) approving the Cure Notice and Contract Procedures.

- E. The Debtors have demonstrated a sound business justification for authorizing the Stalking Horse Bid Protections.
- F. The Bid Procedures were proposed and negotiated in good faith by the Debtors, and are fair, reasonable and appropriate under the circumstances, and are properly designed to maximize the recovery from any sale of the Assets.
- G. The form and scope of the Sale Notice attached hereto as Exhibit 2 is appropriate and reasonably calculated to provide all interested parties with timely and proper notice of the Sale, the Sale Hearing and the Auction and no other and further notice is required.
- H. The Contract Procedures and the notices related thereto, including the Cure Notice attached hereto as Exhibit 3 and the Additional Cure Notice attached as Exhibit 4 are appropriate and reasonably calculated to provide all Contract Parties with proper notice of the potential assumption and assignment of Contracts or unexpired leases and any Cure Amounts relating thereto and no further or other notice is required.
- I. The entry of this Order is in the best interests of the Debtors, their estates, their creditors, and other parties in interest; and it is therefore:

ORDERED, ADJUDGED AND DECREED THAT:

- 1. The relief requested in the Motion is GRANTED as set forth herein.
- 2. The Bid Procedures and Contract Procedures are approved in all respects and the relief requested in the Motion as it pertains to the Bid Procedures and Contract Procedures, is granted.

- 3. All objections to the relief requested in the Motion with respect to the Bid Procedures or the Contract Procedures that have not been withdrawn, waived, or settled as announced to the Court at the hearing on the Motion or as reflected in this Order or by stipulation or withdrawal filed with the Court, are overruled.
- 4. The Bid Procedures attached hereto as <u>Exhibit 1</u> are hereby approved and fully incorporated into this Order, and shall apply with respect to the Auction and the proposed Sale of the Assets.
- 5. The Debtors are authorized to take any and all actions necessary or appropriate, consistent with the terms of this Order, to implement the Bid Procedures.
 - 6. The Stalking Horse Bid Protections are approved as set forth herein:
 - To the extent the Debtors designate a Stalking Horse Bidder with respect to a. any of the assets, the Debtors shall promptly upon execution of a Stalking Horse Agreement (and in no event more than one (1) calendar day following such execution) file with the Court and cause to be published on the website maintained by the Debtors' claims and noticing agent in these Chapter 11 Cases. located at the Debtors' claims agent's website https://www.kccllc.net/invivo, a notice that contains information about the Stalking Horse Bidder, the Stalking Horse Bid, attaches the proposed Stalking Horse Agreement, and describes any Stalking Horse Bid Protections proposed to be afforded to the Stalking Horse Bidder (as defined herein) (the "Notice of Stalking Horse Bidder"):
 - b. Any objections (each, a "Stalking Horse Objection") to the designation of a Stalking Horse Bidder, including any Stalking Horse Bid Protections pursuant to the terms and provisions of a Stalking Horse Agreement, must (i) be in writing; (ii) state the name and address of the objecting party and the amount and nature of the Claim or Interest of such party; (iii) state with particularity the basis and nature of any objection; (iv) conform to the Bankruptcy Rules and the Local Rules; and (v) be served upon the Sale Notice Parties within five (5) calendar days after the filing of the relevant Notice of Stalking Horse Bidder. If a timely Stalking Horse Objection is filed and served in accordance with the preceding paragraph, the proposed Stalking Horse Bid Protections will not be deemed approved until either the Stalking Horse Objection is resolved by agreement of the objecting party and the Debtors or by order of the Court. If no timely Stalking Horse Objection is filed and served with respect to an applicable Stalking Horse

Agreement in accordance with the Bid Procedures, the Stalking Horse Bid Protections shall be deemed approved without further order of the Court upon the expiration of the objection deadline.

- 7. Pursuant to the Bid Procedures, the Debtors may designate one or more Stalking Horse Bidders on or before March 26, 2024 at 4:00 p.m. (ET).
- 8. The Debtors shall have the right to determine at the Auction that any Qualified Bid shall be the Back-Up Bid.
- 9. Pursuant to the Bid Procedures, a Potential Bidder that desires to make a bid shall deliver written copies of its bid to the parties identified in the Bid Procedures no later than 4:00 p.m. (ET) on March 29, 2024, (the "Bid Deadline") and shall comply with all other requirements set forth in the Bid Procedures in making such a bid for the Assets.
- 10. To the extent the Debtors receive at least two Qualified Bids, the Debtors shall conduct the Auction commencing at 10:00 a.m. (ET) on April 3, 2024, at the offices of Landis Rath & Cobb LLP, 919 Market Street, Suite 1800, Wilmington, Delaware 19801, or by remote audio and/or video link.
- 11. If the Debtors do not receive a Qualified Bid, the Debtors will not hold the Auction. No later than 4:00 p.m. (ET) on April 1, 2024, the Debtors shall notify all Qualified Bidders and counsel to the Committee, if any, whether the Auction will occur.
- 12. Upon conclusion of the bidding at any Auction, the Auction shall be closed, and the Debtors, in consultation with the Committee, if any, shall (i) review each Qualified Bid on the basis of financial and contractual terms and the factors relevant to the Sale process and the contract assumption process, including, without limitation, those factors affecting the speed and certainty of consummating the proposed Sale and the amount of the cash (or cash equivalents) consideration and (ii) identify the highest or otherwise best offer for the Assets (the "Successful Bid" and the

entity submitting such Successful Bid, the "Successful Bidder"), the Back-Up Bid and the Back-Up Bidder and advise the Qualified Bidders of such determinations.

- 13. The Debtors, in their reasonable business judgment, in consultation with the Committee, if any, may (a) determine which Qualified Bid, if any, is the highest or otherwise best offer; and (b) reject, at any time before entry of an order of the Court approving a Qualified Bid, any bid that is (i) inadequate or insufficient; (ii) not in conformity with the requirements of the Bankruptcy Code, the Bid Procedures, or the terms and conditions of the Sale; or (iii) contrary to the best interests of the Debtors, their estates, their creditors, or other stakeholders.
- 14. The Debtors' presentation of a particular Qualified Bid to the Court for approval does not constitute the Debtors' acceptance of such Qualified Bid. Other than as expressly set forth in the Bid Procedures Order, the Debtors will be deemed to have accepted a bid only when the bid has been approved by the Court at the Sale Hearing.
- 15. After the Successful Bid, the next highest or otherwise best offer, as determined by the Debtors, in consultation with the Committee, if any, (the "Back-Up Bid") shall remain open, and the entity submitting such Back-Up Bid (the "Back-Up Bidder") shall be required to fully perform under such Back-Up Bid, until the consummation of a Sale Transaction with the Successful Bidder. In the event the Successful Bidder fails to consummate the Sale as a result of the Successful Bidder's default or breach under the applicable purchase agreement in accordance with the terms of such purchase agreement by the closing date contemplated in such purchase agreement, the Debtors shall be, among other things, free to enter into a new purchase agreement with the Back-Up Bidder at the purchase price contemplated in the Back-Up Bid. Following the approval of the Sale of the Assets to the Successful Bidder at the Sale Hearing, if such Successful Bidder fails to consummate the approved Sale within thirty (30) days after entry of an Order

approving such Sale, the Debtors shall be authorized, in consultation with the Committee, if any, but not required, to deem the Back-Up Bid, as disclosed at the Sale Hearing, the Successful Bid, and the Debtors may consummate the Sale to the Back-Up Bidder without further order of the Court.

- 16. The Contract Procedures, setting forth, among other things, the procedures for determining the Cure Amounts and the deadline for objecting to the Cure Amounts and/or the proposed assumption and assignment of executory contracts and unexpired leases, as provided in the Motion, are hereby approved in their entirety. Notice of the Contract Procedures in the form attached hereto as Exhibit 3 and service of such notice of the Contract Procedures to the Contract Parties, are appropriate and sufficient under the circumstances, and no other or further notice of the Contract Procedures need to be given.
- 17. The Court shall conduct the Sale Hearing commencing on April 5, 2024 at 10:00 a.m. (ET), at which time the Court will consider approval of the Sale to the Successful Bidder and entry of the Sale Order.
- Objections to approval of the Sale and entry of the Sale Order, including the sale of the Assets free and clear of all Encumbrances pursuant to Bankruptcy Code section 363(f), with such Encumbrances to attach to the Sale Proceeds (if any) (a "Sale Objection"), must be in writing and filed with the Court and served on (i) counsel for the Debtors, Landis Rath & Cobb LLP, 919 Market Street, Suite 1800, Wilmington, Delaware 19801 (Attn: Matthew B. McGuire, Esq. (e-mail: mcguire@lrclaw.com) and Joshua B. Brooks, Esq. (e-mail: brooks@lrclaw.com)); and Wilmer Cutler Pickering Hale and Dorr LLP, 7 World Trade Center, 250 Greenwich Street, New York, New York, 10007 (Attn: George Shuster, Esq. (e-mail: george.shuster@wilmerhale.com) and Benjamin Loveland, Esq. (e-mail: benjamin.loveland@wilmerhale.com)); (ii) counsel to the

Committee, if any; and (iii) the Office of the United States Trustee, 844 King Street, Suite 2207, Wilmington, Delaware 19801 (Attn: Joseph Cudia, Esq. (email: Joseph.Cudia@usdoj.gov)), so as to be received by such parties prior to 4:00 p.m. (ET) on March 29, 2024 (the "Sale Objection Deadline").

19. Amounts listed by the Debtors and to propose alternative Cure Amounts, and/or (b) the proposed assumption and assignment of the Contracts in connection with the Sale, including, without limitation, the Debtors' ability to assign the Contracts without the Contract Parties' consent (a "Contract Objection"), must be in writing and filed with the Court and served on (i) counsel for the Debtors, Landis Rath & Cobb LLP, 919 Market Street, Suite 1800, Wilmington, Delaware 19801 (Attn: Matthew B. McGuire, Esq. (e-mail: mcguire@lrclaw.com) and Joshua B. Brooks, Esq. (e-mail: brooks@lrclaw.com)); and Wilmer Cutler Pickering Hale and Dorr LLP, 7 World Trade Center, 250 Greenwich Street, New York, New York, 10007 (Attn: George Shuster, Esq. (e-mail: george.shuster@wilmerhale.com) and Benjamin Loveland, Esq. (email: benjamin.loveland@wilmerhale.com)); (ii) counsel to the Committee, if any; and (iii) the Office of the United States Trustee, 844 King Street, Suite 2207, Wilmington, Delaware 19801 (Attn: Joseph Cudia, Esq. (email: Joseph.Cudia@usdoj.gov)), so as to be received by such parties prior to 4:00 p.m. (ET) on the date that is fourteen (14) days following service of the Cure Notice but no later than March 29, 2024 (the "Contract Objection Deadline"); provided, however, that objections to the adequate assurance of future performance to be provided by the Successful Bidder (or any designee thereof) may be made at the Sale Hearing or at another date set by the Court; provided, however, that if the Debtors amend the Cure Notice to add a contract or lease, the non-Debtor party to the added contract or lease shall have until the earlier of (i) fourteen (14) days after service of notice of adding a contract or lease; or (ii) the Sale Hearing to submit a Contract Objection with respect to the contract or lease added by the Debtors' amendment (the "Amended Contract Objection Deadline"); provided further, that if the Debtors amend the Cure Notice to reduce the Cure Amount of a Contract or lease, except where such reduction was upon mutual agreement of the parties, the non-Debtor party to the Contract or lease with the reduced Cure Amount shall have until the Amended Contract Objection Deadline to object to the Cure Amount; and provided further, that in the event the Auction results in a Successful Bidder, the Contract Parties shall have until the Amended Contract Objection Deadline to object to the assignment of executory contracts and unexpired leases to such Successful Bidder, other than to the Cure Amount which shall be subject to the Contract Objection Deadline, with any such objection being heard at the Sale Hearing or at a later-scheduled hearing as the Court deems appropriate.

20. Unless a Contract Objection is filed and served before the Contract Objection Deadline or the Amended Contract Objection Deadline, as applicable, all Contract Parties shall be (i) forever barred from objecting to the proposed Cure Amounts and from asserting any additional cure or other amounts (other than as may be asserted in an Additional Cure Notice), and the Debtors and the Successful Bidder shall be entitled to rely solely upon the proposed Cure Amounts set forth in the Cure Notices; (ii) deemed to have consented to the assumption and assignment, (iii) forever barred and estopped from asserting or claiming against the Debtors or the Successful Bidder, as applicable, that any additional amounts are due or other defaults exist (other than as may be asserted in an Additional Cure Notice), that conditions to assignment must be satisfied under such Contracts, including without limitation adequate assurance of future performance; (iv) precluded from objecting to the Cure Amount (if any) and the assumption and assignment; and (v) barred and estopped from asserting or claiming that their Contract contains an enforceable consent right.

- 21. The Debtors, the Contract Party, and the Successful Bidder may consensually resolve any Contract Objection prior to the Sale Hearing. In the event a Contract Objection is not resolved, such Contract Objection will be heard at the Sale Hearing or thereafter, or the Successful Bidder may designate such Contract as a Contract that will not be assumed and assigned to the Successful Bidder, in which case such Contract shall not be assumed and shall remain property of the Debtors' estates, subject to any further orders of the Court.
- 22. The Debtors are hereby authorized to share certain of the Contracts that contain confidentiality restrictions with Qualified Bidders subject to the terms of the non-disclosure agreement by and between the Debtors and each Qualified Bidder, provided that each such Qualified Bidder requesting access to such confidential contracts enters into a non-disclosure agreement with the Debtors, in a form acceptable to the Debtors.
- 23. All Qualified Bidders are deemed to have submitted to the exclusive jurisdiction of the Court with respect to all matters between and among any Qualified Bidder and the Debtors related to the Auction and the Sale.
- 24. The Sale Notice attached hereto as <u>Exhibit 2</u> is approved. The Sale Notice provides all parties in interest good and sufficient notice of the relief sought in the Motion, including, but not limited to, the Auction, the Bid Deadline, the Bid Procedures, the Sale Hearing, and the Sale.
- 25. Within two (2) business days of the entry of the Bid Procedures Order, the Debtors shall serve by first class mail, postage prepaid, copies of: (i) this Order and (ii) the Sale Notice upon the following entities: (a) the Office of the United States Trustee for the District of Delaware; (b) counsel to the Committee, if any, or if none is formed, the creditors holding the twenty (20) largest unsecured claims as set forth on the list filed with the Debtors' petitions; (c) all taxing authorities having jurisdiction over any of the Assets subject to the Sale, including the Internal

Revenue Service; (d) the Environmental Protection Agency; (e) the U.S. Securities Exchange Commission; (f) the state/local environmental agencies in the jurisdictions where the Debtors own or lease real property; (g) all parties that have requested notice pursuant to Bankruptcy Rule 2002 as of the date prior to the date of entry of the Bid Procedures Order; (h) all persons or entities known to the Debtors that have or have asserted a lien on, or security interest in, all or any portion of the Assets; (i) all of the Debtors' known creditors; (j) the Food and Drug Administration; and (k) all potential bidders previously identified or otherwise known to the Debtors (collectively, the "Sale Notice Parties"). The Debtors are also authorized and directed to publish the Sale Notice in the national edition of either the *Wall Street Journal National Edition* or *USA Today* or similar publication once

- 26. The Cure Notice attached hereto as <u>Exhibit 3</u> provides proper notice to all parties in interest and is approved. The Debtors shall serve the Cure Notice on all Contract Parties by first class mail not less than fourteen days prior to the Sale Objection Deadline.
- 27. The Additional Cure Notice attached hereto as <u>Exhibit 4</u> provides proper notice to all parties in interest and is approved. The Debtors shall serve the Additional Cure Notice pursuant to the additional assumption procedures as provided in the Motion.
 - 28. All of the dates set forth on the attached <u>Schedule 1</u> are hereby approved.
- 29. This Order shall constitute findings of fact and conclusions of law and shall take effect immediately upon execution hereof.
- 30. Notwithstanding the possible applicability of Bankruptcy Rule 6003 or 6004(h) or otherwise, the terms and conditions of this Order shall be immediately effective and enforceable upon its entry, and no automatic stay of execution shall apply to this Order.

BID PROCEDURES

Overview

On February 1, 2024, InVivo Therapeutics Holdings Corp. and InVivo Therapeutics Corporation, as debtors and debtors in possession (together, the "<u>Debtors</u>"), filed voluntary petitions for relief under chapter 11 of title 11 of the United States Code (the "<u>Bankruptcy Code</u>") in the United States Bankruptcy Court for the District of Delaware (the "<u>Court"</u>).

On February [__], 2024, the Court entered an order [D.I. __] (the "<u>Bid Procedures Order</u>")² which, among other things, authorized the Debtors to solicit bids and approved these procedures (the "<u>Bid Procedures</u>") for the consideration of the highest or otherwise best bid for all or a portion of the Debtors' assets on the terms and conditions set forth herein (a "<u>Sale Transaction</u>").

The Bid Procedures describe, among other things: (i) the procedures for bidders to submit bids for the Debtors' assets; (ii) the manner in which bidders and bids become Qualified Bidders and Qualified Bids; (iii) the process for negotiating the bids received; (iv) the conduct of the Auction if the Debtors receive Qualified Bids; (v) the procedure for the ultimate selection of any Successful Bidder; and (vi) the process for approval of a Sale Transaction at the Sale Hearing (as defined herein).

Assets to be Sold

The Debtors intend to offer substantially all of their assets for Sale. Parties may submit bids for the purchase and sale of any and all of the Debtors' assets, in accordance with the terms and conditions set forth herein.

Due Diligence

The Debtors have posted copies of all material documents related to the Debtors' assets to the Debtors' confidential electronic data room (the "<u>Data Room</u>"). To access the Data Room, a party must submit to the Debtors' advisors:

- 1. an executed confidentiality agreement in form and substance reasonably satisfactory to the Debtors (unless such party is already a party to an existing confidentiality agreement with the Debtors that is acceptable to the Debtors for this due diligence process, in which case such agreement shall govern); and
- 2. sufficient information, as reasonably requested by the Debtors, to allow the Debtors to determine that the interested party (i) has the financial wherewithal to consummate a Sale Transaction, and (ii) intends to access the Data Room for a purpose consistent with these Bid Procedures.

An interested party that meets the aforementioned requirements to the satisfaction of the Debtors shall be a "Potential Bidder." As soon as practicable, the Debtors will provide such Potential Bidder access to the Data Room; <u>provided</u>, <u>however</u>, that, such access may be terminated by the Debtors in their reasonable discretion at any time for any reason whatsoever, including that a Potential Bidder does not become a Qualified Bidder, violates these Bid Procedures or these Bid Procedures are terminated.

Each Potential Bidder shall comply with all reasonable requests for information and due diligence access by the Debtors or their advisors regarding the ability of such Potential Bidder to consummate a Sale Transaction.

Until the Bid Deadline, the Debtors will provide any Potential Bidder with reasonable access to the Data Room and any additional information requested by Potential Bidders (subject to any restrictions pursuant to applicable law) that the Debtors believe to be reasonable and appropriate under the circumstances. All additional due diligence requests shall be directed to the Debtors' investment bankers, SSG Advisors, LLC, Attn: J. Scott Victor (jsvictor@ssgca.com) and Teresa Kohl (tkohl@ssgca.com). Unless prohibited by law or otherwise determined by the Debtors, the availability of additional due diligence to a Potential Bidder will cease if (i) the Potential Bidder does not become a Qualified Bidder, (ii) these Bid Procedures are terminated, or (iii) the Potential Bidder breaches any obligations under its confidentiality agreement.

Neither the Debtors nor any of their representatives shall be obligated to furnish any information of any kind whatsoever relating to the Debtors' assets to any person or entity who (i) is not a Potential Bidder, (ii) does not comply with the participation requirements set forth herein, or (iii) in the case of competitively sensitive information, is a competitor of the Debtors.

Designation of Stalking Horse Bidders

<u>Designation of Stalking Horse Bidders</u>. The Debtors, in consultation with any official committee of unsecured creditors appointed in the Chapter 11 Cases (the "<u>Committee</u>"), may designate one or more Stalking Horse Bidders and enter into Stalking Horse Agreements with such Stalking Horse Bidders. The Debtors may designate one or more Stalking Horse Bidders on or

before March 26, 2024 at 4:00 p.m. (ET). To the extent the Debtors designate a Stalking Horse Bidder with respect to any of the assets, the Debtors shall promptly upon execution of a Stalking Horse Agreement (and in no event more than one (1) calendar day following such execution) file with the Court and cause to be published on the website maintained by the Debtors' claims and noticing agent in this Chapter 11 Case, located at Debtors' claims agent's website at https://www.kccllc.net/invivo a notice that contains information about the Stalking Horse Bidder, the Stalking Horse Bid, attaches the proposed Stalking Horse Agreement, and describes any Stalking Horse Bid Protections proposed to be afforded to the Stalking Horse Bidder (as defined herein) (the "Notice of Stalking Horse Bidder").

Stalking Horse Bid Protections. The Debtors, in consultation with any Committee, may (i) establish initial overbid minimum and subsequent bidding increment requirements; (ii) offer each Stalking Horse Bidder a break-up fee and/or expense reimbursement in an amount agreed to by the Debtors (a "Termination Payment"); (iii) provide that, if the Stalking Horse Bidder bids on certain assets at the Auction, the Stalking Horse Bidder will be entitled to a credit in the amount of its Termination Payment against the increased purchase price for the assets; and (iv) provide other appropriate and customary protections to a Stalking Horse Bidder (the Termination Payment and the other bid protection described in this paragraph collectively are referred to as the "Stalking Horse Bid Protections").

Objections to Designation of Stalking Horse Bidders. Any objections (each, a "Stalking Horse Objection") to the designation of a Stalking Horse Bidder, including any Stalking Horse Bid Protections pursuant to the terms and provisions of a Stalking Horse Agreement, must (i) be in writing; (ii) state the name and address of the objecting party and the amount and nature of the Claim or Interest of such party; (iii) state with particularity the basis and nature of any objection; (iv) conform to the Bankruptcy Rules and the Local Rules; and (v) be served upon the Notice Parties³ within five (5) calendar days after the filing of the relevant Notice of Stalking Horse Bidder. If a timely Stalking Horse Objection is filed and served in accordance with the preceding paragraph, the proposed Stalking Horse Bid Protections will not be deemed approved until either the Stalking Horse Objection is resolved by agreement of the objecting party and the Debtors or by order of the Court. If no timely Stalking Horse Objection is filed and served with respect to an applicable Stalking Horse Agreement in accordance with the Bid Procedures, the Stalking Horse Bid Protections shall be deemed approved without further order of the Court upon the expiration of the objection deadline.

For all purposes under the Bid Procedures, any Stalking Horse Bidder approved as such pursuant to these Bid Procedures and the Bid Procedures Order shall be considered a Qualified Bidder, and the applicable Stalking Horse Bid shall be considered a Qualified Bid. In the event that the applicable Stalking Horse Bid is the only Qualified Bid received by the Debtors in respect of the applicable assets by the Bid Deadline, the Debtors may cancel the Auction.

Bid Deadline

The submission of a bid by the Bid Deadline shall constitute a binding and irrevocable offer to acquire the assets specified in such bid. Any party that does not submit a bid by the Bid Deadline will not be allowed to (i) submit any offer after the Bid Deadline or (ii) participate in any Auction. Form and Content of Qualified Bid

A bid is a signed document from a Potential Bidder received by the Bid Deadline that identifies the purchaser by its legal name and any other party that will be participating in connection with the bid, and includes the material terms of the offer to purchase a portion of or substantially all of the Debtors' assets (a "Bid"). To constitute a "Qualified Bid" a Bid must include, at a minimum, the following:

- i. <u>Acquired Assets</u>. Each Bid must clearly identify, in writing and as applicable, the particular assets the Potential Bidder seeks to acquire from the Debtors, including any contracts and leases of the Debtors that would be assumed and assigned in connection with a proposed Sale Transaction.⁴ For the avoidance of doubt, a Qualified Bid may include a Bid for less than all or substantially all of the Debtors' assets.
- ii. Purchase Price; Form of Consideration; Cash Requirements; Assumed Liabilities. Each Bid must clearly set forth, as applicable:
 - (A) <u>Purchase Price</u>. Each Bid must clearly identify the purchase price to be paid (the "<u>Purchase Price</u>"), and whether the Bid is based on an all-cash

- offer or consists of certain non-cash components, including, without limitation and/or the assumption of liabilities;
- (B) <u>Cash Requirements</u>. Each Bid must provide sufficient cash consideration for the payment of any applicable Termination Payment in cash in full;
- (C) <u>Assumed Liabilities</u>. Each Bid must clearly identify, in writing and as applicable, the particular liabilities, if any, including executory contracts, the Bidder seeks to assume. For the avoidance of doubt, a Qualified Bid may include a bid for less than all or substantially all of the Debtors' liabilities; and
- iii. <u>Proposed APA</u>. Each Bid must include an executed asset purchase agreement (the "<u>Proposed APA</u>") for the assets included in such Bid, together with a redline comparing the Proposed APA to the form APA attached hereto as <u>Exhibit A</u>.
- iv. <u>Unconditional Offer</u>. A statement that the Bid is formal, binding, and unconditional, is not subject to any further due diligence or financing contingency, and is irrevocable until the Debtors notify the Potential Bidder that such Bid is not a Successful Bid or a Back-Up Bid, or until the first business day after the close of a Sale Transaction.
- Proof of Financial Ability to Perform. Each Bid must contain such financial and v. other information that allows the Debtors to make a reasonable determination as to the Potential Bidder's financial and other capabilities to consummate a Sale Transaction including, without limitation, such financial and other information setting forth adequate assurance of future performance in satisfaction of the requirements under section 365(f)(2)(B) of the Bankruptcy Code, and the Potential Bidder's willingness to perform under any contracts that are assumed and assigned to such party. Without limiting the foregoing, such information must include current financial statements or similar financial information certified to be true and correct as of the date thereof, proof of financing commitments if needed to consummate the transaction (not subject to, in the Debtors' discretion, any unreasonable conditions), contact information for verification of such information, including any financing sources, and any other information reasonably requested by the Debtors necessary to demonstrate that such Potential Bidder has the ability to consummate a Sale Transaction in a timely manner.
- vi. <u>Designation of Contracts and Leases</u>. Each Bid must identify with particularity each and every executory contract and unexpired lease, the assumption and assignment of which is a condition to closing a Sale Transaction; ⁵ **provided**, **however**, that the Bid may allow for the Potential Bidder to remove executory contracts and unexpired leases from the list of contracts to be assumed and assigned any time prior to the closing of a Sale Transaction; **provided**, **further**, **however**, that to the extent the Debtors identify any additional executory contracts or

- unexpired leases after the Bid is submitted, the Bid may allow for the Potential Bidder to add such executory contracts and unexpired leases to the list of contracts to be assumed and assigned any time from and after the Bid is submitted.
- vii. <u>Required Approvals</u>. A statement or evidence (1) of the Potential Bidder's plan and ability to obtain all requisite governmental, regulatory, or other third-party approvals; and (2) that the Bid is reasonably likely to be consummated, if selected as the Successful Bid, within a time frame required by the Bid Procedures Order and otherwise acceptable to the Debtors.
- viii. <u>Authorization</u>. Each Bid must include evidence of corporate authorization and approval from the Potential Bidder's board of directors (or comparable governing body) with respect to the submission, execution, and delivery of a Bid, participation in the Auction, and closing of the transactions contemplated by the Potential Bidder's Proposed APA in accordance with the terms of the Bid and these Bid Procedures.
- ix. No Entitlement to Expense Reimbursement or Other Amounts. With the exception of any Stalking Horse Bid, expressly state that the Bid does not entitle the Potential Bidder to any break-up fee, termination fee, expense reimbursement or similar type of payment or reimbursement, and a waiver of any substantial contribution administrative expense claims under section 503(b) of the Bankruptcy Code related to the bidding process.
- x. <u>Joint Bids</u>. The Debtors may approve joint Bids in their reasonable discretion on a case-by-case basis.
- xi. <u>Representations and Warranties</u>. Each Bid must include the following representations and warranties:
 - (A) a statement that the Potential Bidder has had an opportunity to conduct any and all due diligence regarding the applicable assets prior to submitting its Bid;
 - (B) a statement that the Potential Bidder has relied solely upon its own independent review, investigation, and/or inspection of any relevant documents and the assets in making its Bid and did not rely on any written or oral statements, representations, promises, warranties, or guaranties whatsoever, whether express or implied, by operation of law or otherwise, regarding the assets or the completeness of any information provided in connection therewith, except as expressly stated in the representations and warranties contained in the Potential Bidder's Proposed APA ultimately accepted and executed by the Debtors;
 - (C) a statement that the Potential Bidder agrees to serve as Back-Up Bidder, if its Bid is selected as the next or highest or next best bid after the Successful Bid with respect to the applicable assets;

- (D) a statement that the Potential Bidder has not engaged in any collusion with respect to the submission of its Bid; and
- (E) a statement that the Potential Bidder agrees to be bound by the terms of the Bid Procedures.
- xii. A Potential Bidder must also accompany its Bid with:
 - (A) a cash deposit in the amount of ten percent (10%) of the Purchase Price (a "Good Faith Deposit");
 - (B) the contact information of the specific person(s) whom the Debtors or their advisors should contact in the event that the Debtors have any questions or wishes to discuss the Bid submitted by the Potential Bidder;
 - (C) a covenant to cooperate with the Debtors to provide pertinent factual information regarding the Potential Bidder's operations reasonably required to analyze issues arising with respect to any applicable regulatory requirements; and
 - (D) if the value of a Bid includes additional non-cash components, a detailed analysis of the value of any additional non-cash component of the Bid and backup documentation to support such value.

Good Faith Deposit

A Good Faith Deposit must be deposited, prior to the Bid Deadline, with an escrow agent selected by the Debtors (the "Escrow Agent") pursuant to an escrow agreement to be provided by the Debtors. To the extent a Qualified Bid is modified before, during, or after the Auction, the Debtors reserve the right to require that such Qualified Bidder adjust its Good Faith Deposit so that it equals ten percent (10%) of the Purchase Price. If a Qualified Bidder is required to adjust its Good Faith Deposit, its status as a Qualified Bidder shall be suspended pending satisfaction of such adjustment.

Review of Bids; Designation of Qualified Bids

The Debtors, in consultation with the Committee, if any, will evaluate Bids that are timely submitted and may engage in negotiations with Potential Bidders who submitted Bids as the Debtors deem appropriate in the exercise of their business judgment, based upon the Debtors' evaluation of the content of each Bid.

A Bid received for assets that is determined by the Debtors (in consultation with the Committee) to meet the requirements set forth herein will be considered a "Qualified Bid" and any bidder that submits a Qualified Bid (including any Stalking Horse Bid) will be considered a "Qualified Bidder."

By no later than April 1, 2024 (the "Qualified Bid Deadline"), the Debtors shall determine, in their reasonable judgment (after consultation with the Committee, if any) which of the Bids

received by the Bid Deadline qualify as a Qualified Bid. The Debtors shall notify each Bidder who submits a Qualified Bid of its status as a Qualified Bidder by the Qualified Bid Deadline.

In evaluating the Bids, the Debtors may take into consideration the following non-binding factors:

- 1. the amount of the purchase price and/or other non-cash consideration, as applicable, set forth in the Bid;
- 2. the assets included in or excluded from the Bid, including any executory contracts or leases proposed to be assumed;
- 3. the value to be provided to the Debtors under the Bid, including the net economic effect upon the Debtors' estates, taking into account any Stalking Horse Bidder's rights to any Termination Payment;
- 4. any benefit to the Debtors' bankruptcy estates from any assumption of liabilities or waiver of liabilities;
- 5. the transaction structure and execution risk, including conditions to, timing of, and certainty of closing; termination provisions; availability of financing and financial wherewithal to meet all commitments; and required governmental or other approvals;
- 6. the impact on employees and employee claims against the Debtors;
- 7. the impact on trade creditors; and
- 8. any other factor the Debtors may reasonably deem relevant consistent with their fiduciary duties.

The Debtors reserve the right to work with any Potential Bidder in advance of the Auction to cure any deficiencies in a Bid that is not initially deemed a Qualified Bid. The Debtors may amend or waive the conditions precedent to being a Qualified Bidder at any time, in their reasonable business judgment and in a manner consistent with their fiduciary duties and applicable law (as reasonably determined in good faith by the Debtors in consultation with their legal counsel).

The Debtors may accept a single Bid or multiple partial Bids for non-overlapping assets such that, if taken together, such multiple partial bids would otherwise meet the standards for a single Qualified Bid as to any assets or combinations of assets that the Debtors determine to auction (in which event those multiple bidders shall be treated as a single Qualified Bidder for purposes of the Auction).

Without the written consent of the Debtors, a Qualified Bidder may not modify, amend, or withdraw its Qualified Bid, except for proposed amendments to increase the Purchase Price or otherwise improve the terms of the Qualified Bid for the Debtors during the period that such Qualified Bid remains binding as specified herein; provided that, any Qualified Bid may be improved at the Auction as set forth in these Bid Procedures.

The Debtors shall make a determination regarding the following:

(A) the assets and/or any combination of assets to be auctioned by the Debtors; and

(B) which Bids have been determined to be Qualified Bids and the applicable assets relating to such Qualified Bids.

Failure to Receive Qualified Bids Far Substantially Similar Assets

If no Qualified Bid (other than the applicable Stalking Horse Bid, if any) is received by the Qualified Bid Deadline, the Debtors will not conduct the Auction, and shall file a notice with the Court indicating that no Auction will be held. The Debtors shall also publish such notice on the website of its claims and noticing agent, https://www.kccllc.net/invivo.

Auction Procedures

If the Debtors receive two or more Qualified Bids for substantially the same assets, the Debtors may, in their business judgment, conduct the Auction in person or by remote audio and/or video link on April 3, 2024, beginning at 10:00 a.m. (ET) at the offices of Landis Rath & Cobb LLP, 919 N. Market Street, Wilmington, DE 19801. Only a Qualified Bidder will be eligible to participate at the Auction, subject to such limitations as the Debtors may impose in good faith. In addition, professionals and/or other representatives of the Debtors, Committee, and any creditors or equity holders of the Debtors shall be permitted to attend and observe the Auction. Each Qualified Bidder shall be required to confirm, both before and after the Auction, that it has not engaged in any collusion with respect to the submission of any bid, the bidding, or the Auction.

The Debtors, in consultation with the Committee, if any, may adopt rules for the Auction at any time that the Debtors reasonably determine to be appropriate to promote a value-maximizing auction. Any rules developed by the Debtors will provide that all bids in the Auction will be made and received on an open basis, and all other bidders participating in the Auction will be entitled to be present for all bidding with the understanding that the true identity of each bidder placing a bid at the Auction will be fully disclosed to all other bidders participating in the Auction and that all material terms of a bid submitted in response to any successive bids made at the Auction will be disclosed to all other bidders. Each Qualified Bidder will be permitted what the Debtors reasonably determine to be an appropriate amount of time to respond to the previous bid at the Auction. The Auction will be conducted openly and shall be transcribed or recorded.

The Debtors may, in their discretion and in consultation with the Committee, if any, identify the highest or otherwise best Qualified Bid as the successful bid (a "Successful Bid" and the bidder submitting such bid, a "Successful Bidder"). The Debtors may also identify a Qualified Bidder that submitted the next highest or otherwise best Qualified Bid as a back-up bid (a "Back-Up Bid" and the bidder submitting such bid, a "Backup Bidder"). A Back-Up Bid shall remain open and irrevocable until the earliest to occur of (i) consummation of a Sale Transaction with the Successful Bidder and (ii) the release of such Back-Up Bid by the Debtors in writing (such date, the "Back-Up Bid Expiration Date"). If a Sale Transaction with a Successful Bidder is terminated prior to the Back-Up Bid Expiration Date, the Back-Up Bid as if it were a Successful Bidder and shall be obligated to consummate the Back-Up Bid as if it were a Successful Bid. Provided, however, that the Debtors are not required to accept any bid or designate a Successful Bidder or Back-Up Bidder.

Within one day after the Auction, a Successful Bidder shall submit to the Debtors fully executed documentation memorializing the terms of a Successful Bid. A Successful Bid may not be assigned to any party without the consent of the Debtors.

At any time before entry of an order approving an applicable Sale Transaction envisioned by a Qualified Bid, the Debtors reserve the right to and may reject such Qualified Bid if such Qualified Bid, in the Debtors' judgment (after consultation with the Committee, if any), is: (i) inadequate or insufficient; (ii) not in conformity with the requirements of the Bankruptcy Code, these Bid Procedures, or the terms and conditions of the applicable Sale Transaction; or (iii) contrary to the best interests of the Debtors and their estates.

Post-Auction Process

Within one day after the conclusion of the Auction, or as soon as reasonably practicable thereafter, the Debtors shall file with the Court a notice of a Successful Bid, Successful Bidder, Back-Up Bid, and Back-Up Bidder. Unless otherwise required pursuant to the Debtors' fiduciary duties, the Debtors shall not consider any bids submitted after the conclusion of the Auction.

Within seven (7) days after the Auction, the Debtors shall direct the Escrow Agent to return the deposit of any bidder, who is not declared a Successful Bidder or Back-Up Bidder. Within five (5) days after the Back-Up Bid Expiration Date, the Debtors shall direct the Escrow Agent to return the deposit of a Back-Up Bidder. Upon the authorized return of any such deposit, the bid of such Potential Bidder, Qualified Bidder or Back-Up Bidder, as applicable, shall be deemed revoked and no longer enforceable.

A Successful Bidder's deposit shall be applied against the cash portion of the purchase price of such bidder's Successful Bid upon the consummation of a Sale Transaction.

In addition to the foregoing, the deposit of a Qualified Bidder will be forfeited to the Debtors if (i) the Qualified Bidder attempts to modify, amend, or withdraw its Qualified Bid, except as permitted herein, during the time the Qualified Bid remains binding and irrevocable or (ii) the Qualified Bidder is selected as a Successful Bidder or Back-Up Bidder and refuses or fails to enter into the required definitive documentation or to consummate a Sale Transaction according to these Bid Procedures.

Notices Regarding Assumption and Assignment

The Debtors shall provide all notices regarding the proposed assumption and assignment of contracts and leases in accordance with the Assumption and Assignment Procedures included in the Bid Procedures Order.

Sale Hearing

If the Debtors elect to proceed with a Sale Transaction, the Debtors will seek the entry of an order authorizing and approving the Sale Transaction at a hearing before the Court on April 5, 2024, or at a date otherwise designated by the Court (the "Sale Hearing"). The Debtors, in the exercise of their business judgment, may adjourn the Sale Hearing without notice or with limited and shortened notice to parties, including by (i) an announcement of such adjournment at the Sale

Hearing or at the Auction or (ii) the filing of a notice of adjournment with the Court prior to the commencement of the Sale Hearing.

Objections to a Sale Transaction, including any objection to the sale of the Debtors' assets free and clear of liens, claims, encumbrances, and other interests pursuant to section 363(f) of the Bankruptcy Code (each, a "Sale Objection"), shall (i) be in writing; (ii) state the name and address of the objecting party and the amount and nature of the Claim or Interest of such party; (iii) state with particularity the basis and nature of any objection, and provide proposed language that, if accepted and incorporated by the Debtors, would obviate such objection; (iv) conform to the Bankruptcy Rules and the Local Rules; (v) be filed with the Court; and (vi) be served upon the Notice Parties (as defined in the in the Bid Procedures Order) by March 29, 2024 at 4:00 p.m. (ET) (the "Sale Objection Deadline"); provided that, the Debtors may extend the Sale Objection Deadline, as the Debtors deem appropriate in the exercise of their reasonable business judgment. If a timely Sale Objection cannot otherwise be resolved by the parties, such objection shall be heard by the Court at the Sale Hearing.

A Successful Bidder shall appear at the Sale Hearing and be prepared to have a representative(s) testify in support of the Successful Bid and such Successful Bidder's ability to close in a timely manner and provide adequate assurance of its future performance under any and all executory contracts and unexpired leases to be assumed and/or assigned as part of the proposed transaction.

Any party who fails to file with the Court and serve on the Objection Notice Parties a Sale Objection by the Sale Objection Deadline may be forever barred from asserting, at the Sale Hearing or thereafter, any Sale Objection to the relief requested in the Motion with regard to a Successful Bidder, or to the consummation and performance of a Sale Transaction, contemplated by an asset purchase agreement between the Debtors and a Successful Bidder, including the transfer of assets to a Successful Bidder, free and clear of all liens, claims, encumbrances, and other interests pursuant to section 363(f) of the Bankruptcy Code. Failure to object shall constitute consent for the purposes of section 363(f)(2) of the Bankruptcy Code.

Consent to Jurisdiction and Authority as Condition to Bidding

All bidders that participate in the bidding process shall be deemed to have (i) consented to the core jurisdiction of the Court to enter any order or orders, which shall be binding in all respects, in any way related to these Bid Procedures, the bid process, the Auction, the Sale Hearing, or the construction and enforcement of any agreement or any other document relating to an applicable Sale Transaction; (ii) waived any right to a jury trial in connection with any disputes relating to these Bid Procedures, the bid process, the Auction, the Sale Hearing, or the construction and enforcement of any agreement or any other document relating to a Sale Transaction; and (iii) consented to the entry of a final order or judgment in any way related to these Bid Procedures, the bid process, the Auction, the Sale Hearing, or the construction and enforcement of any agreement or any other document relating to an applicable Sale Transaction if it is determined that the Court would lack Article III jurisdiction to enter such a final order or judgment absent the consent of the parties.

Reservation of Rights

The Debtors reserve the right to, in their reasonable business judgment, in a manner consistent with their fiduciary duties and applicable law to modify these Bid Procedures; waive terms and conditions set forth herein with respect to all Potential Bidders; extend the deadlines set forth herein; announce at the Auction modified or additional procedures for conducting the Auction; alter the assumptions set forth herein; and provide reasonable accommodations to any Stalking Horse Bidder with respect to such terms, conditions, and deadlines of the bidding and Auction process to promote further bids on any assets, in each case, to the extent not materially inconsistent with these Bid Procedures and the Bid Procedures Order. The Debtors shall not be obligated to consummate or pursue any transaction with respect to any asset.

ASSET PURCHASE AGREEMENT

This ASSET PURCHASE AGREEMENT (this "<u>Agreement</u>"), dated as of [●], 2024, is made and entered into by and among [PURCHASER], a [jurisdiction of organization] [type of entity] ("<u>Purchaser</u>"), and **INVIVO THERAPEUTICS HOLDINGS CORP.**, a Nevada corporation ("<u>Holdings</u>"), and **INVIVO THERAPEUTICS CORPORATION**, a Delaware corporation ("<u>InVivo</u>" and, together with Holdings, "<u>Seller</u>"). Certain capitalized terms used herein are defined in Article I.

RECITALS

WHEREAS, Seller is a research and research and clinical-stage biomaterials and biotechnology company with a focus on the development of its investigational Neuro-Spinal Scaffold implant (the "NSS Implant") for the treatment of spinal cord injuries (the "Business");

WHEREAS, Seller commenced a case (the "<u>Chapter 11 Case</u>") under chapter 11 of title 11 of the United States Code, 11 U.S.C. § 101 <u>et seq</u>. (the "<u>Bankruptcy Code</u>"), in the United States Bankruptcy Court for the District of Delaware (the "<u>Court</u>");

WHEREAS, Purchaser desires to acquire certain assets of Seller identified herein, and Seller desires to sell, convey, assign, and transfer to Purchaser such assets, pursuant to the terms and conditions of this Agreement;

WHEREAS, it is intended that the Acquired Assets (defined below) will be sold and purchased pursuant to the terms of this Agreement in a sale authorized by the Court pursuant to section 363 of the Bankruptcy Code; and

WHEREAS, in connection with such a sale, it is intended that the Court shall approve the assumption and assignment of certain Executory Contracts (defined below) under section 365 of the Bankruptcy Code.

NOW, THEREFORE, in consideration of the foregoing and the mutual representations, warranties, covenants and agreements set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Purchaser and Seller hereby agree as follows:

ARTICLE I.

DEFINITIONS AND EFFECTIVENESS

- 1.1 <u>Certain Definitions</u>. For purposes of this Agreement, the following terms used in this Agreement shall have the respective meanings assigned to them below:
- (a) "Accounts Receivable" means (i) any and all accounts receivable, trade accounts and other amounts (including overdue accounts receivable, refunds, rebates, and other credits) owed to Seller relating to, or arising in connection with the operation and conduct of, the Business prior to the Closing and any other similar rights of Seller to payment from third parties arising prior to the Closing and the full benefit of all security for such accounts or rights to

payment; (ii) all other accounts or notes receivable of Seller as of the Closing and the full benefit of all security for such accounts or notes receivable; and (iii) any and all claims, remedies or other rights relating to any of the foregoing, together with any interest or unpaid financing charges accrued thereon, in each case that have not been satisfied or discharged prior to the close of business on the day immediately preceding the Closing or have not been written off or sent to collection prior to the close of business on the day immediately preceding the Closing (it being understood that the receipt of a check prior to the close of business on the day immediately preceding the Closing Date shall constitute satisfaction or discharge of the applicable account or note receivable to the extent of the payment represented thereby).

- (b) "<u>Acquired Assets</u>" means the assets of Seller related to the Program, as set forth on <u>Exhibit A</u> hereto.
- (c) "<u>Acquired Avoidance Actions</u>" means any and all Avoidance Actions against any vendor, customer, or other counterparty of the Business, including without limitation the Persons listed on <u>Annex A-[•]</u> to <u>Exhibit A</u>.
 - (d) "<u>Acquired Claims</u>" [RESERVED].¹
- (e) "<u>Affiliate</u>" means, with respect to any Person, any other Person that, directly or indirectly through one or more intermediaries, controls, or is controlled by, or is under common control with, such Person, and the term "<u>control</u>" (including the terms "controlled by" and "under common control with") means the possession, directly or indirectly, of the power to direct or cause the direction of the management and policies of such Person, whether through ownership of voting securities, by contract or otherwise.
- (f) "<u>Alternative Transaction</u>" means a sale, transfer or other disposition of all or any substantial portion of the Acquired Assets to any Person or Persons other than Purchaser, in any transaction or series of transactions.
- (g) "<u>Assumed Executory Contracts</u>" means the Executory Contracts to be assumed and assigned to Purchaser pursuant to section 365 of the Bankruptcy Code in accordance with the Bidding Procedures, as set forth on <u>Exhibit B</u> hereto.
- (h) "<u>Assumed Liabilities</u>" means only those liabilities expressly set forth on <u>Exhibit C</u> hereto.²
- (i) "<u>Auction</u>" shall have the meaning set forth in the Bidding Procedures.
- (j) "<u>Avoidance Action</u>" means any and all claims, rights and causes of action of Seller arising under chapter 5 of the Bankruptcy Code or similar federal, state or local laws.

¹ NTD: Treatment of Acquired Claims to be proposed by Purchaser.

² NTD: Seller would expect any Purchaser to assume royalty obligations in respect of the Specified Licenses.

- (k) "<u>Backup Bidder</u>" shall have the meaning set forth in the Bidding Procedures.
- (l) "<u>Bankruptcy Matters</u>" means (a) the amount, extent, or type of Cash and Cash Equivalents of Seller or any other Excluded Assets, or any Excluded Liabilities; (b) any failure, in and of itself, of Seller to meet any projections, budgets, plans or forecasts of revenues, earnings or other financial performance measures or operating statistics filed with the Court; or (c) the announcement, commencement, or continuation of the Chapter 11 Cases or any action approved by the Court in the Chapter 11 Case.

ARTICLE II.

ACQUISITION AND TRANSFER OF ASSETS; ASSUMPTION OF LIABILITIES

2.1 <u>Transfer of Assets</u>. Subject to approval of the Court, and upon the terms and subject to the conditions and provisions contained herein, at the Closing, Seller shall sell, convey, transfer, assign and deliver to Purchaser, and Purchaser shall acquire and accept from Seller, all of Seller's right, title, and interest in the Acquired Assets, free and clear of all Encumbrances, subject to Section 2.3 below. Notwithstanding anything to the contrary contained in this Agreement, Purchaser may, by notice to Seller, at any time on or before the Closing Date, in its sole discretion, alter or amend Exhibit A to this Agreement by removing an Acquired Asset.

- 2.2 <u>Excluded Assets</u>. Notwithstanding anything to the contrary in this Agreement, the Acquired Assets shall not include, and Seller shall retain, all of its rights, title and interest in and to, and shall not sell, convey, transfer, assign or deliver to Purchaser, any of the Excluded Assets.
- 2.3 <u>Assumed Liabilities</u>. At the Closing, Purchaser shall assume and have sole responsibility for the Assumed Liabilities.
- 2.4 <u>Excluded Liabilities</u>. For the avoidance of doubt, notwithstanding any other terms, provisions and conditions of this Agreement, Purchaser shall not assume, or otherwise be responsible or liable for, the Excluded Liabilities.
- 2.5 Assumed Executory Contracts. To the maximum extent permitted by the Bankruptcy Code and in accordance with the Bidding Procedures, each Assumed Executory Contract shall be assumed and assigned to Purchaser pursuant to section 365 of the Bankruptcy Code as of the later of: (a) for any Assumed Executory Contract listed on the Initial Notice of Proposed Assumed Executory Contracts, (1) if no objection is filed by the Closing Date, the Closing Date, or (2) if an objection is filed by the Closing Date, the date such assumption and assignment is approved by an Order of the Court, and (b) for any Assumed Executory Contract listed on a Supplemental Notice of Proposed Assumed Executory Contracts, (1) if no objection is filed by the date specified in such Supplemental Notice of Proposed Assumed Executory Contracts, such date, or (2) if an objection is filed by the date specified in such Supplemental Notice of Proposed Assumed Executory Contracts, the date such assumption and assignment is approved by an Order of the Court.
- (a) On or before the Closing Date, Purchaser may, at any time and for any reason, in its sole discretion, elect to remove any Executory Contract from Exhibit B, in which case such Executory Contract shall not be an Assumed Executory Contract, and, at the request of Purchaser on or prior to the Closing Date, Seller shall reject such Executory Contract as soon as practicable following the Closing Date. On or before the date on which the Sale Order is entered, Purchaser may, at any time and for any reason, in its sole discretion, elect to add to Exhibit B any Executory Contract not previously listed thereon, and such Executory Contract shall be an Assumed Executory Contract.
- (b) Purchaser shall be responsible and liable for, and shall pay, all Cure Costs.
- (c) Seller shall provide Purchaser with no less than five (5) Business Days' prior written notice of the filing of any motion to reject any Executory Contract not designated as an Assumed Executory Contract on Exhibit B as of the date of this Agreement.
- 2.6 <u>Waiver and Release of Acquired Avoidance Actions</u>. Without limiting the provisions of <u>Section 9.2</u> hereof, Purchaser shall be deemed to have waived and released all of the Acquired Avoidance Actions immediately following the Closing, and Purchaser shall not take any action to pursue or enforce any of the Acquired Avoidance Actions. Notwithstanding any provision of the contrary herein, Purchaser agrees that, in addition to Seller, any defendant in any Acquired Avoidance Action is a third-party beneficiary of this section and shall be entitled to rely on and enforce this section.

2.7 <u>Liens Attach to Sale Proceeds</u>. Any liens on the Acquired Assets existing as of the Closing Date will attach to the proceeds from the sale of the Acquired Assets according to such liens' relative priorities.

ARTICLE III.

CONSIDERATION

- 3.1 <u>Consideration</u>. The aggregate consideration (collectively, the "<u>Purchase Price</u>") to be paid for the acquisition of the Acquired Assets shall consist of the following, which shall be payable in accordance with the terms and conditions set forth in this <u>Article III</u> and <u>Article IV</u>: (i) the Cash Purchase Price; *plus* (ii) assumption of the Assumed Liabilities set forth on <u>Exhibit C</u>; *plus* (iii) any Cure Costs.
- 3.2 <u>Payment of Purchase Price at Closing</u>. The Purchase Price as described in <u>Section 3.1</u> shall be satisfied at the Closing, subject to the terms and conditions contained in this <u>Article III</u> and <u>Article IV</u>.
- 3.3 <u>Assumed Liabilities</u>. Purchaser shall assume the Assumed Liabilities pursuant to the assignment and assumption agreement substantially in the form attached hereto as <u>Exhibit F</u> (the "<u>Assignment and Assumption Agreement</u>").
- 3.4 <u>Deposit</u>. Purchaser has provided the Deposit in good faith to the Deposit Escrow Agent to be held in trust in a non-interest-bearing account pursuant to the terms and conditions of the Deposit Escrow Agreement. If the Closing occurs, the Deposit shall be paid to Seller and applied against the Cash Purchase Price at the Closing. If the Closing does not occur, then the Deposit shall be disbursed as follows: (i) in the event of a termination of this Agreement by Seller pursuant to <u>Section 4.6(n)</u>, Seller shall be entitled to retain the Deposit as liquidated damages; (ii) in the event of a termination of this Agreement for any reason other than by Seller pursuant to <u>Section 4.6(n)</u>, the Deposit shall be returned to Purchaser; or (iii) in the event of a termination of this Agreement and the Deposit has not been disbursed in accordance with clauses (i) or (ii) of this <u>Section 3.4</u>, then the Deposit shall be disbursed as any court of competent jurisdiction may direct.
- 3.5 <u>Allocation of Consideration</u>. Within thirty (30) calendar days after the Closing Date, Purchaser shall deliver to Seller an allocation of the Purchase Price among the Acquired Assets (the "<u>Allocation</u>"). Such Allocation shall become part of this Agreement for all purposes. Seller and Purchaser agree to report, pursuant to section 1060 of the Internal Revenue Code of 1986 and the regulations promulgated thereunder, if and when required, the Allocation of the Purchase Price, as adjusted, in a manner entirely consistent with such Allocation in the preparation and filing of all Tax Returns (including IRS form 8594). Neither Seller nor Purchaser shall take any action that would call into question the bona fide nature of such Allocation; and neither party shall take any position for Tax purposes which is inconsistent with such Allocation, unless required to do so under applicable law. Notwithstanding the foregoing, the Allocation shall not be binding upon any person or entity that is not a party to this Agreement.

ARTICLE IV.

CLOSING AND TERMINATION

- 4.1 <u>Closing</u>. Provided that the conditions to closing set forth herein have been satisfied or, if waiveable, have been waived in accordance herewith, the closing of the transactions contemplated herein (the "<u>Closing</u>") shall be held via e-mail or such other place as agreed to between Purchaser and Seller, within three (3) calendar days following the first day that all such conditions have been satisfied or, if waiveable, waived, on a Business Day mutually agreeable to Purchaser and Seller. The date on which the Closing occurs in accordance with the previous sentence is referred to as the "<u>Closing Date</u>". Unless otherwise agreed by the parties in writing, the Closing shall be deemed effective and all right, title and interest of Seller in the Acquired Assets to be acquired by Purchaser hereunder shall be considered to have passed to Purchaser and the assumption of all of the Assumed Liabilities shall be considered to have occurred as of 12:01 a.m. Eastern Time on the Closing Date.
- 4.2 <u>Conveyances at Closing</u>. At the Closing, Seller and Purchaser shall take the following actions:
- (a) Purchaser shall pay to or as directed by Seller, by wire transfer in immediately available funds, the Cash Purchase Price as set forth in <u>Section 3.1</u>, as adjusted (without duplication) pursuant to Section 3.2, Section 3.4, and Section 4.5;
- (b) Seller shall deliver or make available to Purchaser possession of the Acquired Assets;
- (c) Seller and Purchaser shall execute and deliver to one another a duly executed bill of sale with respect to the Acquired Assets, substantially in the form attached hereto as Exhibit E (the "Bill of Sale");
- (d) Seller shall provide to Purchaser all such other duly executed instruments as Purchaser may reasonably require to effectuate the transfer, assignment and conveyance of the Acquired Assets;
- (e) Seller and Purchaser shall execute and deliver to one another the Assignment and Assumption Agreement with respect to the Assumed Liabilities; and
- (f) Seller shall provide Purchaser with executed written consents, in form and substance reasonably satisfactory to Purchaser, from each licensor of a Specified License, consenting to the assignment to Purchaser of each corresponding Specified License, unless the Court or another court of competent jurisdiction has entered a Final Order that such consent is not required; provided, however, that any Cure Costs in respect of any Specified License shall be borne by Purchaser and all liabilities in respect of any Specified License shall be Assumed Liabilities.
- 4.3 <u>Additional Deliveries</u>. After the Closing Date, Seller shall deliver to Purchaser such other instruments and documents, and shall take such other actions, as shall be reasonably requested by Purchaser to vest in Purchaser all of Seller's right, title and interest in and to the Acquired Assets and otherwise to effectuate the transactions described herein.

- 4.4 <u>Transaction Expenses</u>. Except as expressly provided herein in respect of the Expense Reimbursement (to the extent due and owing), each party shall bear its own costs and expenses, including attorney, accountant and other consultant fees, in connection with the execution and negotiation of this Agreement and the Transaction Documents and the consummation of the transactions contemplated by this Agreement.
- Prorations. To the extent there are obligations in respect of the Acquired Assets 4.5 that arose during or relate to the period up to and including the Closing Date ("Pre-Closing Obligations") and obligations that arose during or relate to the period following the Closing Date, including any and all real or personal property tax obligations ("Post-Closing Obligations"), Purchaser and Seller shall allocate such obligations between themselves on a ratable basis that fairly reflects the portions (up to 100%) of such obligations that are Pre-Closing Obligations and that shall be paid by Seller, and the portions (up to 100%) of such obligations that are Post-Closing Obligations and that shall be paid by Purchaser. To the extent that any net amount is owing to Purchaser or Seller, as the case may be under this Section 4.5 as of the Closing, the Purchase Price shall be decreased or increased, as the case may be, to the extent such prorations are identified as of the Closing, and to the extent such prorations cannot or are not identified until after the Closing, then any net amount owing to Seller or Purchaser shall be paid by the party owing such amount. Any net amount owing to Purchaser under this Section 4.5, shall be an administrative expense of Seller's bankruptcy estate under section 503(b) and section 507(a)(2) of the Bankruptcy Code. Notwithstanding the foregoing, this Section 4.5 shall not apply to the items listed on Schedule 4.5, which items shall be paid by Seller and/or Purchaser as indicated thereon.
- 4.6 <u>Termination of Agreement</u>. This Agreement may be terminated at any time prior to the Closing as follows:
 - (a) by the mutual written consent of Seller and Purchaser;
- (b) by Purchaser or Seller, if the Petition Date has not occurred on or before [●], 2024.
- (c) by Purchaser or Seller, upon entry into an agreement to consummate (subject to Purchaser's obligation to serve as a Backup Bidder pursuant to Section 7.1(h)), or the consummation of, an Alternative Transaction, provided, however, that upon a termination pursuant to this Section 4.6(c), Seller shall perform its obligations under Section 4.8 and Section 7.2;
- (d) by Purchaser or Seller, if the Closing shall not have been consummated prior to [●], 2024 (the "Outside Date"); provided, that if the Closing shall not have occurred on or before the Outside Date due to a material breach of any representations, warranties, covenants or agreements contained in this Agreement by Purchaser or Seller, then Purchaser (if Purchaser is in breach) or Seller (if Seller is in breach), respectively, may not terminate this Agreement pursuant to this Section 4.6(d); provided further, that if Purchaser is selected as the Backup Bidder at the conclusion of the Auction, Purchaser shall not be permitted to terminate this Agreement until the earlier of (i) ninety (90) days after entry of the Sale Order if the Closing shall not have occurred by such date, and (ii) the date on which Seller consummates an Alternative Transaction;

- (e) by Purchaser, if the Auction has not been held on or before [●], 2024, unless Seller determines in accordance with the Bidding Procedures not to conduct any Auction;
- (f) by Purchaser or Seller, if there shall be any Law that makes consummation of the transactions contemplated hereby illegal or otherwise prohibited, or there shall be in effect a final non-appealable order of a Governmental Body of competent jurisdiction restraining, enjoining or otherwise prohibiting the consummation of the transactions contemplated hereby; it being agreed that the parties hereto shall promptly appeal any such adverse determination which is appealable (and pursue such appeal with reasonable diligence);
- (g) by Purchaser or Seller, if the Chapter 11 Cases are dismissed or converted to cases under chapter 7 of the Bankruptcy Code, or if a chapter 11 trustee or examiner with expanded powers is appointed, <u>provided</u>, <u>however</u>, that no party shall have such a termination right if it has sought, consented to, or otherwise supported such dismissal or conversion;
- (h) by Purchaser, if the Court enters an order granting stay relief to any third party with respect to any material portion of the Acquired Assets, if such stay relief allows such third party to exercise control over, or reduce the value to Purchaser of, the Acquired Assets;
 - (i) by Purchaser, if there occurs a Material Adverse Effect;
- (j) by Purchaser or Seller, if the Sale Order shall not have been entered on or before [●], 2024 (subject to Purchaser's obligation to serve as a Backup Bidder pursuant to Section 7.1(h));
- (k) by Purchaser, if the Court enters an Order denying any motion or other filing filed by Seller relating to the sale of the Acquired Assets hereunder;
- (l) by Purchaser or Seller, if the Bidding Procedures Order or Sale Order is stayed, reversed, vacated, modified or amended (except as modified or amended in any immaterial respect or with the consent of Purchaser, which consent may be withheld in its sole discretion for material modifications and amendments);
- (m) by Seller, if Purchaser fails to satisfy any of its material obligations at Closing;
- (n) by Purchaser, if the Auction is conducted and Purchaser is not named by Seller as the Successful Bidder or the Backup Bidder at the conclusion of the Auction; or
- (o) by Purchaser, if Seller is in breach of any of its material obligations hereunder and, to the extent such breach is reasonably capable of cure within such period, such breach has not been cured by Seller within fifteen (15) calendar days after written notification by Purchaser.
- 4.7 <u>Procedure Upon Termination</u>. In the event of a termination of this Agreement pursuant to <u>Section 4.6</u>, (a) written notice thereof shall be given promptly by the terminating party

to the other party hereto, specifying the provision hereof pursuant to which such termination is made, (b) this Agreement shall thereupon terminate and become void and of no further force and effect, and (c) the consummation of the transactions contemplated by this Agreement shall be abandoned without further action of the parties hereto. If this Agreement is terminated as provided herein, each party shall return all documents, work papers and other material of any other party relating to the transactions contemplated hereby, whether so obtained before or after the execution hereof, to the party furnishing the same.

4.8 <u>Effect of Termination</u>. In the event that this Agreement is validly terminated pursuant to <u>Section 4.6</u>, each of the parties shall be relieved of its duties and obligations arising under this Agreement effective as of the date of such termination and such termination shall be without Liability to Purchaser or Seller; <u>provided</u>, <u>however</u>, that <u>Section 4.6</u>, <u>Section 4.7</u>, <u>Section 7.2</u> (other than in the case of a termination Seller under <u>Section 4.6(n)</u>), and this <u>Section 4.8</u> shall survive any such termination and shall be enforceable hereunder. In no event shall any termination of this Agreement relieve any party hereto of any Liability for any willful breach of this Agreement by such party. Upon termination of this Agreement, (a) the Deposit shall be delivered to any applicable party as provided in <u>Section 3.4</u> and (b) Purchaser shall be entitled to the Stalking Horse Provisions to the extent set forth in <u>Section 7.2</u>.

ARTICLE V.

REPRESENTATIONS AND WARRANTIES OF SELLER

Seller represents and warrants to Purchaser that the statements contained in this <u>Article V</u> are true and correct as of the date of this Agreement, except as disclosed in the Seller SEC Reports filed or furnished prior to the date of this Agreement or in filings made by Seller in the Chapter 11 Cases prior to the date of this Agreement.

- 5.1 <u>Organization and Power</u>. Seller is a corporation duly organized, validly existing and in good standing under the Laws of the State of Nevada. Seller has all requisite corporate power and authority to own the Acquired Assets.
- 5.2 <u>Corporate Authorization</u>. Subject to entry of the Sale Order, Seller has full corporate power and authority to execute and deliver any and all Transaction Documents and to perform the obligations thereunder. Subject to entry of the Sale Order, the execution, delivery and performance of Seller of the Transaction Documents have been duly and validly authorized and no additional corporate authorization or consent is required in connection therewith.
- 5.3 <u>Binding Effect</u>. Subject to entry of the Sale Order, this Agreement has been duly executed and delivered by Seller. This Agreement, when executed and delivered by Purchaser, and the other Transaction Documents when executed and delivered, will, upon the entry of the Sale Order, constitute the valid and legally binding obligations of Seller, enforceable against Seller in accordance with their respective terms.
- 5.4 Ownership of Acquired Assets. Seller owns (or, in the case of Intellectual Property licensed by Seller from a Third Party, including Specified Licenses, has license rights to) all Acquired Assets and, subject to entry of the Sale Order, has the right to transfer all of its right,

title, and interest in the Acquired Assets to Purchaser, in each case, effective at Closing and free and clear of any Encumbrances.

- 5.5 <u>Taxes</u>. Except for matters that, individually or in the aggregate, are not reasonably likely to have a Material Adverse Effect:
- (a) Seller has filed all Tax Returns that it was required to file, and all such Tax Returns were correct and complete. Seller has paid (or caused to be paid) on a timely basis all Taxes due and owing by Seller, other than Taxes that are being contested in good faith through appropriate proceedings and for which the most recent financial statements contained in the Seller SEC Reports reflect an adequate reserve in accordance with GAAP.
- (b) As of the date of this Agreement, no examination or audit of any Tax Return of Seller by any Governmental Body is currently in progress or has been proposed in writing. There are no liens for Taxes on any of the assets or properties of Seller.
- (c) Seller does not have any liability for any Taxes of any Person (other than Seller) (i) under Treasury Regulation Section 1.1502-6 (or any similar provision of Tax law in any jurisdiction) or as a transferee or successor, or (ii) pursuant to any Tax sharing or Tax indemnification agreement or other similar agreement (other than pursuant to commercial agreements or arrangements that are not primarily related to Taxes).
- (d) Seller has not entered into any "listed transaction" within the meaning of Treasury Regulation Section 1.6011-4(b)(2).

5.6 Real Property.

- (a) Seller does not own any real property.
- (b) Other than general office space leased on a month-to-month basis, Seller does not lease, sublease, or license from any Third Party any real property material to the conduct of the Business as currently conducted.

5.7 <u>Intellectual Property</u>.

- (a) To Seller's Knowledge, Seller owns, licenses, sublicenses or otherwise possesses legally enforceable rights to use all Intellectual Property held by Seller for use in the conduct of the Business as currently conducted (in each case excluding generally commercially available, off-the-shelf software programs), except where the absence of which, individually or in the aggregate, is not reasonably likely to have a Material Adverse Effect, subject, in the case of the Specified Licenses, to the rights of the licensors in respect of the Specified Licenses.
- (b) To Seller's Knowledge, all issued Patents and registrations for Trademarks and Copyrights included in the Seller Owned Intellectual Property are subsisting and have not expired or been cancelled.

- (c) To Seller's Knowledge, the conduct of the Program as currently conducted, does not infringe, violate or constitute a misappropriation of any Intellectual Property of any Third Party, except for such infringements, violations and misappropriations that, individually or in the aggregate, are not reasonably likely to have a Material Adverse Effect. Between January 1, 2022 and the date of this Agreement, Seller has not received any written claim or notice from any Person (i) alleging any such infringement, violation or misappropriation or (ii) advising that such Person is challenging or threatening to challenge the ownership, use, validity or enforceability of any Seller Owned Intellectual Property, except, in each case in clauses (i) and (ii), for any such infringement, violation, misappropriation or challenge that is not reasonably likely to have a Material Adverse Effect.
- (d) To Seller's Knowledge, Seller has implemented commercially reasonable measures to maintain the confidentiality of the Seller Owned Intellectual Property of a nature that Seller intends to keep confidential.
- (e) To Seller's Knowledge, Seller is not in default under any Specified License in any manner that would allow the licensor under any Specified License to terminate such Specified License or otherwise limit or terminate the rights of Seller under such Specified License.
- (f) To Seller's Knowledge, no third party is infringing, violating or misappropriating any of the Seller Owned Intellectual Property, except for infringements, violations or misappropriations that, individually or in the aggregate, are not reasonably likely to have a Material Adverse Effect.
- 5.8 <u>Litigation</u>. As of the date of this Agreement, there is no action, suit, proceeding, claim, arbitration or investigation pending and of which Seller has been notified or, to Seller's Knowledge, threatened against Seller, in each case that, individually or in the aggregate, is reasonably likely to have a Material Adverse Effect. As of the date of this Agreement, there are no judgments, orders or decrees outstanding against Seller that, individually or in the aggregate, are reasonably likely to have a Material Adverse Effect.

5.9 Environmental Matters.

- (a) Except for matters that, individually or in the aggregate, are not reasonably likely to have a Material Adverse Effect: (i) Seller is not in violation of any Environmental Law; and (ii) Seller has all permits, licenses and other authorizations required under any Environmental Law and Seller is in compliance with such permits, licenses and other authorizations.
- (b) The only representations and warranties of Seller in this Agreement as to any environmental matters or any other obligation or liability with respect to Hazardous Substances or materials of environmental concern are those contained in this Section 5.10. Without limiting the generality of the foregoing, the representations and warranties contained in Sections 5.11 and 5.11 do not relate to environmental matters.
- 5.10 <u>Compliance With Laws</u>. Seller is, and since January 1, 2022 has been, in compliance with, and is not in violation of, any applicable statute, law or regulation with respect to the conduct of the Program, or the ownership or operation of its properties or assets,

except for failures to comply or violations that, individually or in the aggregate, are not reasonably likely to have a Material Adverse Effect.

5.11 Permits; Regulatory Matters.

- (a) Seller or its agents and representatives have all Permits required to conduct the Program as currently conducted, including all such Permits required by the FDA, and any other federal, state or foreign agencies or bodies with material regulatory authority over the Business (together with the FDA, the "Regulating Authorities"), except for such Permits the absence of which, individually or in the aggregate, are not reasonably likely to have a Material Adverse Effect (the "Seller Authorizations").
- (b) Except for matters that, individually or in the aggregate, are not reasonably likely to have a Material Adverse Effect, since January 1, 2022 or that have been disclosed in writing to Purchaser or in Seller's public filings with the SEC, Seller: (i) has not received any written notice or correspondence from any Regulating Authority alleging or asserting any noncompliance with any Seller Authorizations; and (ii) has not received written notice that any Regulating Authority has taken or is intending to take action to limit, suspend, modify or revoke any Seller Authorizations and, to Seller's Knowledge, there is no action or proceeding pending or threatened (including any prosecution, injunction, seizure, civil fine, suspension or recall), in each case alleging that such Regulating Authority is considering such action.
- 5.12 <u>Finders' Fees</u>. Except for the fees and expenses of SSG Capital Advisors, LLC ("<u>SSG</u>"), the fees and expenses of which will be paid by Seller, there is no investment banker, broker, finder or other intermediary who has been retained by or is authorized to act on behalf of Seller who might be entitled to any fee or commission in connection with the transactions contemplated by this Agreement.
- No Other Representations or Warranties. Except for the representations and warranties expressly contained herein, Seller makes no other express or implied representation or warranty. WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, THE ACQUIRED ASSETS ARE ASSIGNED, "AS IS," WITHOUT ANY WARRANTY OF ANY KIND, AND SELLER HEREBY EXPRESSLY DISCLAIMS, TO THE EXTENT PERMITTED BY APPLICABLE LAW, ANY AND ALL CONDITIONS OR WARRANTIES OF ANY KIND OR NATURE, WHETHER EXPRESS, IMPLIED OR STATUTORY, INCLUDING ANY WARRANTIES OF OR RELATED TO TITLE, NON-INFRINGEMENT, MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, VALIDITY OR ENFORCEABILITY.

ARTICLE VI.

REPRESENTATIONS AND WARRANTIES OF PURCHASER

Purchaser represents and warrants to Seller that the statements contained in this <u>Article VI</u> are true and correct as of the date of this Agreement.

- 6.1 <u>Organization and Power</u>. Purchaser is a [corporation] duly organized, validly existing and in good standing under the Laws of the State of [state of organization].
- 6.2 <u>Authorization</u>. Purchaser has full power and authority to execute and deliver the Transaction Documents and to perform its obligations thereunder. The execution, delivery and performance by Purchaser of the Transaction Documents have been duly and validly authorized and no additional authorization or consent is required in connection therewith.
- 6.3 <u>Binding Effect</u>. This Agreement has been duly executed and delivered by Purchaser. This Agreement, when executed and delivered by Seller, and the other Transaction Documents when executed and delivered, will constitute the valid and legally binding obligations of Purchaser, enforceable against Purchaser in accordance with their respective terms, subject to bankruptcy, insolvency, reorganization, moratorium and similar Laws of general applicability relating to or affecting creditors' rights and to general equity principles.
- 6.4 <u>Funding</u>. Purchaser has, without the need to obtain any Third Party debt or equity financing, sufficient and unencumbered funds to consummate the transactions contemplated by this Agreement and to pay the Purchase Price, and Purchaser otherwise has the resources and capabilities (financial and otherwise) to perform its obligations to consummate the transactions contemplated by this Agreement and such performance is not conditioned or contingent in any way upon the receipt of financing from any Person or the availability of funds to Purchaser.
- 6.5 <u>Adequate Assurances Regarding Assumed Executory Contracts</u>. As of the Closing, Purchaser will be capable of satisfying the conditions contained in sections 365(b)(1)(C) and 365(f) of the Bankruptcy Code with respect to the Assumed Executory Contracts, including without limitation payment of all Cure Costs.
- 6.6 <u>Finders' Fees</u>. There is no investment banker, broker, finder or other intermediary who has been retained by or is authorized to act on behalf of Purchaser or any Affiliate of Purchaser who might be entitled to any fee or commission in connection with the transactions contemplated by this Agreement, except for any fee or commission paid directly by Purchaser and not reducing the Purchase Price in any way.
- 6.7 <u>Good Faith Purchaser</u>. Purchaser (i) is a "good faith" purchaser, as such term is used in the Bankruptcy Code, and (ii) is entitled to the protections of section 363(m) of the Bankruptcy Code with respect to the transactions contemplated by this Agreement. Purchaser has negotiated and entered into this Agreement in compliance with the Bidding Procedures in compliance with section 363(n) of the Bankruptcy Code, and in good faith and without collusion or fraud of any kind.

- 6.8 <u>Purchaser Experience</u>. Purchaser is experienced and sophisticated with respect to transactions of the type contemplated by this Agreement. In consultation with experienced counsel and advisors of its choice, Purchaser has conducted its own independent review and analysis of the Acquired Assets, the Assumed Liabilities and the rights and obligations it is acquiring and assuming under the Transaction Documents. Purchaser acknowledges that it and its representatives have been permitted such access to the books and records, contracts and other properties related to the Acquired Assets as it required to complete its review..
- Non-Reliance on Seller Estimates, Projections, Forecasts, Forward-Looking Statements and Business Plans. In connection with the due diligence investigation of Seller by Purchaser and its Affiliates, Purchaser and its Affiliates, have received and may continue to receive after the date hereof from Seller and its Affiliates certain estimates, projections, forecasts and other forward-looking information, as well as certain business plan information, regarding Seller and its business and operations. Purchaser hereby acknowledges that there are uncertainties inherent in attempting to make such estimates, projections, forecasts and other forward-looking statements, as well as in such business plans, with which Purchaser is familiar, that Purchaser is taking full responsibility for making its own evaluation of the adequacy and accuracy of all estimates, projections, forecasts and other forward-looking information, as well as such business plans, so furnished to it (including the reasonableness of the assumptions underlying such estimates, projections, forecasts, forward-looking information or business plans), and that Purchaser will have no claim against Seller, any of its Affiliates, or any other Person, with respect thereto. Accordingly, Purchaser hereby acknowledges and agrees that none of Seller nor any of its Affiliates, nor any other Person, has made or is making any express or implied representation or warranty with respect to such estimates, projections, forecasts, forward-looking statements or business plans (including the reasonableness of the assumptions underlying such estimates, projections, forecasts, forwardlooking statements or business plans). Purchaser expressly disclaims that it is relying upon or has relied upon any representations or warranties or other statements or omissions that may have been made by Seller or its Affiliates or any other Person with respect to Seller other than the representations and warranties set forth in this Agreement. Purchaser expressly disclaims any obligation or duty by Seller or its Affiliates to make any disclosures of fact not required to be disclosed pursuant to the specific representations and warranties set forth in this Agreement.

ARTICLE VII.

CERTAIN COVENANTS

7.1 <u>Bankruptcy Sale Process</u>.

(a) Purchaser acknowledges that the Acquired Assets may be subject to competitive bidding and that the Bidding Procedures may be supplemented by other customary procedures consistent with the terms of this Agreement, <u>provided</u> that the Bidding Procedures may not be amended, modified, or supplemented in any respect except as provided for in the Bidding Procedures.

- (b) Seller will, as promptly as possible, but in all events in accordance with the Bidding Procedures, file and serve the Initial Notice of Proposed Assumed Executory Contracts, any Supplemental Notice of Proposed Assumed Executory Contracts, and the Final Sale Notice, together with the proposed Sale Order and a copy of the Transaction Documents (with any redactions Seller and Purchaser mutually deem appropriate in accordance with Bankruptcy Rule 9018 and the Bidding Procedures Order), and serve it upon the parties required to be served in accordance with the Bidding Procedures.
- (c) Seller will, subject to the provisions of this Agreement and the Bidding Procedures Order, in consultation with Purchaser, use its reasonable best efforts to (x) respond to and resolve all timely objections to the entry of the Sale Order and (y) obtain entry of the Sale Order on or before [•], 2024.
- (d) Purchaser will use its reasonable best efforts to assist in obtaining entry of the Sale Order, including furnishing or filing with the Court such affidavits or declarations as Seller may request for the purpose of obtaining entry of the Sale Order.
- (e) All motions and other filings by Seller, including any filings regarding notice procedures and all lists of Persons to receive notice, relating to the sale of the Acquired Assets hereunder shall be in form and substance reasonably satisfactory to Purchaser.
- (f) Purchaser shall not, without prior written consent of Seller, file, join in, or otherwise support or encourage in any manner whatsoever any motion or other filing relating to the sale of the Acquired Assets hereunder.
- (g) In the event that an appeal is taken or a stay pending appeal is requested with respect to the Sale Order, Seller shall promptly notify Purchaser of such appeal or stay request and shall promptly provide to Purchaser a copy of the related notice(s) or order(s). Seller and Purchaser shall use their reasonable best efforts to defend any such appeal or stay request.
- (h) <u>Backup Bidder.</u> Sellers and Purchaser agree that, in the event that Purchaser is not the Successful Bidder at the Auction, Purchaser shall act as the Backup Bidder as set forth in the a Bidding Procedures and Bidding Procedures Order, if so named at the Auction; provided that, Purchaser's obligation to act as the Backup Bidder shall terminate on the earlier of (i) ninety (90) days after entry of the Sale Order if the Closing shall not have occurred by such date, and (ii) the date on which Seller consummates an Alternative Transaction. If Purchaser is selected as the Backup Bidder at the conclusion of the Auction, (a) neither such selection itself nor the failure to select the Purchaser as the Successful Bidder shall give rise to a right of Purchaser to terminate this Agreement, and (b) this Agreement shall remain in full force and effect until terminated in accordance with the terms herein.

7.2 <u>Stalking Horse Provisions</u>.⁵

(a) To participate in the bidding process for all or any substantial portion of the Acquired Assets, a Person (other than Purchaser) must submit a bid, in accordance

with the Bidding Procedures, the cash portion of which exceeds the Cash Purchase Price for such assets by no less than the sum of the following: the Break-Up Fee, the maximum amount of the Expense Reimbursement, and $\{\bullet\}$ (such sum, the "Overbid Protection").

- (b) In the event Seller enters into an agreement to consummate or consummates an Alternative Transaction prior to the Outside Date, Seller shall pay Purchaser, in accordance with the Bidding Procedures and by wire transfer to an account designated by Purchaser on the closing date of such Alternative Transaction, an amount equal to \$[●] (the "Break-Up Fee").
- (c) In the event Seller enters into an agreement to consummate or consummates an Alternative Transaction prior to the Outside Date, Seller shall pay Purchaser, in accordance with the Bidding Procedures and by wire transfer to an account designated by Purchaser on the closing date of such Alternative Transaction, reimbursement of all reasonable, documented costs and expenses of Purchaser incurred in connection with Purchaser's efforts to negotiate and consummate the transactions contemplated by this Agreement (including, without limitation, the fees and expenses of counsel); <u>provided</u>, <u>however</u>, that such reimbursement shall be capped at \$[•] (the "Expense Reimbursement").
- (d) Purchaser shall be entitled to credit bid the amount of the Break-Up Fee and maximum Expense Reimbursement in accordance with section 363(k) of the Bankruptcy Code if Purchaser elects to submit higher bids in the Auction in accordance with the Bidding Procedures.
- (e) The Break-Up Fee and Expense Reimbursement shall be paid from any proceeds of an Alternative Transaction, otherwise payable to Seller, <u>provided</u> that if such amounts are not paid from such proceeds, Seller shall remain liable for such amounts.
- (f) The Break-Up Fee and Expense Reimbursement (to the extent due and owing) shall be a first-priority administrative expense of Seller's bankruptcy estate under sections 503(b) and 507(a)(2) of the Bankruptcy Code.
- (g) The obligation of Seller to pay, and the payment by Seller of, the Expense Reimbursement (to the extent due and owing), shall in no way limit or otherwise affect the rights of Purchaser to a return of the Deposit, including without limitation the rights of Purchaser under Section 3.4 of this Agreement.
- (h) Seller acknowledges and agrees that Purchaser would not have entered into this Agreement but for the provisions in this Section 7.2, and that the provisions of this Section 7.2 are integral to, and shall survive any termination of, this Agreement, other than a termination by Seller under Section 4.6(n).

7.3 Pre-Closing Operating Covenants of Seller.

(a) Until the earlier of Closing or the termination of this Agreement in accordance with Section 4.6, Section 4.7 and Section 4.8, except as expressly provided in this Agreement, or as required by Law, including in connection with the Chapter 11 Cases (it being understood that no provision of this Section 7.3 will require Seller to make any payment to any of

its creditors with respect to any amount owed to such creditors on the Petition Date or which would otherwise violate the Bankruptcy Code), without the consent of Purchaser, Seller shall continue to maintain the Acquired Assets and all books and records on a basis consistent with current practice, and shall continue to make all necessary or appropriate filings and payments with and to Governmental Bodies in connection with the Program in a timely manner, and maintain in effect all existing regulatory approvals required for the ongoing operation of the Program as presently conducted, it being understood that Seller has already taken steps prior to the date of this Agreement to wind down the Business, including suspension of the Program, and it being further understood that Seller shall not be required hereby to make any filing or take any other action with respect to SEC requirements.

- (b) Until the earlier of Closing or the termination of this Agreement in accordance with Section 4.6, Section 4.7 and Section 4.8, except as expressly provided in this Agreement, or as required by Law, subject to the limitations of the Bankruptcy Code and the Bankruptcy Rules, without the consent of Purchaser, Seller will not do any of the following, it being understood that Seller has already taken steps prior to the date of this Agreement to wind down the Business:
 - (i) sell or transfer or create any Encumbrance upon any of the Acquired Assets (other than in the ordinary course of the Business);
 - (ii) fail to pay any maintenance fees by the due date therefor with respect to any of the Acquired Assets, absent Purchaser's written authorization after good faith consideration, provided that Purchaser reimburse Seller for payment of the portion of such fees attributable to the post-Closing period;
 - (iii) reject, cancel, terminate, amend, modify, supplement or rescind any Executory Contract or any terms of any Executory Contract without the express written approval of Purchaser, which shall not be unreasonably withheld or delayed, except for the purpose of effecting any changes in applicable Law or implementing regulatory requirements;
 - (iv) incur any indebtedness for borrowed money.
 - (v) transfer, sell, assign, abandon, permit to lapse or grant any rights or modify any existing rights to the Acquired Assets, or enter into any settlement regarding the breach or infringement, misappropriation, dilution or other violation of, or challenge the title to, any such Acquired Assets; or
 - (vi) institute, settle or agree to settle or modify in any manner that is adverse to the Acquired Assets, any litigation, action or other Legal Proceeding before any court or Governmental Body relating to the Acquired Assets and that is or will be an Assumed Liability (<u>provided</u>, <u>however</u>, that nothing herein shall restrict or prevent Seller from instituting, prosecuting, or settling any claims it may have against Purchaser or its Affiliates arising out of or related to this Agreement).

7.4 Access to Information.

- Seller agrees that, until the earlier of Closing or the termination of this Agreement in accordance with Section 4.6, Section 4.7 and Section 4.8, Purchaser shall be entitled, through its Representatives, to have such reasonable access to and make such reasonable investigation and examination of the books and records, properties, businesses, assets, accountants, auditors, counsel and operations of Seller as Purchaser's Representatives may reasonably request, provided, however, that Seller shall not be obligated to provide information that it is not permitted to provide under applicable Law. Any such investigations and examinations shall be conducted during regular business hours upon reasonable advance notice and under reasonable circumstances, including Seller's right to have its Representatives accompany Purchaser and its Representatives at the time of any on-site inspection or examination and shall be subject to restrictions under applicable Law. Pursuant to this Section 7.4, Seller shall furnish to Purchaser and its Representatives such financial, operating and property related data and other information as such Persons reasonably request. Seller shall use commercially reasonable efforts to cause its Representatives to reasonably cooperate with Purchaser and Purchaser's Representatives in connection with such investigations and examinations, and Purchaser shall, and use its commercially reasonably efforts to cause its Representatives to, reasonably cooperate with Seller and its Representatives and shall use their reasonable efforts to minimize any disruption to the Business. Purchaser and its Representatives shall be permitted to contact, or engage in discussions or otherwise communicate with Seller's landlords, clients, suppliers and other Persons with which Seller has material commercial dealings, provided, that Purchaser must obtain the prior consent of Seller, which consent shall not be unreasonably withheld or delayed, to initiate such communications and give Seller the opportunity to be present therefor.
- (b) No information received pursuant to an investigation made under this Section 7.4 shall be deemed to (i) qualify, modify, amend or otherwise affect any representations, warranties, covenants or other agreements of Seller set forth in this Agreement or any certificate or other instrument delivered to Purchaser in connection with the transactions contemplated hereby, (ii) limit or restrict the remedies available to the parties under applicable Law arising out of a breach of this Agreement or otherwise available at Law or in equity, or (iii) limit or restrict the ability of either party to invoke or rely on the conditions to the obligations of the parties to consummate the transactions contemplated by this Agreement set forth in Article VIII.
- 7.5 <u>Reasonable Efforts; Further Assurances of Each Party.</u> Until the earlier of Closing or the termination of this Agreement in accordance with <u>Section 4.6</u>, <u>Section 4.7</u> and <u>Section 4.8</u>, in each case, subject to the limitations of the Bankruptcy Code and Bankruptcy Rules:
- (a) each party will use commercially reasonable efforts to take all actions and to do all things necessary, proper or advisable in order to consummate and make effective the transactions contemplated by this Agreement (including satisfaction, but not waiver, of the closing conditions set forth in <u>Article VIII)</u>; and
- (b) the parties will execute and deliver any documents, instruments or conveyances of any kind and take all other actions which may be reasonably necessary or advisable to carry out the intent of this Agreement and the transactions contemplated herein.

7.6 Regulatory Affairs. Until the earlier of Closing or the termination of this Agreement in accordance with Section 4.6, Section 4.7 and Section 4.8, Seller shall, to the fullest extent permitted by applicable Law, (i) promptly advise Purchaser of the receipt of any communication from the FDA, SEC or any similar state or foreign Governmental Body or other U.S. Governmental Body whether oral, written, electronic or otherwise, (ii) provide Purchaser with a reasonable opportunity to participate in the preparation of any response thereto and the preparation of any other substantive submission or communication to any such Governmental Body and to review any such response, submission or communication prior to the filing or delivery thereof, and (iii) provide Purchaser with the opportunity to participate in any meetings or substantive telephone conversations that Seller or its representatives may have from time to time with any such Governmental Body. Until the earlier of Closing or the termination of this Agreement in accordance with Section 4.6, Section 4.7 and Section 4.8, at Purchaser's request, Seller shall assist Purchaser in obtaining any meetings with, or facilitating communications between, Purchaser and the FDA, SEC or any similar state or foreign Governmental Body or other U.S. Governmental Body.

ARTICLE VIII.

CONDITIONS TO CLOSING

- 8.1 <u>Conditions Precedent to the Obligations of Seller and Purchaser</u>. The respective obligations of each party to this Agreement to consummate the transactions contemplated herein are subject to the satisfaction or written waiver, on or prior to the Closing Date, of each of the following conditions (any or all of which may be waived in writing by Seller and Purchaser in whole or in part to the extent permitted by applicable Law):
- (a) there shall not be in effect any statute, rule, regulation, Law or Order enacted, issued, entered or promulgated by a Governmental Body of competent jurisdiction restraining, enjoining or otherwise prohibiting the consummation of the transactions contemplated hereby;
- (b) the Court shall have entered the Bidding Procedures Order and such order shall not have been stayed, reversed, vacated, modified or amended (except as modified or amended in any immaterial respect or with the consent of Purchaser, which consent may be withheld in its sole discretion for material modifications and amendments); and
- (c) the Court shall have entered the Sale Order and such order shall not have been stayed, reversed, vacated, modified or amended (except as modified or amended in any immaterial respect or with the consent of Purchaser, which consent may be withheld in its sole discretion for material modifications and amendments).
- 8.2 <u>Conditions Precedent to the Obligations of Seller</u>. The obligations of Seller to consummate the transactions contemplated by this Agreement are subject to the satisfaction, on or prior to the Closing Date, of each of the following conditions (any or all of which may be waived in writing by Seller in whole or in part to the extent permitted by applicable Law) in addition to those set forth in Section 8.1:

- (a) <u>Covenants and Representations</u>. Purchaser shall have performed in all material respects all agreements and covenants required hereby to be performed by Purchaser prior to or at the Closing Date, and the representations and warranties of Purchaser made in <u>Article VI</u> shall be correct and complete in all material respects as of the Closing Date as if made on such date.
- (b) <u>Purchase Price</u>. On or prior to the Closing Date, Purchaser shall have satisfied the Purchase Price.
- (c) <u>Deliveries</u>. On or prior to the Closing Date, Purchaser shall have delivered to Seller each of the items set forth in <u>Section 4.2</u> of this Agreement.
- 8.3 <u>Conditions Precedent to the Obligations of Purchaser</u>. The obligations of Purchaser to consummate the transactions contemplated by this Agreement are subject to the satisfaction, on or prior to the Closing Date, of each of the following conditions (any or all of which may be waived in writing by Purchaser in whole or in part to the extent permitted by applicable Law) in addition to those set forth in <u>Section 8.1</u>:
- (a) <u>Covenants and Representations</u>. Except as would not, individually or in the aggregate, be reasonably likely to have a Material Adverse Effect, Seller shall have performed all agreements and covenants required hereby to be performed by Seller prior to or at the Closing Date, and the representations and warranties of Seller in <u>Article V</u> shall be correct and complete as of the Closing Date as if made on such date.
- (b) <u>Deliveries</u>. On or prior to the Closing Date, Seller shall have delivered to Purchaser each of the items set forth in <u>Section 4.2</u> of this Agreement.
- (c) <u>Regulatory Approvals</u>. All of the Regulatory Approvals necessary for Purchaser to acquire the Acquired Assets, and assume the Assumed Liabilities, shall have been obtained, and all such Regulatory Approvals shall be in full force and effect.

ARTICLE IX.

MISCELLANEOUS

- 9.1 <u>Transfer Taxes</u>. Any sales, use, transfer, deed, fixed asset, stamp, documentary stamp or other similar type Taxes and recording charges (each, a "<u>Transfer Tax</u>") which may be payable by reason of the acquisition of the Acquired Assets or the assumption of the Assumed Liabilities under this Agreement or the transactions contemplated herein shall be timely paid by Purchaser. Purchaser and Seller shall cooperate to prepare and timely file any Tax Returns required to be filed in connection with Transfer Taxes described in the immediately preceding sentence.
- 9.2 <u>Releases</u>. Effective as of and conditioned upon the occurrence of Closing, Purchaser hereby releases and forever discharges Seller and Seller's directors, officers, employees, agents, representatives, successors, assigns, and holders of Claims or interests in Seller's chapter 11 bankruptcy estate, from any and all actions, suits, debts, liens, sums of money, accounts, judgments, claims and demands whatsoever, at law or in equity, either in

contract or in tort, whether known or unknown, on account of, arising out of or relating to any act or omission of any kind or character whatsoever that relates to Seller or this Agreement and the proposed transactions contemplated herein occurring at or prior to the Closing; provided that nothing in this Section 9.2 shall release or discharge any Claim of Purchaser under this Agreement. Notwithstanding any provision of the contrary herein, Purchaser agrees that, in addition to Seller, any other person or entity released and discharged under this section is a third-party beneficiary of this section and shall be entitled to rely on and enforce this section.

- 9.3 <u>Survival</u>. None of the (a) covenants or agreements to be performed by either Seller or Purchaser prior to the Closing pursuant to this Agreement and (b) representations and warranties by Seller or Purchaser contained in this Agreement shall survive Closing, and neither Seller nor Purchaser shall have liability to the other party after Closing for any breach of any such covenant, agreement, representation or warranty. Except as set forth in the immediately preceding sentence, the covenants and agreements of the parties set forth in this Agreement will survive until fully performed or until such performance is expressly waived in writing by the other party.
- 9.4 <u>Injunctive Relief.</u> Damages at Law may be an inadequate remedy for the breach by Purchaser or Seller of any of its covenants, promises and agreements contained in this Agreement and, accordingly, each of Purchaser and Seller shall be entitled to injunctive relief with respect to any such breach, including specific performance of such covenants, promises or agreements or an order enjoining a party from any threatened, or from the continuation of any actual, breach of the covenants, promises or agreements contained in this Agreement. The rights of Purchaser and Seller set forth in this <u>Section 9.4</u> shall be in addition to any other rights which a party may have at Law or in equity pursuant to this Agreement.
- Exhibits and Schedules hereto and other documents specifically referred to herein) represents the entire understanding and agreement between the parties hereto with respect to the subject matter hereof and supersedes all prior agreements, understandings, negotiations and discussions, whether oral or written, of the parties. Any provision of this Agreement may be amended or waived if such amendment or waiver is in writing and signed, in the case of an amendment, by Purchaser and Seller, or in the case of a waiver, by the party against whom the waiver is effective. No failure or delay by either party in exercising any right, power or privilege hereunder will operate as a waiver thereof nor will any single or partial exercise thereof preclude any other or further exercise thereof or the exercise of any other right, power or privilege. The rights and remedies provided herein will be cumulative and, except as otherwise expressly provided herein, are not exclusive of any rights or remedies provided by applicable Law.
- 9.6 <u>Counterparts; Electronic Signatures</u>. For the convenience of the parties hereto, this Agreement may be executed in any number of counterparts, each such counterpart being deemed to be an original instrument, and all such counterparts shall together constitute the same agreement. Facsimile signatures or signatures delivered by email in PDF or similar format will be deemed original signatures for purposes of this Agreement.
- 9.7 <u>Governing Law.</u> This Agreement will be governed by and construed in accordance with the Laws of the State of Delaware without regard to principles of conflicts of Law. The parties hereby submit to the exclusive jurisdiction of the United States Bankruptcy Court for the

District of Delaware and any U.S. federal appellate court therefrom (or, if the United States Bankruptcy Court for the District of Delaware declines to or may not accept authority or jurisdiction over a particular matter, the United States District Court for the District of Delaware; or if the United States District Court for the District of Delaware declines to or may not accept jurisdiction over a particular matter, any state court within Suffolk County of the Commonwealth of Massachusetts) for any actions, suits or proceedings arising out of or relating to this Agreement or the transactions contemplated herein (and each party agrees not to commence any action, suit or proceeding relating thereto except in such courts), and each party further agrees that service of any process, summons, notice or document by U.S. registered mail to its respective address set forth in Section 9.9 shall be effective service of process for any action, suit or proceeding brought against it in any such court.

- 9.8 <u>Waiver of Jury Trial</u>. EACH OF THE PARTIES HERETO HEREBY IRREVOCABLY WAIVES ANY AND ALL RIGHT TO TRIAL BY JURY IN ANY LEGAL PROCEDING ARISING OUT OF OR RELATED TO THIS AGREEMENT OR THE TRANSACTIONS CONTEMPLATED HEREBY.
- 9.9 <u>Notices</u>. Unless otherwise set forth herein, any notice, request, instruction or other document to be given hereunder by any party to the other parties shall be in writing and shall be deemed duly given (i) upon delivery, when delivered personally, (ii) one (1) day after being sent by overnight courier or when sent by facsimile transmission or email PDF format (with a confirming copy sent by overnight courier), and (iii) three (3) calendar days after being sent by registered or certified mail, postage prepaid, as follows:

Except as otherwise expressly stated herein, nothing in this Agreement will create or be deemed to create any Third Party beneficiary rights in any Person or entity not a party to this Agreement. Neither party may assign or delegate its rights or obligations under this Agreement (whether by operation of Law, change of control, or otherwise), either in whole or in part, without the prior written consent of the other party, <u>provided, however</u>, that (a) Purchaser may assign, delegate or transfer any of its rights or obligations under this Agreement to any wholly-owned direct or indirect Subsidiary of Purchaser by sending written notice to, but without the consent of, Seller; <u>provided, further</u>, that such assignment, delegation or transfer shall not relieve Purchaser of any liability or obligation under this Agreement. Any attempted assignment, delegation or transfer in violation of this Section 9.10 shall be void and without effect.
- 9.11 <u>Third Party Beneficiaries</u>. Except as otherwise expressly stated herein, no Person other than the parties hereto (and any permitted assignee under <u>Section 9.10</u>) shall have any rights or claims under this Agreement.
- 9.12 <u>Publicity</u>. Neither Seller nor Purchaser will issue any press release or make any public statement regarding the transactions contemplated hereby, without the prior written consent of the other party.
- 9.13 <u>Severability</u>.
