STIPULATION EXTENDING TIME

This Stipulation Extending Time (the “**Stipulation**”) is entered into by and between Eastman Kodak Company (“**Kodak**”) and Global OLED Technology LLC (“**Plaintiff**”), by and through their respective undersigned counsel.

WHEREAS, on December 19, 2012, Plaintiff commenced the above-captioned adversary proceeding (the “**Adversary Proceeding**”);

WHEREAS, the return date on the summons in the Adversary Proceeding was January 25, 2013, and was continued to February 15, 2013, by prior stipulation of the parties [Adv. Docket No. 8];

WHEREAS, a pretrial conference of the Adversary Proceeding is presently noticed for February 20, 2013 at 11:00 a.m. [Adv. Docket No. 7];

WHEREAS, counsel to Kodak and Plaintiff have conferred and agreed that, in order to allow the parties time to further discuss the issues raised in the Adversary Proceeding, Kodak's time in which to file a response to Plaintiff's Adversary Proceeding complaint shall be further extended;

NOW THEREFORE, the parties hereby stipulate and agree, through their undersigned counsel, as follows:

1. Kodak shall have an extension of time until and including March 8, 2013, in which to file a response to Plaintiff's Adversary Proceeding complaint.
2. The pretrial conference of the Adversary Proceeding has been adjourned with the Court's permission until March 20, 2013 at 11:00 a.m.
3. The foregoing is without prejudice to the rights of Kodak to seek a further extension of time to respond to the Adversary Proceeding complaint.
