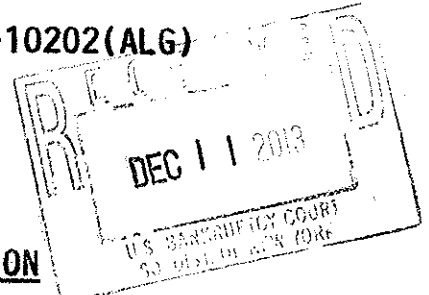

RESPONDENT'S RESPONSE TO DEBTORS OBJECTION
TO GENERAL ADMINISTRATIVE CLAIM & MOTION TO COURT TO DENY DEBTOR'S
REQUEST IN EXHIBIT A TO DISALLOW & EXPUNG RESPONDENT'S CLAIM & TO
GRANT RESPONDENT'S EQUITY INTEREST CLAIM IN FULL

Respondent, TOMMY ROBINSON, pro-se, hereby responds to the Reorganized Debtors EASTMEN KODAK COMPANY et. al. and their attorneys and their objection to deny Respondent Equity Interest Claim of 2,000 shares of Kodak stock purchased for \$17,169.55 actual money spent.

Debtors first request to the Court is for Respondents to file their **Response** to the relief requested electronically with the Court on a 3.5 inch disc, & served by U.S. mail or other means.

Respondant is unable to honor this request because he do have access to a computer and cannot file his response electronically.

Therefor the Court must allow the Respondant to file his Response



in old fashion form by typing it out and using the U.S. mail to deliver his response to the Chambers of the Honorable Allan L. Gropper, United States Bankruptcy Court for the Southern District of New York, One Bowling Green, New York, New York 10004.

The Respondent must rely on the "mail box rule" and the case of Houston v. Lack, 487 U.S. 266, 276, (1988), since Respondent is currently locked up, this case states that a prisoner's pleading is considered filed on the same day it is mailed or at the moment of delivery to prison authorities for mailing.

In this case if Respondent's response is not received by December 11, 2013, 4:00 p.m. ET, it is to be considered filed on time on the day of the postmark from Cumberland, Maryland.

Due to the strict requirement set for the Administrative Claim to be received on October 18, 2013 at 5:00 p.m. Respondent's intention was not to file duplicate claims, but to make sure that his Claim was received on time, so a certified letter was mailed to Kurtzman Carson Consultants on 9 October 2013 but was not postmarked by Cumberland Post Office until October 11, 2013 and received on October 18, 2013. See EXHIBIT: A, so in order to be safe a copy of this Claim was mailed to the Bankruptcy Court in New York. But there is only one Claim. See EXHIBIT NO: B.

DEBTORS RELIEF SHOULD NOT BE GRANTED

Respondent Responds to the Debtor's relief and should not be granted for these reasons. The Debtors request entry of the Proposed Order, disallowing and expunging, in full, each of the Disputed Claims, as indicated in further detail on Exhibits A and B, and that this objection addresses not more than 100 Disputed Claims.

1. Respondent's response to the Court is to notice that the Debtors attorneys have listed 61 claims in Exhibit A and request that all be expunged.
2. Respondent request that the Honorable Allan L. Gropper, Judge for this Court, take notice that of the 61 claims listed 27 claims have been settled or indicates \$0 balance owed.
3. Listing these claims with actual USD claims is an effort to convince the Judge that all these claims have no value and influence a decision to disallow all the remaining claims and to have them expunged from the records.
4. Respondent, TOMMY ROBINSON, hereby claims that his Equity Interest Claim was actual money spent.

See Exhibits 1 thru 13, copies of brokerage statements where

Respondent purchased 2000 shares in good faith and believed he had a interest in the operation of the company Eastman kodak, and spent \$17,169.55 that the Managers used to give themselves bonuses and pay their high salaries.

5. Eastman Kodak is not broke and still do own a great majority of property, land and buildings that have value so to deny Respondent's claim to reinburse him \$17,169.55 would be a Travesty to Justice.

VERIFICATION

For These reasons the Respondent hereby solemnly declare and affirm, upon personal knowledge (or upon knowledge, information, and belief were so indicated) and under the penalitits of perjury that the following statements are true and correct:

1. The issues presented is of serious concern.
2. I sincerely believe that I have good and just cause of action.
3. I possess a reasonable likelihood of success of the merits of this claim.
4. The facts asserted in my response are true.
5. I respectfully pray this Court **Grant my Equity Interest Claim in full** and rule in Respondent's favor.

WHEREFORE, for the reasons set forth herein, the Respondent

respectfully request that this Court enter a Order and deny
the Debtors their request and GRANT Respondent relief as may be
just and proper.

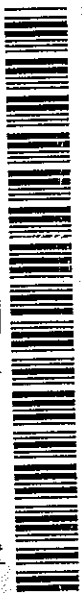
