**ORDER STAYING AND ADMINISTRATIVELY CONSOLIDATING  
RICOH COMPANY, LTD.’S AND RICOH AMERICAS CORPORATION’S  
ADVERSARY PROCEEDING AND PROOFS OF CLAIM**

Following the May 9, 2014 scheduling conference in the adversary proceeding *Ricoh Co. Ltd. v. Eastman Kodak Co.*, Adv. Pro. No. 13-01332 (ALG) (the “**Adversary Proceeding**”), commenced by Ricoh Company, Ltd. and Ricoh Americas Corporation (together “**Ricoh**”) against Eastman Kodak Company (“**Kodak**”), it is hereby ORDERED THAT:

1. The Adversary Proceeding is stayed (i) pending resolution of Kodak’s motion to withdraw the reference, pending before Judge Cote in the United States District Court

2. Ricoh's prepetition proofs of claim filed against Kodak, which have been assigned claim numbers 5807 and 5835 (the "**Ricoh Proofs of Claim**"), are administratively consolidated for pretrial and adjudication purposes with the Adversary Proceeding.

3. This Court shall retain jurisdiction to interpret and enforce this order.
