**ORDER SETTING STATUS CONFERENCE**

21 On October 25, 2022, the Bankruptcy Court for the District of  
22 Delaware granted the Ledesma Action Plaintiffs' Motion to Change  
23 Venue (ECF #160) to this Court. In order to ensure the efficient  
24 administration of the above-captioned bankruptcy case and  
25 adversary proceedings, the Court **HEREBY SETS** a status conference  
26 pursuant to its authority under 11 U.S.C. § 105(a) for Tuesday,  
27 November 8, 2022, at 2:00 pm.

1 Counsel for the parties may appear virtually via Zoom or in  
2 person. The Court anticipates attendance by counsel for the  
3 Debtors in Possession, the proposed Unsecured Creditors  
4 Committee, and the counter-parties in the adversary proceedings  
5 referenced above, as well as the U.S. Trustee. In addition,  
6 although their attendance is not required, the Court would  
7 appreciate attendance by the Debtor's Chief Reorganization  
8 Officer (CRO) and the Patient Care Ombudsmen Blanca E. Castro.

9 Given the short time period between the date of this Order  
10 and the date of the hearing, the Court is not preparing an  
11 agenda of items to be discussed at the status conference. That  
12 notwithstanding, the Court expects to conduct a discussion of  
13 issues pertinent to the transfer of the case and procedures  
14 going forward in connection to the case and the adversary  
15 proceedings and various other scheduling matters.
