In accordance with the *Order Granting Debtors' Motion for Order Pursuant to Bankruptcy Code Sections 105(a) and 331, Bankruptcy Rule 2016, and Local Bankruptcy Rule 2016-1 Establishing Procedures for Interim Compensation and Reimbursement of Expenses of Professionals*, dated March 11, 2020 [Docket No. 176] (the “**Interim Compensation Order**”),<sup>2</sup> Skadden, Arps, Slate, Meagher & Flom LLP (“**Skadden**”) hereby submits this seventh monthly statement (the “**Seventh Monthly Statement**”), seeking compensation for services rendered and reimbursement of expenses incurred as counsel to the Debtors, for the period from August 1, 2020 through August 31, 2020 (the “**Seventh Monthly Period**”). By this Seventh Monthly Statement, and after taking into account certain voluntary discounts and reductions,<sup>3</sup> Skadden seeks payment in the amount of \$557,728.95, which comprises (i) 80% of the total amount of compensation sought for actual and necessary services rendered during the Seventh Monthly Period and (ii) reimbursement of 100% of actual and necessary expenses incurred in connection with such services.

### **SERVICES RENDERED AND EXPENSES INCURRED**

1. Attached hereto as **Exhibit A** is a summary of Skadden professionals by individual, setting forth the (a) name and title of each individual who provided services for the Seventh Monthly Period, (b) aggregate hours spent by each individual, (c) hourly billing rate for each such individual at Skadden’s current billing rates, (d) amount of fees earned by each Skadden professional, and (e) year of bar admission for each attorney. the fees and expenses in the percentages set forth above. To the extent such objection is not resolved, it shall be preserved and scheduled for consideration at the next interim fee application hearing.
