other or further notice is necessary; and it appearing that the relief requested in the Objection is in the best interests of the Debtors, their estates, their creditors, and other parties in interest; and that the legal and factual bases set forth in the Objection establish just cause for the relief granted herein; and a Certificate of No Objection concerning the Objection having been filed on November 17, 2020; and upon the hearing conducted before this Court to consider the Objection (the "Hearing") and upon the record of the Hearing; and after due deliberation thereon; and good and sufficient cause appearing therefor; it is hereby

#### ORDERED, ADJUDGED, AND DECREED THAT:

- 1. The relief requested in the Objection is GRANTED as set forth herein.
- 2. The Equity Interest Claims listed on **Exhibit 1** attached hereto are hereby reclassified as proofs of equity interests.
- 3. Each Equity Interest Claim and the objections by the Plan Administration Trustee to each Equity Interest Claim as identified and set forth on **Exhibit 1** attached hereto constitutes a separate contested matter as contemplated by Bankruptcy Rule 9014. This Order shall be deemed a separate order with respect to each Equity Interest Claim. Any stay of this Order shall apply only to the contested matter that involves such interest holder and its Equity Interest Claim and shall not act to stay the applicability or finality of this Order with respect to the other contested matters and corresponding Equity Interest Claims.
- 4. The Plan Administration Trustee shall have the right to further object in the future on any ground to any of the Equity Interest Claims that are not disallowed and expunged pursuant to this Order. Neither the Objection nor this Order shall constitute any admission or finding with respect to the validity or amount of the Equity Interest Claims that are not disallowed and expunged pursuant to this Order.
