# ORDER GRANTING PLAN ADMINISTRATION TRUSTEE'S THIRTIETH OMNIBUS OBJECTION TO CLAIMS (REDUCED CLAIMS, RECLASSIFIED CLAIMS, AND REDUCED AND RECLASSIFIED CLAIMS)

Harding (the "Declaration") in support thereof; and this Court having jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334 and the *Amended Standing Order of Reference from the United States District Court for the Southern District of New York*, dated January 31, 2012; and this Court having found that this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2), and that this Court may enter a final order consistent with Article III of the United States Constitution; and this Court having found that venue of this proceeding and the Objection in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and due and sufficient notice of the Objection

having been given under the particular circumstances; and it appearing that no other or further notice is necessary; and it appearing that the relief requested in the Objection is in the best interests of the Debtors, their estates, their creditors, and other parties in interest; and that the legal and factual bases set forth in the Objection establish just cause for the relief granted herein; and a Certificate of No Objection concerning the Objection having been filed on February 12, 2021; and after due deliberation thereon; and good and sufficient cause appearing therefor; it is hereby

#### ORDERED, ADJUDGED, AND DECREED THAT:

- 1. The relief requested in the Objection is GRANTED as set forth herein.
- 2. The Reduced Claims listed on **Exhibit 1** attached hereto are hereby reduced to the amounts listed in the column titled "*Reduced Amount*" on **Exhibit 1** attached hereto.
- 3. The Reclassified Claims listed on **Exhibit 2** attached hereto are hereby reclassified as Class 5 General Unsecured Claims as defined in the Plan.
- 4. The Reduced and Reclassified Claims listed on **Exhibit 3** attached hereto are hereby reduced to the amounts listed in the column titled "*Reduced Amount*" on **Exhibit 3** attached hereto, and reclassified as Class 5 General Unsecured Claims as defined in the Plan.
- 5. Each claim and the objections by the Plan Administration Trustee to each claim as identified and set forth on **Exhibits 1-3** attached hereto constitutes a separate contested matter as contemplated by Bankruptcy Rule 9014. This Order shall be deemed a separate order with respect to each claim. Any stay of this Order shall apply only to the contested matter that involves such creditor and its claim and shall not act to stay the applicability or finality of this Order with respect to the other contested matters and corresponding claims.

general unsecured, or reduced and reclassified pursuant to this Order, including to seek

disallowance and expungement of same, and the rights and defenses of the claimants regarding such

claims are fully preserved. Neither the Objection nor this Order shall constitute any admission or

finding with respect to the validity, basis for, or amount of the Disputed Claims that are not reduced

and/or reclassified pursuant to this Order.

7. The claims agent retained in the Debtors' Chapter 11 Cases is authorized

to reflect the reduction in amount and/or reclassification to general unsecured claim of the

Disputed Claims on the official claims register maintained for the Debtors' cases.

8. The terms and conditions of this Order are effective immediately upon

entry.

9. This Court shall retain jurisdiction with respect to all matters arising from

or related to the implementation or interpretation of this Order.
