Brandt, Jr., the GUC Recovery Trustee of the GUC Recovery Trust created under the Debtors’ Chapter 11 Plan confirmed on September 25, 2020 [Docket No. 879], and the prospective class representatives Lorianne Sawin, Monica Gallardo, Robert Langford, Kimberly Holliman, Billy Trahim, and Merle Renslow, on their own behalf and similarly situated prospective class members, filed the *Joint Motion Seeking to (I) Approve the Settlement Agreement, (II) Certify a Class of Former Newspaper*
