On June 22, the GUC Recovery Trustee filed Affidavits of Service of the CAFA Notice and the Class Notice. Three class members timely opted out of the proposed settlement, but no class member objected. Also, no CAFA noticed party objected to the proposed settlement. A final hearing on the Joint Motion was originally scheduled to be held on September 8, but the Court agreed to adjourn the hearing to September 15 [Docket No. 1220].
