



<u>SUPPLEMENTAL NOTICE OF SETTLEMENT PURSUANT TO 28 U.S.C. § 1715</u>	

William A. Brandt, Jr., in his capacity as trustee (the “**GUC Recovery Trustee**”) of the JCK GUC Recovery Trust established under the JCK Legacy GUC Recovery Trust Agreement and the confirmed *First Amended Joint Chapter 11 Plan of Distribution of JCK Legacy Company and Its Affiliated Debtors and Debtors in Possession* [Docket No. 879], through his undersigned counsel, hereby gives supplemental notice under 28 U.S.C. § 1715 of the *Settlement and Mutual Release Agreement* (the “**Settlement**”), settling *Veronica Becerra et al. v. The McClatchy Co., et al*, Superior Court Case No. 08CECG04411 (KAG).

1. On February 25, 2022, the GUC Recovery Trustee filed and served the *Joint Motion to Preliminary Approve Class Action Settlement Between GUC Recovery Trustee and Becerra Class Representatives*. See Docket No. 1410.

2. On March 4, the GUC Recovery Trustee served the *Notice of Settlement Pursuant to 28 U.S.C. § 1715* on appropriate federal and state officials. See Docket No. 1419. On March 17, the United States Bankruptcy Court Southern District of New York (Wiles, J.), held a hearing to preliminarily approve the Settlement and entered an order approving the Settlement on a preliminarily basis on March 18 (the “**Order**”). A copy of the Order is attached as **Exhibit 1**.
