SUPPLEMENTAL DECLARATION OF MARK D. SHERRILL IN SUPPORT OF THE DEBTOR'S APPLICATION FOR AN ORDER AUTHORIZING THE RETENTION AND EMPLOYMENT OF EVERSHEDS SUTHERLAND (US) LLP AS SPECIAL COUNSEL FOR THE DEBTOR EFFECTIVE AS OF THE PETITION DATE

Pursuant to 28 U.S.C. § 1746, I, Mark D. Sherrill, declares as follows:

- 1. I am a Partner at the firm of Eversheds Sutherland (US) LLP ("Eversheds"), which maintains offices for the practice of law at, among other places, 1000 Louisiana Street, Suite 3700, Houston, TX 77002. I am an attorney at law, duly admitted in good standing to practice in the State of Texas, the Commonwealth of Virginia, the District of Columbia, and the State of Ohio.
- 2. I am duly authorized to execute this supplemental declaration (the "Supplemental Declaration") on behalf of Eversheds. I am familiar with the matters set forth herein and, if called as a witness, I could and would testify thereto. Unless otherwise stated in this Supplemental Declaration, I have personal knowledge of the facts hereinafter set forth. To the extent that any information disclosed herein requires amendment or modification upon Eversheds' completion of further analysis or additional creditor information becomes available to Eversheds, a further supplemental declaration will be submitted to the Court.
- 3. I am filing this Supplemental Declaration to supplement the disclosures that were included in my original declaration, dated April 6, 2021 (the "Original Declaration"), that was filed with the Application of the Debtor for an Order Authorizing the Retention and Employment of Eversheds Sutherland (US) LLP as Special Counsel for the Debtor Effective as of the Petition Date [Docket No. 87] (the "Application") in accordance with Rule 2014(a) of the Federal Rules

of Bankruptcy Procedure (the "<u>Bankruptcy Rules</u>"). The Court has not yet entered an order regarding the Application.

4. Except as otherwise indicated herein, all facts stated in this Supplemental Declaration are based on my personal knowledge of Eversheds' operations and finances, information learned from my review of relevant documents, and information supplied to me by Eversheds' partners or employees. If called upon to testify, I could and would testify on that basis.

ADDITIONAL DISCLOSURES

- 5. In accordance with its ongoing obligations under Bankruptcy Rule 2014 and Local Rule 2014-1, Eversheds has conducted, and continues to conduct, an examination of its relationships with the Debtor, its creditors, and other parties in interest in this Chapter 11 Case. Based on ongoing conflicts review, Eversheds learned that it inadvertently did not run the parties listed in **Schedule 1** through conflicts and therefore supplements the disclosures in the Application.
- 6. Attached hereto as <u>Schedule 2</u> and incorporated herein is a list of Potential Parties in Interest whom Eversheds currently represents, has represented in the three years prior to the Petition Date, and may in the future represent in matters unrelated to the Debtor, the Debtor's Chapter 11 Case, such entities' claims against or interests in the Debtor, or the Scope of Services.
- 7. Although Eversheds has represented, currently represents, and may continue to represent certain entities and individuals listed on **Schedule 2** hereto, no representation reflected on **Schedule 2** is materially adverse to the Debtor or its estate with respect to the Scope of Services.
- 8. Eversheds Sutherland represents the Medley complex (Medley Management Inc., Medley LLC, Medley Capital LLC, and several current and former officers, directors and employees) in a Securities and Exchange Commission (the "SEC") enforcement investigation. The investigation is being conducted by the SEC's Division of Enforcement pursuant to a formal order of investigation that sets out various statutory grounds that allegedly warrant investigation. The investigation has included voluminous requests for information, subpoenas directing the production of books and records, and subpoenas requiring testimony.

9. To our knowledge, information and belief, no other law firm is representing or

defending the Medley complex in the SEC matter. We also anticipate that some coordination may

be needed with the Debtor's primary bankruptcy counsel, Lowenstein Sandler LLP, with regard to

the Plan/Disclosure Statement treatment of the SEC investigation.

10. Eversheds, to the best of its knowledge, information and belief, believes that it

continues to be a "disinterested person" as that term is defined in section 101(14) of the Bankruptcy

Code, and that it does not hold or represent an interest adverse to the Debtor's estate with respect

to the matters on which it is employed.

11. I continue to reserve the right to supplement Eversheds' disclosures in the event

that Eversheds learns of any additional connections that require disclosure. If any new material,

relevant facts, or relationships are discovered or arise, Eversheds will promptly file another

supplemental declaration pursuant to Bankruptcy Rule 2014.
